

On behalf of the Lake County State's Attorney's Office, I would like to express my condolences to the families and those who lost their lives during the Highland Park Parade due to the premeditate and calculated attack. What should have been a celebration of freedom, has ended in despair for our community.

Separate from the lives that have been lost, over two dozen other mothers, fathers, sons, daughters, friends, neighbors, and loved ones were injured by gunfire on Monday. Hundreds, if not thousands, have been psychologically scarred by the events that transpired on July 4, 2022, in Highland Park.

As a community, we are only at the beginning of the long healing journey we have ahead of us. We are only beginning to process the tremendous loss we have suffered. Each person will have a unique experience in the way they deal with the shock and their emotions caused by the killer.

Our office is here to provide full assistance and support for the victims and survivors. No one should feel alone or feel like they must deal with trauma alone. What a horrible week we are all having. I have so many connections to this, as I lived in HP for 24 years. That monster grew up 2 blocks from my house. My friend and her husband were standing at the epicenter and she can't stop crying. Another friend's daughter teaches at Edgewood and thinks that he could have easily shot people there.

You heartfelt letter to these kids says it all. I saw you on TV, shaking the VP's hand. Your face was different than I've ever seen it. I'm sorry you have to suffer this trauma. I'm thinking of you as I cry each day.

I look forward to seeing you in August, when some healing will have begun. But things will never be the same for so many people. I lived in Skokie for 23 years and what outsiders think of that town is when the KKK threatened to march there in 1970, to the horror of so many Jewish people living there and many who were Holocaust survivors. Then I lived in HP for 24 years and now that town will always be associated with the shootings. We are living in a very troubled world.

Yesterday we received the names of the individuals murdered in the July 4 shooting that shook our community to its core.

We will forever remember these innocent victims murdered by gun violence. May their memory be a blessing.

Katherine Goldstein (64) of Highland Park Irina McCarthy (35) of Highland Park Kevin McCarthy (37) of Highland Park Jacquelyn Sundheim (63) of Highland Park Stephen Straus (88) of Highland Park Nicolas Toledo-Zaragoza (78) of Morelos, Mexico

A seventh victim who succumbed to injuries within Cook County. Further information is not available at this time.

I am reaching out to the victim's families and will be joining them as they mourn. I will stand with them, attending their funerals and offering the community's sympathy and support.

Yesterday Vice President Kamala Harris stood at the site of the shooting, in our beloved downtown. She shared her support and condolences, and offered continued Federal resources. She brought a message of hope and strength.

There is no roadmap that tells us what to do next, but we cannot allow this shooting to define us. Today as we begin a new day -- we do so with a renewed sense of resolve and purpose.

Each day, we will find the strength to take a step forward. No single action will heal us, but many small steps, taken together as a community will help, and each of us has a role in the healing process. Kindness matters and small actions that you take every day will help us heal. Check on your neighbors, reach out with a kind word or supportive action, continue to check the City's website and emails for updates, resources, and other information. We want you to be in touch and connected.

We will get through this together. We will move forward together. We are Highland Park strong. These are not just words on a page, these are words to live by.
