Mayor Rotering,

I want to begin by offering my condolences to you and the people of Highland Park. The fact that we as a country haven't taken action to stop this kind of violence is just heartbreaking. I'm reaching out this evening because I produce a weekly interview segment called Our Chicago that airs during our Sunday morning newscast (it was previously called Newsviews. I think you spoke with us for Newsviews back in 2016 during your Congressional run). Wondering if you might be able to speak with us again this Friday morning at 10 am. Last time you were in studio, this time we would do the interview over Zoom. Here are some of the questions/topics I expect we'd cover: the city has been in the spotlight in the past for gun control efforts but is now dealing with this mass shooting? What do communities do? What can they do? Do they now have to rethink every public gathering? We can talk about the counseling and any other assistance you're providing to residents. What is your message to every other community who thinks they couldn't possibly experience such violence? This would be about a 10 minute long interview. I've included a link below so you can see what these interviews are like now over Zoom.

SCHNEIDER STATEMENT ON HIGHLAND PARK 4TH OF JULY SHOOTING

HIGHLAND PARK, Ill. — Congressman Brad Schneider (IL-10) released the following statement regarding the tragic shooting at the Highland Park 4th of July parade. Law enforcement has a suspect in custody.

“Yesterday, around 10:15 AM, a man on a rooftop with a “high powered rifle” shot more than 30 people at the Highland Park Independence Day Parade, murdering 7. What should have been a joyful celebration of our nation’s birth ended in mayhem and tragedy. Our community has been rocked, families have been shattered, life will forever be changed.

“I extended my sincerest condolences to the families of those murdered, and am praying for the recovery of all those wounded or injured.


“I am grateful for the rapid response of the heroic first responders, as well as the many local residents who immediately stepped in to assist the wounded. I am thankful for law enforcement and first responders from communities in the area, the state of Illinois, and the federal government who urgently mobilized with remarkable professionalism to swiftly identify, locate, and apprehend the person of interest. I also appreciate the leadership of our Mayor Nancy Rotering, Police Chief Lou Jogmen, Fire Chief Joe Schrage, and countless others who shepherded us through the tense hours of yesterday. You all showed the power of community in the darkest of moments.

“Yesterday, our country experienced at least 4 mass shootings. We have suffered more than 300 mass shootings already this year alone (just 185 days). The nation needs to act, and act now, to save other communities from experiencing the pain Highland Park is suffering today. Most Americans agree on common-sense actions such as universal background checks and an assault weapons ban to keep our communities safe. Our community has my total commitment to do everything I can to make our children, town, and nation safer. Enough is enough.

“Highland Park is strong, and we will stand united as a community as we recover from this senseless tragedy. In time we will heal, but we will never forget. As the victims' names are identified, we will share further information with respect to their families' wishes. May the memory of the lives lost forever be a blessing.

“Free counseling is available to Highland Park students, families, and community members at the Highland Park High School. Please do not hesitate to go in person or contact (224) 765-2000 with questions or concerns.”

DECLARACIÓN DE SCHNEIDER SOBRE EL TIROTEO DEL 4 DE JULIO EN HIGHLAND PARK

HIGHLAND PARK, Ill. - El congresista Brad Schneider (IL-10) emitió la siguiente declaración sobre el trágico tiroteo en el desfile del 4 de julio en Highland Park. La policía tiene un sospechoso en custodia.

"Ayer, alrededor de las 10:15 AM, un hombre en una azotea con un "rifle de alta potencia" disparó a más de 30 personas en el desfile del Día de la Independencia de Highland Park, asesinando a 7. Lo que debería haber sido una alegre celebración de la independencia de nuestra nación terminó en caos y tragedia. Nuestra comunidad ha sido sacudida, las familias han sido destrozadas, la vida cambiará para siempre.

Expreso mis más sinceras condolencias a las familias de los asesinados, y rezo por la recuperación de todos los heridos o lesionados.

"Estoy agradecido por la rápida respuesta de los socorristas heroicos, así como por los numerosos residentes locales que intervinieron inmediatamente para ayudar a los heridos. Estoy agradecido a las fuerzas del orden y a los primeros intervinientes de las comunidades de la zona, del estado de Illinois y del gobierno federal, que se movilizaron con urgencia y con notable profesionalidad para identificar, localizar y detener rápidamente a la persona en cuestión. También agradezco el liderazgo de nuestra alcaldesa Nancy Rotering, del jefe de policía Lou Jogmen, del jefe de bomberos Joe Schrage y de innumerables personas que nos guiaron durante las tensas horas de ayer. Todos ustedes demostraron el poder de la comunidad en los momentos más oscuros”.

Ayer, nuestro país experimentó al menos 4 tiroteos masivos. Ya hemos sufrido más de 300 tiroteos masivos sólo este año (sólo 185 días). La nación necesita actuar, y actuar ahora, para evitar que otras comunidades experimenten el dolor que Highland Park está sufriendo hoy. La mayoría de las estadunidenses están de acuerdo en acciones de


sentido común como la comprobación universal de antecedentes y la prohibición de las armas de asalto para mantener a nuestras comunidades seguras. Nuestra comunidad tiene mi compromiso total de hacer todo lo posible para que nuestros niños, nuestra ciudad y nuestra nación estén más seguros. Ya es suficiente.

"La ciudad de Highland Park es fuerte, y nos mantendremos unidos como comunidad mientras nos recuperamos de esta tragedia inesperada. Con el tiempo sanaremos, pero nunca olvidaremos. A medida que se identifiquen los nombres de las víctimas, compartiremos más información respetando los deseos de sus familias. Que la memoria de las vidas perdidas para siempre sea una bendición".

So, there have been departments buying the M300 and H20T to replace the M210 and XT cameras. But DJI also recently release the M30T which is a smaller version of the M300 but does not have swappable payloads. If budget is tighter, it is about half the price of a M300 package.

M30T w/accessories roughly \$16-25K

We can make our way out to you for a demo of both if you would like. This way you and the brass can compare the two systems and decide what you would rather have.

As for other options with thermal there is the Mavic 2 Enterprise Advanced, Autel Evo 2 Dual, and Parrot Anafi USA. All of these are the smaller drone platforms and range from \$6500 – 16K depending on accessories added.

Mayor Rotering, I'm sure you have been inundated with all kinds of mail since the tragic shooting that occurred in your city recently. My heart goes out to you and all the citizens touched by this senseless tragedy. I have tried for years to get an idea in front of anyone I thought would read it and comment on it. Politicians won't touch it ; I have had some positive responses from some news sources but that didn't go far. I wrote it shortly after the Uvalde tragedy, so that is why Uvalde is included in the article.

Please read it carefully and let me know what your thoughts are. You simply acknowledge receiving it would make my day. It touches on many of the points you made in a news article I read that you had written. Something CAN be done to address the senseless crimes being committed with weapons of war by individuals who should never have been able to purchase them legally. It will take leadership, courage and determination but I sincerely believe that my proposal is the place to start. I'm afraid all three perquisites are sadly missing in our federal politicians.

Uvalde Didn't Have Happen It Could Have Been Prevented

The National Firearms Act of 1934 was enacted 88 years ago in an attempt to address the problem of gangsters and their possession of fully automatic firearms. Military style high capacity, semiautomatic assault rifles were not invented at the time and were not produced until 1944.

The law addresses machine guns but it also regulated short barreled shotguns, even single shot ones as well as silencers. Which weapons would you be most threatened by if facing a situation like occurred at Uvalde, a regulated single barreled shotgun or an unregulated M16 assault rifle?? The situation is totally ridiculous and tragic.

I suggest that we revise or update The National Firearms Act to include military style assault weapons. The law is already there..USE IT. Any weapon included in the Act would require the same process used today for Class III weapons and includes:

1. Must be 21 years of age.
2. Apply by completing 3 copies of Form 4. One copy goes to the applicant's local law enforcement office. This process also requires a passport style photo and fingerprint for a background check. There is also a \$200 transfer fee. This transfer fee if not paid amounts to tax evasion. Thus a way to prosecute the aforementioned gangsters.

The law has been somewhat vetted by the fact that it was enacted in 1934 with support from The National Rifle Association. IMAGINE THAT!! Anyone who abides by the provisions of the law and completes the process can own a Class III weapon, including a fully automatic machine gun. (Or a short barreled shotgun). In 1938 the Supreme Court ruled that the Act did not infringe on the constitutional right of legal gun owners. It avoids anything like a gun ban or confiscation of legally procured weapons. The only legitimate issue for legal gun owners is the inconvenience and time required to get through the process. Just how much inconvenience is a 10 year old child's life worth, not to mention 19, 10 year old's lives. The fact that there are thousands of these weapons already out there would have to be addressed. I suggest that these current legally owned weapons be grandfathered, but declare that they are included in this law as a Class III weapon. That would mean if a current owner wanted to sell, trade or give the weapon away, the purchaser would be required to abide by the sale/transfer process prescribed by the law.

Talking Points:

1. This law puts awareness and control of who purchases one of these weapons in the hands of local law enforcement where it should be and the only logical way to control who can possess these weapons. At the present time they are notified of a class III weapons transfer as a simple notification. In the past they had the ability to stop or delay the transfer. That ability should be reinstated. Many of the people perpetrating these horrendous acts are known by local authorities but do not have a criminal record that would stop the sale at the ATF firearms background check.
2. This could and should be a bipartisan effort. It addresses the background check issue, it avoids the so called gun show, car trunk sales where no records are kept, it also addresses concerns being expressed in the Red Flag laws. It's simply the right thing to do.
3. The majority of people in this country are tired of the carnage and would support this law.
4. It certainly doesn't solve all the problems, but no one has shown me a better start and no one has convinced me it couldn't work. It did in the past.

It simply requires courage on the part of our elected officials. Which sometimes is severely lacking. I would like to let you know where I am coming from with this. My name is Joe Coleman, I live in south Alabama, I am a veteran, a lifelong (currently disgusted) Republican and a member of the NRA. I have tried for years to get the attention of my congressional delegation to listen to what I have to say. Apparently they have more important issues to address (like getting reelected). If I sound frustrated, I AM. Probably along with most of the country.

Thank you for indulging me, any response will be appreciated.

If you are able to assist, please email me which shifts you can cover ASAP so I can coordinate a roster with Highland Park and Northwest Central Dispatch.


