ALL LICENSE RENEWALS ARE DUE JANUARY 1 AND BECOME DELINQUENT AFTER JANUARY 31 WITH THE FOLLOWING EXCEPTIONS:

- INSURANCE COMPANY LICENSE DUE JANUARY 1 BECOMING DELINQUENT AFTER MARCH 1.

This form is intended as a simplified, standard mechanism for businesses to initiate contact with the municipality concerning their activities within the City of Hueytown. A business license will be required prior to engaging in business activity. Typically there are Zoning and Building Code approvals required for businesses with a physical location within the City.

In certain instances, a business may simply be required to register with the City to create a mechanism for the reporting and payment of any tax liabilities. If the is the case, you will be provided the materials for that registration process.

The completion and submission of this form does not guarantee the approval or subsequent issuance of a license to do business within the City. Any prerequisites for a type and location of the business must be satisfied prior to licensing.
