



LEGAL DESCRIPTION

Commence at an old 2" pipe at the SE corner of the Southwest ¼ of the Southeast ¼ of Section 34, Township 19 South, Range 5 West; thence Northerly on an azimuth of 00°49′30° a distance of 118.00 feet to the point of beginning; thence proceed northerly along the previous course a distance of 230.60 feet to an old ½" rebar on the southerly line of Bruce A.
