ORDINANCE NO. 22-0614-02

AN ORDINANCE TO AMEND SUBSECTION F(2) OF SEC. 82-4 ENTITLED "WASTE COLLECTION" OF ARTICLE I ENTITLED "IN GENERAL" OF CHAPTER 82 ENTITLED "SOLID WASTE" OF THE CODE OF ORDINANCES OF THE CITY OF HUEYTOWN, ALABAMA

Be it ordained by the City Council of the City of Hueytown as follows:

Section 1. That Subsection (f)(2) of Section 82-4 entitled "Waste Collection" of Article I entitled "In General" of Chapter 82 entitled "Solid Waste" of the Code of Ordinances of the City of Hueytown, Alabama, is deleted in its entirety and the following is substituted in its place:

"(2) For purposes of this section, "trash" shall mean:


- a. Tree trunks means that part of a tree more than six inches in diameter. Tree trunks shall be no longer than three (3) feet in length and less than eight (8) inches in diameter.
- b. Tree limbs: tree limbs shall be no longer than six (6) feet in length and less than six (6) inches in diameter.
- c. Leaves and grass clippings: All leaves and grass clippings shall be bagged by the resident in a biodegradable bag capable of natural decomposition and suitable for landfill use.
- d. Untreated wood only."

Section 2. All Ordinances or parts of Ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 3. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable, and, if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.




