WHEREAS, Mount Moriah Missionary Baptist Church "CHURCH" located at 330 Marsh Avenue, Hueytown, Alabama suffered a great loss due to a fire; and

WHEREAS, the estimated cost to reconstruct the facility is three million four hundred thousand two hundred and forty dollars (\$3,400,240.00) and

WHEREAS, after the "CHURCH" received funds from the "CHURCH" insurance company, there is a deficit of one million five hundred thousand dollars (\$1,500,000.00) to rebuild the facility; and

WHEREAS, upon request of the "CHURCH" presented to the City City Council to consider the waiver of the permitting fees estimated to be seventeen thousand three hundred and ninety dollars (\$17,390.00); and

WHEREAS, a proposed Resolution has been prepared and discussed by this City Council that this waiver of public funds for the purpose herein specified will serve a valid and sufficient public purpose, not withstanding any incidental benefit accruing to any private entity or entities.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUEYTOWN, ALABAMA, THAT:

- 1. The Recitals above are true, correct, approved and included herein as if fully set forth.
- 2. The City Council hereby sets a Public Hearing for Resolution 6668 granting waiver of said building permit fees to be held in the Council Chamber of Hueytown City Hall on September 26, 2023 at 6:00PM.
- 3. The City Clerk is authorized to publish in the Alabama Messenger a "Notice of Public Hearing" to be held for consideration of Resolution 6668 to grant waiver of building permit fees for construction of the Mount Moriah Missionary Baptist Church.
- 4. The Mayor and Staff shall have the full authority to do those things, perform those functions, make such decisions, and to sign necessary documentation in order to carry out and fully complete the actions so authorized herein.
- 5. The provisions of this Resolution are severable if any part of this Resolution is determined by a court of law to be invalid, unenforceable or unconstitutional, such determination shall not affect any other part of this Resolution.
