The Village is divided between Kane County in the south and McHenry County in the north.

HUNTLEY POLICE OFFICERS ARE REPRESENTED BY THE METROPOLITAN ALLIANCE OF POLICE, CHAPTER #207. WE OFFER A COMPETITIVE SALARY STARTING AT \$64,130 IN 2021 AND TOPPING OUT IN EIGHT YEARS AT \$100,127. THE WORK SCHEDULE IS BASED ON A 12-HOUR DAY ALLOWING THE OFFICERS EVERY OTHER WEEKEND OFF DUTY WITH ROTATING DAYS OFF DURING THE WEEK. AUTHORIZED SWORN OFFICERS IN 2020 : 36



GEOGRAPHIC POLICING

THE HUNTLEY POLICE DEPARTMENT IS STRUCTURED TO DELIVER POLICE SERVICES THROUGH THE PRACTICE OF GEOGRAPHIC POLICING. THE VILLAGE IS DIVIDED INTO FOUR AREAS. AN AREA SERGEANT IS ASSIGNED TO EACH SECTION AND THAT SERGEANT IS RESPONSIBLE FOR THE COMMUNITY NEEDS IN THAT SPECIFIC AREA. THE SERGEANT TRACKS ACTIVITY, ANALYZES CRIME TRENDS, MONITORS TRAFFIC ISSUES, IDENTIFIES AND RESPONDS TO NEIGHBORHOOD PROBLEMS AND SERVES AS A CONDUIT BETWEEN THE COMMUNITY AND THE POLICE DEPARTMENT.

CALEA ACCREDITED AGENCY

THE PURPOSE OF CALEA (COMMISSION ON ACCREDITATION FOR LAW ENFORCEMENT AGENCIES) IS TO ESTABLISH STANDARDS OF PROFESSIONAL EXCELLENCE FOR PUBLIC SAFETY AGENCIES, AND TO DEVELOP AND ADMINISTER A PROCESS FOR RECOGNIZING PROFESSIONAL EXCELLENCE. ON JULY 31, 2010, THE HUNTLEY POLICE DEPARTMENT WAS AWARDED FULL ACCREDITATION STATUS BY CALEA. UPON ACCEPTANCE, THE HUNTLEY POLICE DEPARTMENT BECAME ONLY THE SECOND AGENCY IN MCHENRY COUNTY TO OBTAIN THIS COVETED AWARD. THE AGENCY HAS SINCE OBTAINED REACCREDITATION IN 2013, 2016 AND 2020.
