LIQUOR COMMISSION HEARING
August 9, 2018
MINUTES

CALL TO ORDER:

A meeting of the Huntley Liquor Commission was called to order on Thursday, August 9, 2018 at 7:00 p.m. in the Municipal Complex, Village Board Room, 10987 Main Street, Huntley, Illinois 60142.

ITEMS FOR CONSIDERATION:

- A. Consideration of an Ordinance for the Approval of an Outside Event: Cuhlife LLC Huntley d/b/a Lucky Bernie's / Riddick's Ride Foundation Fundraiser / 9800 Route 47

Chairman Sass reported that a request has been received from Cuhlife LLC Huntley d/b/a Lucky Bernie's (Lucky Bernie's) to conduct an outside event to raise money for the Riddick's Ride Foundation on Sunday August 19, 2018. Lucky Bernie's is located north of Reed Road next to Dunkin Donuts.

Staff Analysis

The event will include small tents, music performed by solo artists, food and drinks, and miscellaneous events for the kids. The hours of the event will be from 1:00 p.m. until 7:00 p.m. with outside alcohol service ending at 6:30 p.m. The event area will utilize all parking spaces on the east side of the parking lot leaving the west side parking spaces available for patrons. The entire area will be fenced.

The owner of the shopping center, who is also the owner of the other tenant Dunkin Donuts, has provided a letter of their approval for the event to take place in the parking lot.

Chairman Sass asked if the Liquor Commission had any comments or questions.

Commissioner Piwko asked if this was going to be an annual event. Ms. Kathleen Leavitt (owner) reported that this is a one-time event.

A MOTION was made to approve an Ordinance approving the outside event for Cuhlife LLC Huntley d/b/a Lucky Bernie's; 9800 Route 47 for a Fund Raising event for Riddick's Ride Foundation subject to the following conditions of approval:

1. The approved alcohol can only be sold and consumed within the restaurant and designated fenced area.
2. The petitioner agrees that the event is to be undertaken in accordance with all reasonable Village requirements including all necessary permits, rules and regulations of the Village, the Huntley Fire Protection District, and the Illinois State Liquor Control Commission.
