The Commission was notified that the Village will begin the process to start a new Lateral Transfer Eligibility List this month, and will begin researching vendors for a new Police Officer Recruitment Eligibility List.

Other Business:

Chairman Jim Burgess and Commissioner Dan Maloney brought forth the discussion to have Police Commission members complete more IFPCA training modules to benefit the commission. HR Director Chrissy Hoover mentioned all renewals for the Illinois Fire and Police Commissioners Association have been processed.
