Permit Application for Dog Friendly Restaurants

- (1) Please attach a diagram and description of the outdoor seating area to be designated as available to patrons' dogs. The diagrams must be accurate and to scale but need not be prepared by a licensed professional. The diagram shall include dimensions of the designated outdoor seating area; a depiction of the number and placement of tables, chairs, and restaurant equipment, the entryways and exists to the designated outdoor seating area, outdoor areas **not available** for patrons' dogs, fences and/or other barriers, surrounding property lines including rights-of-way. Please indicate the location of required signage and permit display on the diagram and provide photos of the proposed location.
- (2) Please provide a signed and notarized statement that the permittee shall hold harmless and indemnify the Village from any claims for damage to property or injury to persons which may be occasioned by any activity carried on under the terms of this permit (template included in application).
- (3) Please attach insurance certificate. The permittee shall provide and maintain liability and property damage insurance providing coverage for all claims and damage to property or bodily injury, including death, which may arise out of incidents related to or caused by dog(s) in the establishment. Insurance coverage shall provide limits of not less than \$1,000,000 for bodily injury or property damage, per occurrence. All insurance shall be from companies duly authorized to do business in the State of Florida and acceptable to the Village. Policy shall state that it will not be terminated or cancelled without 45 days' written notice sent via certified mail to the Village Licensing Official.

Please note that the following notices must be in the form of a sign or signs posted in a conspicuous manner to employees and patrons in the designated outdoor seating areas available for patrons' dogs, as applicable:

- Notice to employees to wash their hands promptly after touching, petting or handling dog(s) and before entering other parts of the public food service establishment.
- Notice to employees that they are prohibited from touching, petting or otherwise handling dog(s) while serving food, beverages or handling tableware.
- Notice to employees to clean and sanitize all table and chair surfaces between seating patrons.
- Patrons' shall be advised to wash hands before eating.
- Waterless hand sanitizer shall be located on all tables in the designated outdoor seating areas available for patrons' dogs.
- Patrons shall keep their dogs on a leash at all times and shall keep their dogs under reasonable control.
- Notice to employees and patrons that all dog waste shall be removed immediately and floor/ground area shall be cleaned and sanitized with an appropriate product. Employees shall keep a kit with appropriate materials for this purpose near the designated outdoor seating area available for patrons' dogs.

- Signage notifying the public that the designated outdoor seating area is available for patrons' dogs.
- Ingress and egress to the outdoor seating area with patrons' dogs shall not require entrance into or passage through any indoor area or non-designated outdoor portion of the public food service establishment.
- Dogs shall not be allowed on chairs, tables or other furnishings.
- Permits shall be displayed in the designated approved outdoor seating areas available for patrons' dogs.
