



Circus	\$100.00	Per Day
Coin Op. Amusement / VGT	\$\$35.00/\$100.00	Annual- July 1 st – June 30 th Pro-Rated at half after January 1 st
Golf Cart / UTV	\$100.00	Annual- May 1 st – April 30 th
Horse Drawn Vehicle	\$100.00	Annual- January 1 st – December 31 st
Itinerant Merchant / Transient Vendor	\$75.00	Monthly
Itinerant Merchant / Transient Vendor	\$200.00	Annual- From Date of Application
Motion Picture Theater	\$100.00	Annual- January 1 st – December 31 st
Peddler	\$20.00	Per Day, Per Person
Raffle	\$50.00	Annual- Club (charitable, educational, fraternal, labor, religious or veterans administration) – From Date of Application
Raffle	\$25.00	All Other Raffles less than \$5,000 in prizes- License to be issued no more than 90 days prior to drawing and expires on day of drawing
Raffle	\$150.00	All Raffles between \$5,000 & \$50,000 in prizes- License to be issued no more than 90 days prior to drawing and expires on day of drawing- Subject to Council Approval
Raffle	\$250.00	All raffles more than \$50,000 in prizes- License to be issued no more than 90 days prior to drawing and expires on day of drawing- Subject to Council Approval

Skating Rink	\$50.00	Annual- January 1 st – December 31 st
Tattoo Parlor	\$50.00	Annual- January 1 st – December 31 st
Taxi Owner	\$100.00	Annual- January 1 st – December 31 st
Tree Trimmer	\$100.00 Per Hauling Vehicle	Annual- January 1 st – December 31 st
Waste Hauler	\$50.00 plus \$100.00 Per Hauling Vehicle	Annual- January 1 st – December 31 st
