Township Proposals:

Blue Lake Township

ROAD PROPOSAL

This proposal will permit the Township to levy up to 1.5 mills for the purpose of providing funds for the construction and maintenance of roads in the township.

Shall the limitation on the amount of taxes which may be imposed on taxable property in the Township of Blue Lake, County of Kalkaska, State of Michigan be increased by up to one dollar and fifty cents (\$1.50) per thousand dollars (\$1,000) (1.5 mill) of the taxable value on all taxable property in the township for five (5) years, 2021 through 2025, inclusive, for the purpose of providing funds for the construction and maintenance of roads in the township, and shall the Township levy such millage for these purposes? If approved and levied in its entirety, it is estimated that the 1.5 mills would raise an estimated \$169,240 for the township when first levied in 2021.

Clearwater Township

RENEW FIRE MILLAGE

This proposal reestablishes the 1 mill fire department millage previously approved by the electors that expires December 31, 2021. Specifically, this proposal renews the previously authorized 1 mill Fire Department operations levy.

Shall the limitation on the amount of ad valorem taxes which may be levied by the Township of Clearwater, Kalkaska County, Michigan, against taxable property in the Township be renewed at 1 mill (\$1.00 per \$1,000 of taxable value) for a period of 4 years; 2022 through 2025, inclusive; for the purpose of providing funds for the operation and maintenance of the Township Fire Department and firefighting equipment. Shall the Township levy such millage for these purposes? Approved and levied, this millage would raise an estimated \$139,416 for Township Fire Department 2022 operations.

Springfield Township

FIRE EQUIPMENT MILLAGE

This proposal will permit the Township to levy up to 1 mill for the purpose of providing funds to purchase firefighting equipment and other capital improvements for fire protection services.

Shall the constitutional limitation on the amount of taxes which may be imposed on taxable property in the Township of Springfield, County of Kalkaska, State of Michigan be increased by up to one dollar (\$1.00) per thousand dollars (\$1,000)(1 mill) of the taxable value on all taxable property in the township for five (5) years, 2021 through 2025 inclusive, for the purpose of providing funds to purchase firefighting equipment and other capital improvements for fire protection services, and shall the Township levy such millage for these purposes? If approved and levied in its entirety, it is estimated that the 1 mill would raise an estimated \$48,760 for the township when first levied in 2021.
