### **Adopt Resolution EC1-23 to Consolidate Election Precincts for 2023**

Elections in 2023 will be for school bond proposals, three City Commission seats, and any other local proposals that may be approved. Historically, these local elections have low voter turnout, and it is beneficial to consolidate precincts where it will not add a burden for voters.

Motion by Robarge, seconded by Shane to adopt Resolution EC1-23 to Consolidate Election Precincts for calendar year 2023.

**RESOLUTION EC1-23**

**RESOLUTION TO CONSOLIDATE ELECTION PRECINCTS FOR CALENDAR YEAR 2023**

WHEREAS, Section 168.659 of the Michigan Election Law, Act 116 of 1954, provides for City Election Commissions to temporarily consolidate election precincts; and

WHEREAS, by consolidating precincts, voters will still be voting at their regular polling location, as follows:

<i>Precincts</i>	<i>Location</i>
Precincts 1, 4, 5	Kentwood Activities Center, 355 – 48 <sup>th</sup> St SE
Precincts 3, 6	Kelloggsville CRC, 610 – 52 <sup>nd</sup> St SE
Precincts 13, 15	St Paul UMC, 3334 Breton Ave SE
Precincts 14, 18	Covenant Park Clubhouse, 3724 Shaffer Ave SE

and

WHEREAS, it is in the best financial interest of the City to consolidate these precincts for elections with projected small voter turnout, and consolidation will have no negative impact on voters; and

WHEREAS, the Election Commission has confirmed the number of active registered voters for the temporary consolidations does not exceed 5,000 voters in compliance with Michigan election law;

NOW THEREFORE, BE IT RESOLVED that the City of Kentwood Election Commission approves the temporary consolidation of the above noted precincts for potential May, August and November 2023 elections.

The foregoing resolution was proposed by Commissioner Robarge and seconded by Commissioner Shane.
