Permission is requested to transport the following oversize and/or overweight vehicle or combination of vehicles with the listed maximum axle load in accordance with the following conditions and restrictions. Duration of the movements to be from \_\_\_\_\_ to \_\_\_\_\_. Location of the movements to be on any road or street in the City of Kentwood excluding and county or state truck lines.

**CONDITIONS AND RESTRICTIONS**

- 1) All movements shall be during daylight hours only. Permit is not valid on Saturdays, Sundays, nor during the period beginning at 12:00 noon on the day preceding and continuing until 12:00 noon the day after the following holidays listed here: New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.
- 2) The Movement shall not impede other traffic and at no time shall other traffic be detained unnecessarily from use of the highway. The driver is to pull off the highway to allow traffic to pass when ever excessive congestion develops.
- 3) Applicant shall be responsible for any damage caused to or along the highway and shall save harmless and indemnify the City of Kentwood from all suits, claims, damages and proceedings of every kind arising out of the use of the highway by the movement.
- 4) The speed of the vehicle and load shall not exceed 30 miles per hour. Vehicle shall not be loaded or unloaded within the shoulder lines of any road under jurisdiction of the City of Kentwood. Vehicles shall not be left on the highway during day or night
- 5) Applicant must furnish complete equipment information outlined on the back of this application
- 6) The driver of the vehicle shall carry the permit in the vehicle to which it applies and shall have it available for inspection by any police officer or agent of the City of Kentwood.
- 7) The Application shall submit a certificate of insurance showing that at least the following motor vehicle insurance coverage is in full force and effect on each vehicle while operating under this permit:

Bodily injury liability	each person	\$100,000
Bodily injury liability	each accident	\$300,000
Property damage liability	each accident	\$50,000
- 8) Permit is automatically invalidated by the violation of any of the conditions or a restriction specified herein or by false information given on the application, this permit revocable at once at the will of the City of Kentwood.
- 9) Permit is not valid for periods extending beyond expiration date of vehicle registration or motor vehicle insurance, which ever comes first.
- 10) Permit will be issued only for vehicles owned or leased and licensed by applicant.
- 11) Permit will not be issued for oversize or overweight vehicles or loads which can be readily dismantled, reduced, or otherwise rearranged to come within the legal limits or which exceed 12 feet in width, 14 feet in height, 45 feet in length for straight trucks, 70 feet in length for combinations, or which exceed the statutory gross axle loading by 25%, or which exceed other statutory restriction, except the following will be allowed:
  - a. Road construction equipment, 12 ft., 6 in. in width, 14 ft. in height, and 70 feet in length
  - b. Mobile homes, 12 ft. in actual body width and fixtures not to exceed 3 in. on each side, 14 feet in height, 70 ft. in body length of the mobile home and 85 feet over-all length with lowering vehicle.
- 12) Permit is not valid on highways or structures which are posted for lighter than normal loading if the vehicles exceeds loadings as posted. Permit is not valid for overweight when restricted loadings are in effect.
- 13) Loads shall be arranged to effect minimum width. Crosswise loading is not permitted
- 14) The boom on cranes or draglines is to be securely fastened to the frame of the truck and parallel to the highway while in transit. The ball or bucket is to be removed from the boom.
- 15) All vehicles and loads shall be properly and sufficiently flagged. Such flags must be red in color, clean, and at least 16 square inches.
- 16) The City of Kentwood may suspend an extended transportation permit, either in its entirety or in respect to certain of its provisions, due to season or other special conditions
- 17) If this equipment is to be moved on any road other than specified in this permit, permission be obtained from the appropriate authority
- 18) Permit is issued only for specific vehicles described on the back of this application to move the specific equipment also described in this application. No other vehicle or part of vehicle may be used and no other equipment may be transported.
- 19) Permit valid only if favorable driving conditions prevail
