We look forward to your contributions to this exceptional and growing community.



# HOW TO REPORT AN ISSUE

**Public Service Request** – Whether it's a pothole, tree or brush concern, park or playground issue, water or sewer concern, snowplow damage or other maintenance issues, it's easy to <u>report issues</u> <u>online</u>. Someone will respond to your inquiry within two business days. For urgent issues after 4 p.m. and on weekends or holidays, please call 616.554.0751.

**Code Enforcement Complaint** – If you need to file a complaint about issues such as abandoned vehicles, overgrown weeds or grass, a parking violation, sidewalk hazard, sign violation, yard waste or trash, you can submit the complaint <u>online</u>, **by phone** 616.656.6574 or **in person** at the Police Department, 4742 Walma Ave. SE.

**Power or Street Light Outages** – Streetlight or general power outages should be reported to Consumers Energy. For burned-out or flickering street lights, visit this <u>street light outage webpage</u>. For power outages, visit <u>Consumer Energy's online Outage Center</u>. You may also call 800.477.5050 for either situation.

**File a Police Report** – Residents can use our <u>online system to submit a police report</u> immediately and print a copy for free. Please confirm the following to find out if online police report filing is right for you:

- This is not an emergency.
- There are no injuries.
- This incident occurred within Kentwood city limits.
- There is no evidence to collect at the incident location and police follow-up is not required.
- For traffic crashes, it occurred on private property.

If your incident meets these criteria, you are ready to file your report online. Another option is to call the non-emergency number 616.698.6580 and ask for an officer to come to your location. For emergencies, always call 911.

# A GUIDE TO GENERAL RULES, REGULATIONS AND ACTIVITIES

### A - Accessory Buildings

A residential lot may have up to two accessory buildings, which can include an attached or detached garage and shed. Building and zoning permits are required for any one-story detached accessory structure larger than 200 square feet. Zoning administrator approval is required for one-story detached accessory structures 200 square feet or less in area. All accessory buildings must be structurally sound and maintained in good repair.

For questions about accessory buildings, including allowable sizes, locations and setback, call the Planning Department at 616.554.0707. Permit applications are available on our website at <u>kentwood.us/permits</u>. For questions about the building permit application process and building codes, contact the Inspections Department at <u>inspections@kentwood.us</u> or 616.554.0700.

#### **B** - Block Parties

Block parties are allowed upon review and approval by the City. A block party permit application is available on our website at <u>kentwood.us/BlockPartyPermit</u>. For more information, call the Department of Public Works at 616.554.0817.

#### **C** - Conflicts with Neighbors

Disagreements between neighbors can happen from time to time. When they do, the Dispute Resolution Center of West Michigan can help. The Center can assist residents with resolving disagreements about fences, property damage, trees and other issues.

The Dispute Resolution Center is located at 678 Front Ave. NW, Grand Rapids, MI 49504. Visit the <u>Center's website</u> or call 616.774.0121.

#### **Commercial Vehicles**

The storage of commercial vehicles is not allowed in residential areas. This includes heavy equipment, semitractors, semitrailers and other commercial vehicles that weigh more than 10,000 pounds. Heavy equipment may be parked overnight on a property during a construction project. The owner, tenant or lessee of a farm may openly store the machinery and equipment used on the farm.

To park a semitrailer for a recycling fundraiser in the lot of an institutional use in a residential area, a one-week temporary special exception permit from the zoning administrator is required. Permit applications are available on our website at <u>kentwood.us/permits</u>. For more information or to file a complaint, contact the Planning Department at <u>ePlanning@Kentwood.us</u> or 616.554.0707. You can also <u>file the complaint online</u>.

## **Children's Playhouses and Play Equipment**

Children's playhouses and play equipment are allowed in backyards only and cannot exceed 100 square feet. Playhouses cannot exceed 14 feet in height and must be placed so there is a minimum of 3 feet between the drip edge of the roof and the side and rear property lines.

# **E** - Elections

# F - Fences

Fences that follow City regulations are allowed in residential areas. A permit is required for any fence higher than 30 inches. All fences must be maintained structurally sound and in good repair. Permit applications are available on our website at <u>kentwood.us/permits</u>.

### Fireworks

The following rules are in accordance with state law, which was adopted in 2019. Fireworks are allowed only during the following days and times:

- From 11 a.m. on Dec. 31 until 1 a.m. on Jan. 1
- The Saturday and Sunday immediately preceding Memorial Day from 11 a.m. to 11:45 p.m. on each of those days
- June 29 to July 4 from 11 a.m. to 11:45 p.m. on each of those days
- July 5, only if that date falls on a Friday or Saturday, from 11 a.m. to 11:45 p.m.
- The Saturday and Sunday immediately preceding Labor Day from 11 a.m. to 11:45 p.m. on each of those days

Fireworks are not allowed other than on these permitted days. Violation can result in a penalty. To report the use of fireworks during prohibited times, call the Kentwood Police Department's non-emergency line: 616.698.6580.

Examples of legal fireworks include firecrackers, bottle rockets, roman candles and certain aerial shells not exceeding 1.75 inches in diameter. To learn more, visit <u>kentwood.us/FireOrdinances</u> or call the Fire Department at 616.554.0804.

## Flagpoles

Flagpoles are allowed as long as they do not exceed the maximum building height permitted by City ordinance:

- For the R1-A single family residential district, the maximum height is 35 feet.
- For the R1-B, R1-C, and R1-D single family residential districts, the maximum height is 25 feet.
- For the R2 two-family residential district, the maximum height is 25 feet.
- For the R-PUD-1 and R-PUD-2 districts, the maximum height is 35 feet.
- For commercially zoned properties, the maximum height is 45 feet.
- For industrial properties, the maximum height is 45 feet.

If you are considering adding a flagpole, call the Planning Department at 616.554.0707.

# **G** - Garage/Yard Sales

The Zoning Ordinance allows for garage/basement/yard sales that last no more than four days during a three-month period. For more information or to file a complaint, contact the Planning Department at <u>ePlanning@Kentwood.us</u> or 616.554.0707. For information on garage/yard sale signs, please see see the guidance on page 16.

## **Gypsy Moths**

Please use <u>this form</u> to report gypsy moths in your home or neighborhood. Questions regarding the <u>Gypsy Moth Suppression Program</u> for the City of Kentwood can be directed to Deputy City Administrator Shay Gallagher at 616.554.0770 or <u>GallagherS@kentwood.us</u>.

#### H - Home-Based Businesses

Home-based businesses are allowed upon City review and approval. More information about starting and running a business in Kentwood is available at <u>kentwood.us/StartingABusiness</u>. If you are considering a home-based business, you can call the Planning Department at 616.554.0707 for assistance.

#### **Household Animals**

A household may have up to a total of three dogs or cats in any combination (not three of each). For ducks, chickens, bees, goats, rabbits and other domestic animals, fowl or insects, zoning administrator review and approval is required. Applications may be denied if the zoning administrator believes it may create a nuisance related to odor or noise.

Up to two horses for personal use are allowed within certain areas of the City. Large farm animals, including cows and pigs, are not allowed.

## **Household Trash and Litter**

Trash is collected by private companies. One or more containers with tightly fitted covers may be used for the disposal of household trash. The containers must be kept reasonably clean and be rodent proof. All residential garbage containers must be stored inside a structure or at the rear or side of a building. The containers cannot be filled beyond capacity or placed out for collection no earlier than 6 p.m. the day before the regularly scheduled pickup. They must be returned to their storage spot on collection day. The accumulation of trash, junk, scrap, debris, industrial or construction waste, litter of any kind, waste materials, waste products, excess dirt or soil or any other dangerous or unsightly materials on a property is prohibited.

# l - Inoperable and Unlicensed Vehicles

All vehicles parked outside a building must be licensed and be able to operate lawfully and safely on City streets. For more information or to file a complaint, call Code Enforcement at 616.656.6574. You can also <u>file the complaint online</u>.

# L - Landscaping

Seeding or sodding is the minimum acceptable landscaping of any lot or parcel of land within the City. Gravel, wood chips, stone or other non-vegetative materials cannot be substituted for grass. This does not exclude the allowance for limited decorative use of such materials.

The area between the street paving or curbline and the property line or sidewalk, with the exception of driveways and walkways, must be used exclusively and maintained as landscaped area with grass, trees and other plants and materials as approved by the City. For more information or to file a complaint, call the Planning Department at 616.554.0707. You can also <u>file the complaint online</u>.

## Lawn Mowing (Weeds, Grasses or Undergrowth)

All properties must be maintained to prevent weeds, grasses or undergrowth higher than 6 inches. The only exceptions to this regulation are:

- Portions of undeveloped property behind a wooded tree line.
- Portions of unsubdivided lands more than 25 feet from a public sidewalk, walkway, driveway, street or other public right-of-way.
- Portions of undeveloped lots in a subdivision less than 60% developed and more than 25 feet from a public sidewalk, walkway, driveway, street or other public right-of-way.

# Leaf, Brush and Holiday Tree Recycling

On designated dates in the spring and fall, residents may drop off leaves and brush at the Department of Public Works, 5068 Breton Ave. SE. Only loose leaves and grass clippings are accepted – no branches, dead plants, containers or bags. On designated dates in the winter, we also offer an annual tree recycling site at the Department of Public Works. # ${\tt M}$ - Mailboxes and Other Objects in the Public Right-of-Way

The following are allowed in the public right-of-way, the section of land between the sidewalk and street:

- Mailboxes with a 4-inch-by-4-inch wood post or a maximum 3-pound-per- foot metal post.
- Public and private utilities by City permit only.
- Trees by City permit only. Planting must be done only in the exact location indicated in the permit.
- Wood or stone driveway curbing 6 inches or less in height and not within 5 feet of the pavement edge. It is the property owner's responsibility to restore wood or stone curbing if it is disturbed during normal street maintenance.


Vegetation, embankments and objects such as rocks, fences and basketball hoops are not allowed in the street right-of-way.

## **0** - Obstruction of Sidewalks and Clear-Vision Corners

Trees, shrubs, bushes, weeds or other plant growth cannot obstruct a sidewalk, walkway, driveway, street or other public right-of-way. No plantings or structures that will obstruct the view of a driver approaching the intersection or entering or exiting a driveway can be added or maintained on any corner lot or along the driveway.

For corner lots, the clear vision area is a triangle formed by the street right of way, which includes both the street pavement and sidewalk, and a line connecting them at points 25 feet back from the intersection lines. Shrubbery less than 30 inches in height is allowed in this area. Tree branches must be at least 10 feet above the adjoining street level within the clearance corner.

## **Open Burning**

A recreational fire is allowed only in a purchased appliance approved for this purpose. The appliance must be fully enclosed with screens in place and the lid on. It must always be used on a non-combustible surface and be a safe distance from any structure, vehicle or fence. Only firewood may be burned in the appliance – no yard waste, trash, paper, leaves or any other combustible material.

A working garden hose or fire extinguisher must be nearby, and an adult must always be present when

the appliance is in use. After use, the fire must be fully extinguished. For information about recreational fires or to file a complaint, call the Fire Department at 616.554.0804.

# **P** - Parking of Vehicles

In residential areas, parking in the front yard is restricted to an improved driveway or garage, except in an emergency or when necessary to follow the direction of a police officer or traffic control device. An improved driveway means a private road, drive or parking area designed for parking or turning movements.

Property owners may install an additional parking lane adjacent to the driveway with zoning administrator approval. For information on adding a parking lane, call the Planning Department 616.554.0707.

Please note, **winter on-street parking rules** are in place every year Nov. 15-March 15. During that time, parking is not allowed on any public street 1 a.m.-8 a.m. any day or any time street parking makes it difficult for snow removal.

## ${\bf R}$ - Recreational Vehicles, Recreational Equipment and Utility Trailers

All utility trailers, recreational vehicles and recreational equipment should be stored in the backyard. If it is not possible to use the backyard for storage, these types of vehicles and equipment may be stored in the side yard. However, they must be as far to the back of the side yard and as far away from neighboring lot lines as possible.

Items such as detachable camper tops may not be stored in any residential zone unless it is in an enclosed building. Recreational vehicles and/or equipment cannot be lived in or have fixed connections to electricity, water, gas or a sanitary sewer. A permit for sleeping accommodations only not to exceed two weeks may be obtained from the zoning administrator.

There are exceptions that allow for a utility trailer, recreational vehicle or recreational equipment to be temporarily placed in the front yard. # **Repair of Vehicles**

The owner or resident of a home may perform mechanical work on an owner-operated vehicle, but the work must be performed within an enclosed building. # **S** - Selling of Vehicles

The selling of a vehicle is allowed in a residential area only when it is owned by the current resident or property owner. The resident or property owner may sell one vehicle for up to 30 days within a sixmonth period. The vehicle for sale is restricted to a paved driveway.

## Signs

Temporary signs that are 6 square feet or smaller must be kept on the property that is for sale or where a garage or yard sale is happening. These signs may not be placed on public property such as telephone poles or in the public right-of-way, which is the section of land between the sidewalk and street. Following are the requirements for non-commercial signs:

- Number of signs:
  - **Residential zones** One per each candidate or issue per lot, parcel or tract. No exception for corner lots, parcels or tracts.
  - **Office, commercial and industrial** One per each candidate or issue per street frontage.
- Maximum size of signs:
  - Residential and multi-family zones 6 square feet
  - Office, commercial and industrial 32 square feet
- Signs may not be placed in the right-of-way or attached to utility poles, mailboxes etc.
- Where there are sidewalks, signs must be placed one foot back from the sidewalk.
- The public right-of-way generally extends 30 feet out from the centerline of local streets, for each side of the street and likewise extending 50 feet from the centerline of major streets.

• Permits are not required for non-commercial (political) signs, however the consent of the property owner should be secured before installation.

### **Skateboard Pipes and Ramps**

## Sound Amplifiers and Other Loud Noises

No loud noise is allowed 11 p.m.-7 a.m. every day except when a permit has been issued by the City. The use of any loudspeaker, sound amplifier or other electrical or mechanical device intended to increase the volume of sound without a <u>sound permit</u> is not allowed. If you have any questions regarding sound permits, please contact the Kentwood Police Department at 616.698.6580.

## **Swimming Pool and Hot Tubs**

Residents may install swimming pools, hot tubs and similar structures as long as they meet all applicable building and zoning codes. A building permit for a swimming pool or hot tub is required for pools and hot tubs with a water depth of more than 24 feet.

## Sidewalk Snow Removal

Property owners are responsible for keeping the sidewalks and fire hydrants on their property clear of snow, ice and other hazards. Residents are required to shovel if two or more inches of snow fall on the sidewalk. Sidewalk snow removal must be done within 24 hours after snowfall has ended. ## **Street Snowplowing**

The City of Kentwood's Department of Public Works makes every attempt to have all the roads cleared within 24 hours after the snow event has ended. During most snow events our crews are working around the clock with trucks on the road 24 hours a day, sometimes for several days in a row.

We prioritize winter operations from highest volume street to lowest volume street in the following order:

1. **Major streets** within the City of Kentwood with the most traffic are the first priority when it comes to snow removal. A few examples of major streets are 44th Street, 52nd Street, Kalamazoo Avenue and Eastern Avenue. We plow and salt the major routes first during a snow event.

- 2. **Collector streets** are the "main" streets throughout many of the subdivisions where you live. They act as the most effective way to enter or exit an area adjacent to the major streets. These routes are plowed and salted after the major streets have been cleared and are as safe as possible to travel on. Some examples of collector streets are: Baileys Grove Drive, Stauffer Avenue and Gentian Avenue.
- 3. **Local streets** are the streets within the subdivisions themselves. We plow these once the collectors are cleared and safe for travel. We typically do not spread salt on the local streets.
- 4. **Cul-de-sac/stub streets** are plowed last with smaller pickup trucks. We direct the snow to areas in the cul-de-sac that are suitable for snow storage. Please make sure all items are removed from the cul-de-sacs such as: soccer goals, portable basketball hoops and any other miscellaneous items.

There are many times when we have finished one classification of street and moved into another and Mother Nature decides to disrupt our plan. In these cases, as the major roads deteriorate, we will shift our attention back to them and then the cycle starts over. #### **Snowplow Damage**

If a City snowplow has damaged your mailbox or other personal property, please visit our <u>Report an</u> <u>Issue</u> page. Someone from the City will contact you within two business days.

Any mailbox damaged as a result of plowing or scraping the roadway, the City, after an inspection by staff, and with a current and valid receipt, will reimburse up to \$70 for the mailbox and/or post. It is the homeowner's responsibility to properly install the mailbox and/or post according to the USPS standard guidelines. Once installed, the Department of Public Works staff will re-inspect.
