Pride and City Staff briefly discussed a chance in the next quarter that Pride revenues will be less than current revenues due to Covi-19 and business reducing

waste.

Peter Watts introduced the issues and stated that part of the street was dedicated, and the other half was not. In Resolution 115, the City accepted a quitclaim deed from Royal Gardens HOA. Whether the quitclaim deed dated March 30, 1987, was never filed with Washington County or was filed and rejected by the County is not apparent. The City has no record of further action or inaction.

The only way to properly file this was by dedication deed. Peter mentioned a 2004 case before the Land Use Board of Appeals, Linderhof v. Deschutes County, LUBA No. 2004-156, related to the dedication of a County road that is analogous to our current situation. In that case, LUBA wrote:

"Three actions were required to complete a dedication of land for a county road...
(1) a deed that dedicated land for a public road, (2) acceptance of that deed by the county court, and (3) recording of the deed."

Because all three of those steps had not occurred, the road had not been dedicated. The same is true in this case.

Berry O Conner, the HOA president, left a message to be played during the meeting. he had questions for the attorney (Peter Watts) if in his preparation of the staff memo - if he referred to Ordinance 55 "An Ordinance accepting Lot 28, Block 15, King City #3, Now Known as S.W. Royalty Court as a city street and taking jurisdiction thereof for public and municipal purposes."

Peter stated that this was only for a portion of the Royalty Court roadway.

Staff, legal counsel, and the city council discussed further.

Council directed legal to write up language stating that unless the city standards are met, the City cannot take jurisdiction of this area.

Chief Happala read the proclamation:

To recognize National Police Week 2020 and to honor the service and sacrifice of those law enforcement officers killed in the line of duty while protecting our communities and safeguarding our democracy.

WHEREAS, there are more than 900,000 law enforcement officers serving in communities across the United States, including the dedicated members of the King City Police Department; and

WHEREAS, the Congress and the President of the United States have designated May 15 as Peace Officer's Memorial Day, and the week in which May 15 falls as National Police week; and

WHEREAS, the members of the police department of King City, Oregon play an essential role in safeguarding the rights and freedoms of the citizens of King City; and

WHEREAS, it is vital that all citizens know and understand the duties, responsibilities, hazards, and sacrifices of the members of the King City Police Department, and that members of the King City police department recognize their duty to serve the people by safeguarding life and property, by protecting them against violence and disorder, and by protecting the rights and dignity of all citizens.

WHEREAS, the members of the King City Police Department unceasingly provide a vital public service;

NOW, THEREFORE, I the Mayor of King City, Oregon call upon all citizens of King City and upon all professional, civic, and educational organizations to observe the week of May 10-16, 2020 as Police Officer Memorial Week. A week that all of our citizens may join in commemorating law enforcement officers, past and present, who by their faithful and loyal devotion to their responsibilities, have rendered dedicated service to their communities and in doing so have established for themselves an enviable and enduring reputation for preserving the rights and security of all citizens.

I further call upon all citizens of King City, Oregon to observe May 15, 2020 as Police Officers' Memorial Day in honor of those law enforcement officers who, through their courageous deeds, have made the ultimate sacrifice in service to their communities or have become disable in the performance of their duty, and let us recognize and pay respect to the survivors of our fallen heroes.

In witness thereof, I have hereunto set my hand and caused the Seal of the City of King City to be affixed on this 15th day of April 2020.
