My qualifications for King City Council are based on my public sector employment with the City of Portland (1999-2011) and subsequent consulting with government agencies since 2011.

I worked for the city of Portland where I met then Parks & Recreation commissioner Charlie Hales who would later become mayor (2012-2016). I worked for Hales on his 2012 mayoral campaign.

During my 12 years with the city of Portland, I managed at three Parks & Recreation community centers before my retirement in 2011. Southwest Community Center (Gabriel Park), Mt. Scott Community Center in SE Portland and Charles Jordan Community Center in north Portland.

My work with Portland during this time provided exposure and education on the process of city government. In 2006-2007 I was chosen to represent the Portland Park Bureau in the budget review process.

During employment with the city of Portland, I developed workshops and provide seminars for annual state conferences. (ORPA - Oregon Recreation & Parks Association & WRPA - (Washington Recreation & Parks Association).

After Portland, I developed a consulting operation <u>Recreation at Your Service</u> (See attached).

In 1977 I accepted a position with a national New York based Branding, Marketing, labeling company. (Resume attached)

Time to hit the brakes on 'YMCA'

Let's set the record straight.

Bond measure 34-241 seeks \$34.5 million dollars to construct a community and recreation center. The Summary Notes attached to the City Notice of Measure Election specifies "The city expects the community & recreation center to be operated by a non-profit organization, such as a YMCA."

No contract has been awarded to anyone yet.

Advertisements by the Friends of the Downtown YMCA are premature.

I am a recreation professional. In September 2012, I was requested to make a presentation to the Tigard Parks & Recreation Board. This request was based on a seminar I had delivered to a state conference for Recreational Professionals earlier that year. I retired from Portland Parks & Recreation as a community center manager in 2011. I managed at Southwest Community Center, Mt. Scott Community Center and Charles Jordan Community Center. Presently, I provide seminars and workshops to public recreation organizations in Oregon and Washington. I teach a methodology to maximize profitability by efficient programming and service development.

In 2014, the city of Tigard awarded a contract to MIG, Inc. (a national recreational consulting group) to provide a comprehensive recreational study. It was completed in March 2015. The city paid \$62,000 for this study. I was part of that study. MIG, Inc. previously developed the 2009 Tigard Parks Master Plan.

The 2014 MIG, Inc. Recreation Program Study provided recommendations for the city to move forward and develop its own recreational planning. The study advised this could be accomplished with existing resources. A community center was not deemed a priority at this time.

This information was ignored.

The city then developed a partnership with the Columbia-Willamette YMCA to use a YMCA consulting company, Daxko T2, and then chose to move forward with an abbreviated study by Daxko T2 and develop this bond levy to build a community center with the YMCA as operator.

Why did the city choose this path?

In 2018, the 20-year contract between the city of Sherwood and YMCA ends.

In 2014, Sherwood generated a Review of the Operation Agreement with the YMCA to review its contract. If the city of Sherwood chooses not to renew its contract with the YMCA, they will assume all the revenue presently going to the YMCA. If the YMCA loses its contract with Sherwood, it will experience a drop in revenue.

It would be prudent to await the outcome of the Sherwood/YMCA contract negotiations in order to understand the long-term effects of signing a similar contract.

Who are the driving forces for this bond levy?

A citizens group was formed to promote the YMCA as the preferred operator. The Columbia-Willamette YMCA has contributed \$18,000 of the \$22,300 to the Friends of Downtown YMCA as reported in The Times on Sept. 24. This group failed to report the donations to ORESTAR, the state website that tracks campaign funding, until Friday — nearly a month after the complaint against them was filed. The Friends group has never published complete findings to support the claims it has made. It has advertised a specific downtown location that ironically is in a FEMA 100-year Flood Plain as confirmed by Brian Wegener of Tualatin Riverkeepers.

I was on the City of Portland Parks & Recreation Budget Committee for the years 2006 and 2007.

I am schooled in the intricacies of government process and procedures. No community center is necessary at this time for Tigard to begin a recreation program. The resources already exist.

I provided a comprehensive report and delivered it to Mayor John L. Cook and City Manager Marty Wine on Aug. 10. I have provided this report to the news media. I will make it available to any citizen who would care to view it.

Soapbox: The Tigard community center epilogue

With the defeat of bond measure 34-241, there are questions concerning accountability and transparency within city government.

The largest contributor to the Friends of the Downtown YMCA campaign was the Columbia-Willamette YMCA. The YMCA provided \$31,800 of the \$35,800 that the state of Oregon website ORESTAR shows was deposited.

The YMCA also contributed \$10,000 to the Daxko T2 study. Daxko website states "... they are the only consultant team with access to more than a decade of YMCA, JCC, and other community organization data." This brings the total amount of money the YMCA spent here to \$41,800.

In the Oct. 1 edition of The Times, reporter Geoff Pursinger provided information in his article, "YMCA campaign discloses campaign finance activity," that said: "Although the city has no formal agreement with the YMCA to operate any future Tigard facility, the measure's supporters have said for months that they expect the YMCA to operate the center should the bond pass muster with voters."

The "Friends" group distributed three mailers over the course of the campaign. In each, Tigard City Councilor Marc Woodard provided commentary stating his position that the YMCA would be the best operator for this planned community center based on the Daxko T2 study.

Daxko T2 is a YMCA consultant. Woodard's endorsement came before the vote was taken and other non-profit organizations were identified or considered.

This begs the following questions.

n Why did the Columbia-Willamette YMCA invest such a large amount of money?

n Did they believe this monetary investment would result in a different outcome?

n Who may have led them to believe that it was a done deal?

In total, the "Friends" group spent \$45,800. The vote totals as of Nov. 6 showed 3,866 "yes" votes. That works out to \$11.84 per vote. Not a very good return on this investment considering that the bond measure was defeated.

These may be questions for Bob Hall, President and CEO of the Columbia-Willamette YMCA.

Here is where we are now.

n There is an ongoing investigation into campaign finance violations by the "Friends" group.

n Information is being gathered for the Oregon Government Ethics Commission.

On October 28, an e-mail was sent to Mayor John L. Cook asking him to investigate the involvement of Woodard as it pertains to his involvement with the campaign based on his endorsement of the proposed community center operated by the YMCA.

This request to Mayor Cook was based on:

n Woodard's appearance and comments in all three YMCA campaign flyers

n Woodard's appearance on the TigardYMCA.com website

n Email records from Aug. 10-28 between Woodard and the Parks & Recreation Board attempting to accelerate the vetting process for potential operators of the proposed community center prior to the vote. (Copies of these emails were given to Pursinger.)

We believe that Councilor Woodard should be relieved of his position as liaison to the Parks & Recreation Board pending the outcomes of these investigations. If the public would like to provide input and comments, please contact Mayor Cook at <u>mayorcook@tigard-or.gov</u>

The TigardYMCA.com website is still up, but has a new posting that states:

"The 2015 campaign was a good test of the waters. It showed the only barrier to victory is low voter turnout ... something we knew. Now, our strategy is simple: Bypass the City Council and use the Citizen Initiative Process to place this on the ballot for the 2016 November Presidential election!"

Hmm. This is contrary to what Neal Brown said in the Oct. 5 Times about gathering signatures for next year.

Do you wonder how much more money the YMCA has to invest in this process?
