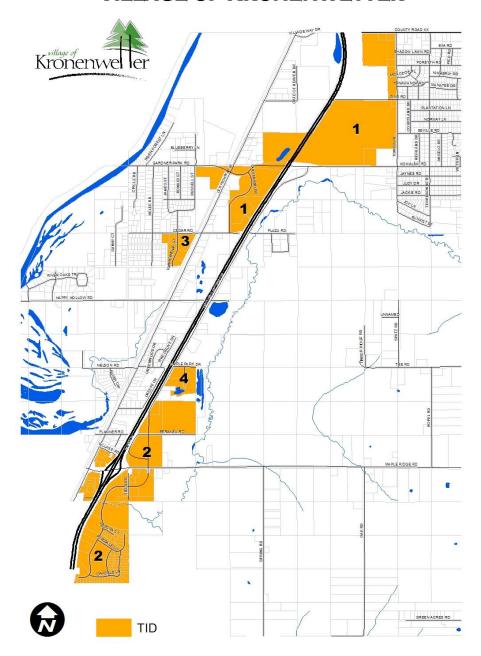

TID BOUNDARY MAP VILLAGE OF KRONENWETTER





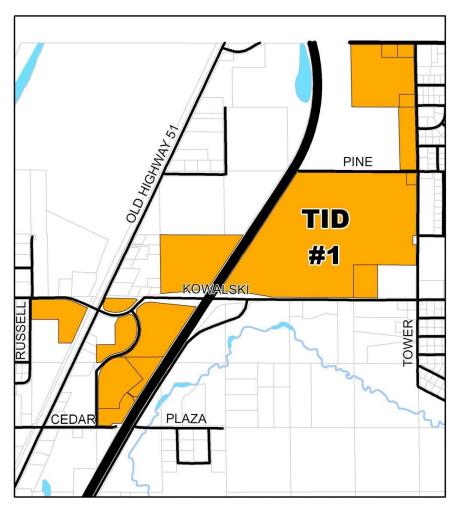

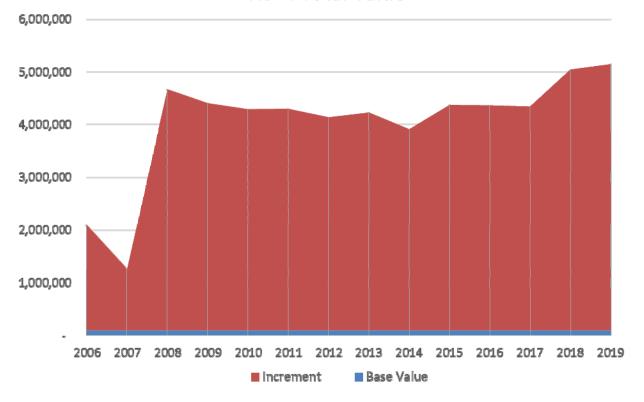
