

# Application for Water Delivery

All water that is delivered shall be done by Village of Kronenwetter personnel. Prior to any water being delivered, a completed application shall be on file with the Village of Kronenwetter, and this application shall include a signed waiver by the applicant indemnifying the Village of Kronenwetter and the Kronenwetter Water Utility from any claim or cause action for any injury to person or property. Delivery of water shall only occur to properties within the Village of Kronenwetter and shall be charged at a rate adopted by the Village of Kronenwetter Village Board from time to time. Deliveries shall be cancelled without notice to the property owner and rescheduled if there is a pressing need for the delivery equipment to meet an emergency service need, such as a structure fire, grass fire or other departmental need.
