



South Shore Beach 2024 Camper Application

Dear Campers,

The procedures for camper permit application have changed from previous years. A non-refundable processing fee of \$100 must be submitted with the camper permit application. The Beach Commission will give 50% off this fee for Senior Citizens (65 or older) and Veterans. Please read through the attached package, which explains the procedures.

Please note that in the rules for camper parking in addition to: the one vehicle allowed for self-contained campers, and the tow vehicle allowed for tow behinds; all additional vehicles, non-resident will be charged the non-resident daily rate and must be on the beach before 4pm. You must pick up the car parking pass at the gate if you are a non-resident. Non-resident vehicles will not be allowed in after 4pm without a parking pass.

PLEASE NOTE THAT THE “RULES FOR CAMPER PARKING” ENCLOSURE (3) WILL BE ENFORCED. VIOLATORS WILL HAVE THEIR CAMPING PRIVILEGES REVOKED AND THEIR RESERVATIONS WILL NOT BE ACCEPTED FOR THE REMAINDER OF THE CAMPING SEASON. There will be no refunds.

Fill out the new application completely and return it to the Little Compton Beach Commission, P.O. Box 226, Little Compton, RI 02837-0226. Thank you for your patience. It is our intention to provide the best level of accommodation possible to all. **Application cutoff date is 15 June 2024.**

The beach season ends Labor Day but camping is allowed till September 30th with a approved 2024 camper application. The Beach Commission as well as the Beach Manager has the right to enforce rules. The Beach Commission has the right to revoke parking and access privileges for infractions of beach rules.

NOTICE & RULES FOR CAMPING SOUTH SHORE BEACH LITTLE COMPTON

We currently have 11 camper sites on the Tunipus pond side of the parking lot. We will reserve 8 sites for residents and 3 sites for non-residents. If all the reserved sites have not been taken, they will be offered to anyone on the wait list.

- Applications are required for determination of vehicle (camper) standards compliance and for determination of residency. Applications must be approved prior to consideration for reservations.
- During the beach season (Memorial Day weekend until Labor Day) reservations will be required and can be made based on availability as follows:

Town residents may call the Beach 401-239-4818 after 9 AM on Mondays for reservations for the following weekend. Reservations will only be taken by phone to the above number which provides time stamp. There is no charge for town residents, however, a \$25 processing fee will be assessed for no shows unless notice of cancellation is provided by 3 PM on the Friday just prior to the weekend of the reservation.

Each camper shall make their own reservation.

Non-residents may call the Beach 401-239-4818 after 10 AM on Mondays for reservations for the following weekend. Reservations will only be taken by phone to the above number which provides time stamp. The fee for non-residents of the Town of Little Compton is \$40 per day (includes overnight).

A \$25 processing fee will be assessed for no shows unless notice of cancellation is provided by 3 PM on the Friday just prior to the weekend of the reservation.

Each camper shall make their own reservation.

For midweek campers (9 AM Monday arrival, through Friday 9 AM departure) reservations are required. Same fee structure as weekends applies. **

- ***Reservations will be held until noon Friday at which time they will be forfeited and considered as a no show unless prior arrangement has been made.***

** Exception - Holiday weekends - When a R.I. State, or Federal Holiday falls on a Friday or Monday; that day will be considered a weekend day for the purposes of the Application of reservation guidelines.

After season camping will be allowed for campers with approved application till September 30th. There will be no charge for after season camping. The gate will be locked at 11pm starting October 1st and camping will not be allowed.

All fees (application fee and per-night fee) must be paid prior to entering camp site.

Fees:

Non-Resident overnight \$50.

Non-Resident day pass \$40.
Residents only pay the application fee.

Non-resident campers must pick up a parking pass for a non-camper vehicle at the gate. One pass per site. Non-resident vehicles will not be allowed in after 4pm without a pass.

Fires are permitted for campers, but they must be in a self-contained fire pit that is above the ground and can not scorch the grass, per RI DEM. Campers do not need to purchase a fire permit. All fires must be extinguished by 10pm and fires should **never be left unattended.**

No tents, pop up campers or camper that are not self-contained. External septic tanks are not allowed.

Campers cannot be left unattended overnight.

We are a carry on carry off facility. Please take all materials that you have taken onto South Shore with you at the end of your stay.

We will have night security all season till 11pm. We expect campers to PLEASE contact night security before 11pm and Little Compton Police after 11pm if you see anyone violating the rules of the beach. Do not take matters into your own hands. It is important that we keep vandalism and rule violations to a minimum. If we don't, we may have to start locking the gate at 11pm and that will end camping for the season.
