

CONNECT


The networks act as a hub connecting and strengthening relationships of local public health, Tribal public health, community organizations, and others advancing health equity.

STRENGTHEN

We strengthen our communities' capacity to work on health inequities and advance health equity through training, technical assistance, and skills development.

AMPLIFY

We amplify the interconnected work of communities and public health systems. We support the local and Tribal public health systems to prioritize community solutions and engage with communities.



What is Health Equity?

Health equity is achieved when systems truly support all people and communities to have the opportunity to be as healthy as possible no matter who they are or where they live. This requires understanding the social inequities that impact health in each region, and actively working on those inequities.

Every region, community, and Tribal nation experience different inequities and require different solutions.


Narrative in Communications

A narrative is a powerful tool to connect with your audience, convey your message, and inspire action.

- The narrative are the pieces or parts that make up the story that share values, a central idea or belief, all of which guide behavior and influence how we move in the world
- Narrative can be intentional and become subconscious, framing how we tell our stories, address problems, view the world around us and assess the people and systems within it.

What is our narrative?

- Health Equity & Communication looks different in each region and community
- Each community has their own strengths, needs and solutions around communications and the way they talk about equity issues... some not saying the phrase "health equity"



Creating our narrative

- The networks use a relational approach
- Part of what we do is we set the grounding narratives
 - Foundational Frameworks
 - Health Equity Definition
 - Alignment with the Health Equity Bureau Connect, Strengthen, Amplify
 - Land Acknowledgment
 - Accessibility
