

RESOLUTION NO. 18-42

A RESOLUTION OF THE COMMISSION OF LUNA COUNTY, NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE COMMISSION CHAIR TO ACT AS THE COUNTY OF LUNA, CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE COUNTY OF LUNA, PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within the County of Luna for neighborhood improvement projects in several low and moderate income neighborhoods, and the County of Luna desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for neighborhood improvement projects; and

WHEREAS, the Commission has held three public hearings for public input and comment on August 28 during the 2018 application process; and **WHEREAS**, the Commission finds that there is a significant need to undertake the update to the Comprehensive Plan to provide adequate services to the community; and

WHEREAS, Commission determines that the update to the Comprehensive Plan meets the requirements of the Community Development Block Grant Program.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF LUNA, NEW MEXICO, that

1. The County of Luna is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for the Comprehensive Plan Update;
2. That the Commission directs and designates the Commission Chair as the County of Luna Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the County of Luna participation in the New Mexico Community Development Block Grant Program.
3. The County of Luna officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution.
4. That the full application amount be for \$50,000.00 of grant funds for the Comprehensive Plan Update;

5. That it further be stated that the County of Luna is committing \$2,500.00 from its General Fund as a cash contribution toward the professional services activities of this Comprehensive Plan Update.

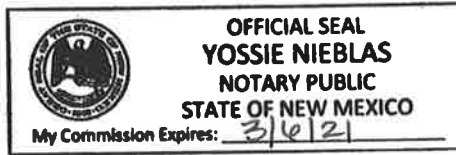
