

## CDBG POST SELECTION NOTICE OF PUBLIC HEARING

The County of Luna wishes to inform all interested parties that a public hearing will be held at the Luna County Courthouse, Commission Chambers, and 700 S. Silver Ave, Deming, NM on March 13, 2020 at 10:00 a.m.

The purpose of this meeting will be to report on past CDBG program activities and to discuss and to solicit input on possible community development needs and suggestions for future CDBG projects.

The Community Development Block Grant (CDBG) Program was established under Title I of the Housing and Community Development Act of 1974, as amended, in order to assist communities in providing essential community facilities, providing decent housing for residents, promoting economic development and maintaining a suitable living environment. The State of New Mexico estimates that approximately \$11,000,000 will be appropriated to be distributed statewide on a competitive basis.

State and national objectives of the CDBG Program require that assistance be made available for activities that address at least one of the following:

- 1) An activity identified and principally benefitting persons of low and moderate income
- 2) Aid in the prevention and elimination of slum and blight
- 3) Meet other community development needs of recent origin having a particular urgency because existing conditions pose a serious and immediate threat to the health and welfare of the community where other financial resources are not available to meet such needs.

Applications are limited to a maximum of \$500,000 without certified cost estimates and \$750,000 with certified cost estimates by a licensed professional. Planning applications which have a limit of \$50,000.

Eligible activities and categories will be described. All interested parties are invited to attend to submit project ideas, to provide supporting data and testimony, and other pertinent information.

With sufficient notice, a translator will be provided for non-English speaking residents.

El Condado de Luna Nuevo Mexico, quiere informar e invitar a todos los interesados a participar en unas audiencias publicas en el edificio del condado situado en la calle 700 S. Silver, Deming, Nuevo Mexico el dia 10 de Marzo, 2020 a las 10:00 de la manana.

Estas juntas consideraran propuestas de proyectos para aplicacion de fondos del Community Development Block Grant (CDBG). Anualmente el estado de Nuevo Mexico deberia recibir fondos en la cantidad de 11,000,000 (compruebe con el encargado de proyecto para saber si hay la figura actualizada).

El programa de Community Development Block Grant fue establecido en 1974 bajo el Title I/Housing & Community Development Act para asistir 1) a comunidades y a residentes de pocos o moderados recursos, 2) ayudar a eliminar barrios bajos, sucios y manchados 3) y tambien estos fondos se pueden usar en condiciones de emergencias que pongan en peligro inmediato a la salud y bienestar de la gente.

Las solicitudes están limitadas a un máximo de \$500,000 sin estimados de costos certificados y \$750,000 con estimados de costos certificados por un profesional con licencia. Planificación de aplicaciones que tienen un limite de \$50,000.

Se describirán las actividades y categorías elegibles. Se invita a todas las partes interesadas a asistir para presentar ideas de proyectos, proporcionar datos de apoyo y testimonios, y otra información pertinente.

Con suficiente antelación, se proporcionará un traductor para los residentes que no hablen inglés.
