NOTICE OF INTENT TO ADOPT AN ORDINANCE  
LUNA COUNTY BOARD OF COUNTY COMMISSIONERS**

NOTICE is hereby given, pursuant to Section 4-37-7, NMSA 1978, of the title and a general summary of the subject matter contained in the proposed amendment of Ordinance 96 which the Board of County Commissioners of Luna County intends to adopt at its Regular Meeting on September 10, 2020, at 10:00a.m. in the Commission Chambers at the Luna County Courthouse, 700 South Silver Street, Deming, New Mexico 88030, relating to:

The title of the amendment is:

AMENDING THE DELAYED REPEAL OF A COUNTY LOCAL OPTION GROSS RECEIPTS TAX (Increment 430).

The general summary of the amendment is:

To extend the delayed repeal of Ordinance 96 from December 31, 2021 to December 31, **2026**, thereby allowing the continued imposition of the one-eight of one percent (0.1250%)(1/8%) tax on reported gross receipts for the purpose of continuing to finance the costs of county ambulance transport or the operation of a rural health clinic.

Effective Date:

Pursuant to Section 4-37-9, NMSA 1978, the Board of County Commissioners intends to declare that it is necessary to the public health and safety that the amendment of Ordinance 96 take effect immediately after passage by electorate.
