**APPLICATION REQUIREMENTS FOR PERMIT TO INSTALL
MANUFACTURED HOUSING IN LUNA COUNTY**

The transportation, movement and installation of Manufactured Homes to a home site are regulated by the Luna County Planning Department.

To obtain an **installation permit** (MHIP), the following items must be submitted with a completed, signed application attached hereto. **On site utilities are a requirement of this application with no sharing of utilities.** If any of the items are not provided and checked off, please explain. Failure to provide the requested items may result in delay or denial of your application.

- ☐ 1. Proof of ownership on Mfg. Home: ex. Sales contract or Registered Title

- ☐ 2. Proof of property ownership: ex. Warranty Deed or Real Estate Contract

- ☐ 3. Copy of Tax Release obtained from Assessor's Office (Not required for new manufactured homes)

- ☐ 4. Copy of Domestic Water Well Permit: obtained from State Engineers District Office

- ☐ 5. Copy of Liquid Waste System Permit: obtained from New Mexico Environment Office

- ☐ 6. Electric Meter Pole on site: receipt or contract

- ☐ 7. Proof of NM Manufactured Housing Division Blocking Permit: 575-524-6320

If all on site utility requirements are met and there are no violations on the home site. An onsite inspection will be conducted by a Luna County Land Use Official. Upon approval of the application, a \$100 non-refundable administrative fee will be assessed. A \$35 addressing fee is assessed for all housing units installed in Luna County, if there is no address on site.

Manufactured homes are NOT to be moved without a permit from this office.
