# MINUTES SPECIAL MEETING LUNA COUNTY BOARD OF COUNTY COMMISSIONERS Friday, September 7, 2018

**BE IT REMEMBERED** that the Luna County Board of County Commissioners met in Special Session at 1:00 p.m. on Friday, September 7, 2018 in the County Commission Chambers of the Luna County Courthouse, Deming, New Mexico, for the purpose of conducting any and all business to come properly before the Board.

The following staff and elected officials were present: Assistant Manager Glory Juarez, Clerk Andrea Rodriguez, Chief Deputy Clerk Berenda McWright, Deputy Clerk Pilar Salcido, Treasurer Gloria Rodriguez, Chief Deputy Treasurer Dora Madrid, Sheriff Captain Michael Brown, Dispatch Director Lauree Sanchez, Operations Manager Yovanie Granillo, Community Projects Director Jessica Etcheverry, Code Enforcement Officer Manny Armendariz, Executive Secretary Estella Ortiz, Administrative Assistant Rachel Bishop, Emergency Services Director Mark Jasso and Administrative Assistant Patricia Rodriguez.

**CALL TO ORDER:** Chair Smrkovsky called the meeting to order at 1:09 p.m. and led the Pledge of Allegiance and the salute to the flag of the State of New Mexico.

**ROLL CALL:** Deputy Clerk Pilar Salcido called roll. The following members of the Board constituting a quorum were present:

Barbara L. Reedy, District 1 Linda M. Smrkovsky, Chair, District 2 John S. Sweetser, District 3

**PUBLIC COMMENT:** Chair Smrkovsky opened the floor for Public Comment. There was no public comment forthcoming.

#### **NEW BUSINESS:**

Work Schedule Clarification: Chair Smrkovsky stated the reason this item is on the agenda is because it has come to the Board's attention that the Detention Center, Dispatch and the Sheriff's Department did not conform with the decision the Board made in July to go back to the five day work schedule. Chair Smrkovsky stated there is a problem with that, due to the Holiday Schedule that was adopted after the change was made as well as other employees' complaints. A written letter was submitted by Sheriff's Executive Assistant Estella Ortiz requesting the Luna County Board of County Commissioners allow the other Elected Officials or Department Heads to continue managing their own departments, which includes work schedules. Ms. Ortiz came before the Board and explained that her office staff consists of three people that work four ten hour shifts, except on the weeks there is a holiday. On the weeks there is a holiday, they each work 32 hours and still accommodate the public with having the office open 8am to 5pm without accruing or using comp time nor PTO the remainder of that week. Assistant Manager Glory Juarez stated that it causes some

difficulties with payroll, however, the main issue is complaints from other employees who would also prefer to work four tens. Commissioner Reedy stated when this issue began, the Elected Officials and Department Heads were given an opportunity to come up with a plan to maintain a four day work week while still having the Courthouse open five days a week. Ms. Ortiz stated that the Personnel Policy allows for department to set the hours for their employees. Commissioner Sweetser stated that the schedule really needed to apply to all of the departments across the board according to their action that any department that was on four tens prior, would stay at four tens, but any department that was not previously on four tens would go back to five eights. Dispatch Director Lauree Sanchez informed the Board that they had already complied. Ms. Juarez reported that the Detention Director was under the understanding they could continue the shift work but his department would be willing to go back. Sheriff Captain Michael Brown pointed out that the Personnel Ordinance under subsection 9.1 of Ordinance 23 under hours of work: states "employees will work their scheduled hours pursuant to work schedules established by the department". The Board of Commissioners stated they were not aware of that and agreed the personnel ordinance should be reviewed. Ms. Juarez stated that it was discussed at the beginning of the process because she recalled having conversations with Manager Ira Pearson that it didn't even need to go to the commission to switch to four ten's but it was his executive decision to bring it before the commission. Chair Smrkovsky stated that she knows there was a case in which the issue was challenged in another county and the courts supported the decision of the commission. Ms. Juarez stated that she believes the Board of County Commissioners have the authority to set the hours of operation. Chair Smrkovsky made a motion to clarify the decision made by the Luna County Commissions at the July meeting that every department that had gone to the four tens a year ago in June would go back to five eights if they worked five eights prior to that. The motion was seconded by Commissioner Sweetser and carried unanimously following a roll call vote.

Opposition of the Straight Party Voting Option: Chair Smrkovsky explained that the Secretary of State has determined to go back to straight party ticket voting in order to make voting go faster and recommended approval of a resolution opposing that decision. The issue is currently before the Supreme Court to determine if she has that authority. Legislation was passed back in 2001 removing the straight ticket voting in New Mexico. Commissioner Reedy stated there are seven other counties that have voiced their opposition and it was her opinion that Luna County is a county that votes for the person and not the party. Commissioner Sweetser read the following statement for the record: "Straight party voting benefits the majority party and creates an insurmountable obstacle to independent or third party candidates at election time. Unfortunately many voters are more concerned with the top of the ballot options and disregard down ballot races. This hurts our local races immeasurably as the races are usually based on the people running and not the party affiliation." He also stated there are only seven or eight states that still offer straight party voting. Chair Smrkovsky suggested the Board of County Commissioners send an Amicus Curiae (Amicus Brief) pertaining to the lawsuit that is before the Supreme Court as a Friend of the Court opposing the "Straight Party Ticket" per Resolution #18-39. Commissioner Reedy motioned to approve Resolution #18-39 as presented and direct the County Attorney to petition for status of Amicus Curie and file a brief consistent with this resolution with the New Mexico Supreme Court on the issue of Straight Party ticket voting. The motion was seconded by Commissioner Sweetser and carried unanimously following a roll call vote.

**EXECUTIVE SESSION: Executive Session to discuss Limited Personnel Matters pursuant to §10-15-1 (H)(2) NMSA 1978 pertaining to the County Manager's contract:** Chair Smrkovsky requested a motion to go into Executive Session to discuss Limited Personnel Matters pursuant to §10-15-1 (H)(2) NMSA 1978 pertaining to the County Manager's contract. Commissioner Sweetser so moved, Commissioner Reedy seconded and the motion carried unanimously following a roll call vote. The Board went into Executive Session at 1:50 p.m. and returned at 4:09 p.m.

Commissioner Reedy motioned to return from Executive Session where no other matters were discussed other than limited personnel matters. The motion was seconded by Commissioner Sweetser and carried unanimously upon a roll call vote.

No action was taken.

**ADJOURN:** Upon a motion by Commissioner Sweetser and a second by Commissioner Reedy the meeting was adjourned the meeting at 4:10 p.m.

#### **PRESENTATIONS:**

**Commissions' Report on Ruff Ruff Sanctuary Complaint:** Charles C Kretek, County Attorney submitted a written report and attached timeline of activity in response to a formal complaint by Alan Edmonds regarding Ruff Animal Sanctuary.

**PUBLIC INPUT:** Sandy Hastings, Director of Humane Society Robert Floyd, Michelle Whitehurst, John Whitehurst, Pat Danser with Deming Animal Guardians, Matt Robinson, Seth Delanoy, Jamie Holingsworth, Julia Granado, Sharon Miller, Board Member and Director of Deming Animal Guardians Mike Reitz, Alberta Morgan and Jackie Nobel came before the Board and provided public input regarding the ordinance for animal control and the situation with the Ruff Ruff Animal Sanctuary. The following recommendations were brought forth by the concerned citizens who spoke.

- Spay and neuter very important
- o The need to have more places to put animals is urgent
- o Put restrictions on amount of animals for first year facilities
- o Define the amount of animals per caregiver
- County should be responsible to oversee sanctuaries
- o Background check should be required for anyone starting animal sanctuaries
- o Spay and neuter before taking animal from Humane Society should be required
- Luna County needs someone in charge of animal control
- o There is a problem in Luna County with dogs being overbreeding
- o Many complaints were made regarding animal abuse at the Ruff Ruff sanctuary

- o Bring together Commission, Sheriffs and local veterinary as part of the Ordinance structure
- o Transparency and accountability is key
- o Licensee should be held accountable
- o Inspections should be done by third party i.e. Dr. Wetzel was inspector for Army
- o Breeder should have license fees, large fines applied if license fees not paid
- o Intact dogs should have to pay extra fees to have them intact
- o 501C3 non-profit should be part of the rescue
- o Fines and fees should be applied to pay for inspectors, County wouldn't have to pay
- o Existing ordinances are inadequate and the revision as proposed is also inadequate
- o The County is in need of well-defined ordinances, similar to Santa Fe's or Dona Ana's
- Those in charge of inspections should be held accountable, if not the licensee then the Humane Society for issuing a license after knowing the background of licensee

**CALL TO ORDER:** Chair Smrkovsky called the meeting to order at 10:08 a.m., and led the Pledge of Allegiance and the salute to the flag of New Mexico.

**ROLL CALL:** Deputy Clerk Pilar Salcido called roll. The following members of the Board constituting a quorum were present:

Barbara L. Reedy, District 1 Linda M. Smrkovsky, Chair, District 2 John S. Sweetser, District 3

**APPROVAL OF AGENDA:** Chair Smrkovsky requested Items H and I from the Consent Agenda be removed and considered under New Business Items E and F. Also, Item number 16 Jail Inspection to be remove from the agenda this month. Commissioner Reedy moved to approve the Agenda, with Items 12H and 12I moved to new business and Item 16 jail inspection removed. Commissioner Sweetser seconded the motion which was unanimously approved.

#### PRESENTATION:

**Flood Control Implementation Strategy Plan by NM Border Authority**: Mario Juarez of Wilson and Company gave an extensive slide show presentation regarding the Flood Control Implementation Strategy Plan by New Mexico Border Authority. Mr. Juarez stated that the Border Authority requested to be added to this agenda because of the storm back on July 15<sup>th</sup> and 16<sup>th</sup> that exceeded the hundred year storm event and flooded Columbus. Eric Kiltz Recovery Officer with the New Mexico Department of Homeland Security in Emergency Management was also present and reported on response and recovery mitigation efforts.

**MINUTES:** Upon a motion made by Commissioner Sweetser and a second by Commissioner Reedy the Minutes of the August 9, 2018 Work Session were unanimously approved. Upon a motion made by Commissioner Reedy and a second by Commissioner Sweetser the Minutes of the August 9, 2018 Regular Meeting were unanimously approved. Upon motion made by Commissioner Sweetser and seconded by Commissioner Reedy the Minutes of the August 20, 2018 Special Meeting were unanimously approved.

**ELECTED OFFICIALS REPORTS:** Sheriff Captain Brown reported that assaults are up slightly, burglaries are down considerably, vehicle thefts are up as well, non-criminal are up considerably. Deputy Richard Huerta

started resource officer duties last week and the Sheriff's Department will be posting for a vacant core security position.

Treasurer Gloria Rodriguez reported that we have new Tax rates and they are currently working with the Assessor to start the process with the 2018 tax bills.

Chair Smrkovsky reported on the priorities for the New Mexico County Legislative session. The NMC is working on restoring the original appropriation of \$5 million to the County Detentions Facilities Reimbursement Act. This fund helps counties pay for State prisoners whom are in our jails and creates a line item in the DFA budget for \$700,000 to reimburse for Sherriff Officers who transport State prisoners. The State Statue is in place which authorizes the State to make such payments but hasn't been funded in over 20 years. Chair Smrkovsky encouraged the County Treasurer's, Assessor's, Clerk's employees attend classes dealing with economic development.

#### **COUNTY MANAGER'S REPORT:** Assistant County Manager Glory Juarez reported on the following items:

- Dispatch received 10,138 calls for the month of August.
- Currently working on the Radio Communications Project with the Road Department
- Today is Jessica Etcheverry's last day with Luna County
- Community Projects held for the CDBG Planning Grant Application
- Clean ups have begun for the new fiscal year
- Capital Outlay agreements were received and executed for the Domestic Violence Shelter received \$225,000.
- Capital Outlay Resolution and Agreement for Road Improvement through NMDOT \$100,000
- Colonia's Infrastructure Grant for Rockhound Road has been closed
- Detention Center: Number of Inmates Incarcerated: LCDC Daily average population for August: 340 Inmates. U.S. Marshals Service 149 Inmates. Sierra County 43 Inmates. Fire Marshal inspections and recommendations being addressed. Received approval for certificate.
- Several applications for truck drivers have been received hoping to fill positions soon. Department is currently working on Camino Doce and Lucca to Hermanas/Franklin coordination meeting with NMDOT.
- Budget and Procurement Department: Starmax has received a total of \$371,367 on the reimbursements for the conversion project. Starmax is down to a debt of only \$6,385 on that digital conversion project.
- Starmax sales in August were \$83,837
- Ribbon cutting on CDBG project –playground done this week we had several County Officials present at ribbon cutting.
- Community Health Fair tomorrow from 9am-1pm at the Courthouse with the walk starting at 8am beginning at the Visitors Center. Everyone invited to join.
- Resolution 18-05 Amended Notice of Right to Inspect Public Records "Item E on Consent Agenda" is to appoint Yossie Nieblas as the Custodian of Public Records.
- Resolution 18-41 Participation in Capital Outlay Program and Approval of Agreement "Item F on the Consent Agenda" is for the road capital outlay funding.
- Resolution 18-42 Authorizing the submission of a New Mexico Community Development Block Grant "item 12G of the Consent Agenda" is a planning grant for the Comprehensive Plan.

**CALL TO REPEAL ORDINANCE:** Chair Smrkovsky recommended approval of the call to repeal the three ordinances regarding animal control. Commissioner Reedy motioned to direct the County Manager's Office to publish the title and summary of Ordinance Number 1; An Ordinance to Regulate, Restrain, Control and require vaccination of dogs; Repeal Ordinance Number 33; Luna County Animal Control; and Repeal Ordinance Number 52; Animal Regulation and Control one time in the Deming Headlight at least two weeks prior to the meeting for the Board at which the Ordinance is proposed for final repeal. The publication shall also include the date

and time at which the repeal of the Ordinances is to be considered. Commissioner Sweetser seconded the motion which carried unanimously following a roll call vote.

**CALL TO ADOPT AN ORDINANCE:** Commissioner Sweetser motioned to direct the County Manager's Office to publish the title and summary of Ordinance Number 98; providing for Animal Regulation and Control for Luna County, New Mexico one time in Deming Headlight at least two weeks prior to the meeting of the Board at which the ordinance is proposed for final passage. The publication shall also include the date and time at which the ordinance is to be considered. Commissioner Reedy seconded the motion which carried unanimously following a roll call vote.

**INDIGENT CLAIMS REPORT:** Upon motion by Commissioner Reedy and a second by Commissioner Sweetser, the meeting of the Board of County Commissioners was unanimously recessed and the meeting of the Indigent Hospital Claims Board convened. Budget and Procurement Director Joanne Hethcox reported that four claims were processed for the month of August at which none of these claims were for the detention center. The gross receipts collections totaled \$70,105.79 and the balance for Indigent Claims Fund totaled \$844,195.81 of that \$254,155.73 is encumbered. Has not been received Safety net care pool billing, but expect it to be about \$400,000 this year. Commissioner Sweetser motioned to approve the Indigent Claims Report as submitted. Commissioner Reedy seconded the motion which carried unanimously. Commissioner Sweetser motioned to recess as a Claims Board and reconvene as a County Commission. Commissioner Reedy seconded the motion which carried unanimously.

**PUBLIC COMMENT:** Chair Smrkovsky opened the floor for Public Comment. No public comment was forthcoming.

**CONSENT AGENDA:** Chair Smrkovsky noted that Item H, Supporting 2019 NMC Legislative Priorities, and item I, Certificate of 2018 Property Tax Rates was moved to new business. Upon a motion by Commissioner Reedy, and a second by Commissioner Sweetser the following items of the Consent Agenda were unanimously approved following a roll call vote.

**NEW BUSINESS:** Chair Smrkovsky reviewed each item on the New Business agenda with the Commissioners:

- a. **Resolution 18-40 Water Trust Board Funding Application:** Chair Smrkovsky stated that the County did a letter of intent for this grant which is 1.5 million with the County match being \$225,000. Commissioner Reedy motioned to approve Resolution 18-40 Water Trust Board Funding Application. The motion was seconded by Commissioner Sweetser and carried unanimously following a roll call vote.
- b. Authorize the Luna County Detention Center Director, Chris Brice, as Project Manager for the LCDC Expansion and Renovation: Chair Smrkovsky recommended approval of authorizing Chris Brice as Project Manager on the expansion and renovation of the final phase of the detention center project. Commissioner Reedy motioned to approve Chris Brice being named Project Manager of the LCDC Expansion and Renovation project. The motion was seconded by Commissioner Sweetser and carried unanimously.

- c. Luna County Detention Center Collective Bargaining Agreement and Payment Plan: Assistant County Manager Glory Juarez explained that Mr. Pearson and Mr. Kretek along with the Union Representative Andy Gilmore and Mr. Brice have met several times to negotiate and create a payment plan which will eliminate inconsistencies and discrepancies with pay, work load, responsibilities and accountabilities. Detention Director Chris Brice stated that there has been an issue with upward mobility of detention officers. The plan helps by adding defined goals for promotions and provides for an average for overall raise is 2.16% this year. The plan will be reviewed annually. Commissioner Sweetser motioned to approve Luna County Detention Center Collective Bargaining Agreement and Payment Plan. The motion was seconded by Commissioner Reedy and carried unanimously following a roll call vote.
- d. Oath of Office and Appointment of Sheriff Deputy-Kris Seats and Ricardo S. Huerta. Ms. Juarez on behalf of Sheriff Gannaway requested to table this item. Commissioner Reedy motioned to table the Oath of Office and Appointment of Sheriff Deputy Kris Seats and Ricardo S. Huerta. The motion was seconded by Commissioner Sweetser and carried unanimously.
- e. Supporting 2019 NMC Legislative Priorities: Chair Smrkovsky stated that approving the NMC Legislative priorities shows support. Commissioner Reedy motioned to approve supporting 2019 NMC Legislative Priorities. The motion was seconded by Commissioner Sweetser and carried unanimously following a roll call vote.
- f. **Certificate of 2018 Property Tax Rates:** Assessor Rojo reported that the new tax rates have been received for 2018.
