MINUTES REGULAR MEETING LUNA COUNTY BOARD OF COUNTY COMMISSIONERS Thursday, August 12, 2021

BE IT REMEMBERED that the Luna County Board of County Commissioners met in regular session at 10:00 a.m. on Thursday, August 12, 2021 in the Chambers of the Luna County Courthouse, Deming, New Mexico, for the purpose of conducting any and all business to come properly before the Board. Due to the Covid-19 Pandemic and the Governor's Orders regarding social distancing, the commission meeting was also conducted via teleconference and webcasting.

The following staff and elected officials were present: County Manager Chris Brice, Assistant to the County Manager Yossie Nieblas, Deputy Clerk Rachel Bishop, Clerk Berenda McWright, Assessor Michelle Holguin, Chief Deputy Assessor Isabelle Encisco, Treasurer Kristie Hobbs, Sheriff Kelly Gannaway, Road Department Director David Bailey, IT Technician Joseph Apodaca, LCDC Director Lee Cook, Economic Development, Community Director Christie Ann Harvey, Budget & Procurement Director Joanne Hethcox, Assistant Admin Sarah Estrada, Planning Director Premal Patel, Deputy Director Pablo Montoya, Community Development Liason Mary Mackey, Parents as Teachers Program Manager Anna Barraza, and County Attorney Charles Kretek. Other directors and elected officials were present virtually.

CALL TO ORDER: Chair Reedy called the meeting to order at 10:00 a.m. and led the Pledge of Allegiance and the salute to the flag of New Mexico.

ROLL CALL: Deputy Clerk Rachel Bishop called roll. The following members of the Board constituting a quorum were present:

Barbara L. Reedy, Chair, District 1 Linda M. Smrkovsky, District 2 John S. Sweetser, District 3

MINUTES: Upon a motion made by Commissioner Smrkovsky and a second by Commissioner Sweetser the Minutes for the Regular Meeting of July 8, 2021, Work Session of July 23, 2021, and the Special Meeting of July 23, 2021 were unanimously approved following a roll call vote.

SERVICE AWARDS: Parents as Teachers Director Anna Barraza presented a 5-year service award to Olga Neave. Sheriff Kelly Gannaway presented Luis Lobato a 10-year service award. Road Department Director David Bailey presented Ricardo de la Torre a 20-year service award.

PRESENTATION:

• Fishing Day 2021: County Manager Chris Brice presented a video to be viewed and talked about the community fishing day. He reported there were 100 fishing poles given to children attending the event. Another big fishing event is planned for Summer 2022.

ELECTED OFFICIALS REPORTS: Assessor Michelle Holguin reported that they have received an evaluation back from the Property Tax Division with recommendations and questions to be answered. They should be receiving the final response soon. Sales Ratio studies that were provided by the state have been mailed out. It is a year to year reflection of the market if state guidelines are being followed and sales are being valued correctly and accurately. Luna County is meeting all requirements set by the state at this time. The following appraisal staff completed and passed the required continued education hours towards certification to Property Tax Division, Ashley Gallegos, Appraiser III, Mary Perez, Appraiser II, Petra Stevenson, Appraiser I, Jacqueline Tarazon, Appraiser I, and three Certified Appraisers, Alma Arias. Isabel Enciso and Michelle Holguin also completed their continuing education to maintain their certification as Certified Appraisers. The appraisal staff are busy working on the protests and then they will begin working out in the field. The County Service Specialist staff are busy processing deeds for the month of July. They have also been busy processing changes of addresses, affidavits, tax levies, personal property, livestock, and helping customers in the office, online, and on the phone. The GIS/Floodplain /911 rural addressing department have updated the maps for 2021. They are busy processing UPCs, deeds, flood plain inquires, and parcel data inquires, new addresses, address designation letters, and are continuing to work on the City limits subdivision on the GIS maps. Online services are available and staff is available to help anyone walk through the online services or help with any questions they have. Assessor Holguin encouraged all to visit their office if anyone has questions.

Clerk Berenda McWright reported on the number of voter registrations processed for the month of June. There were 11 in person, 2 via mail, 111 removable, and 124 online registrations processed. Luna County currently has a total of 12,580 active registered voters, 5,235 Democrats, 4,217 Republicans, 109 Libertarians, and 3,019 Declined to State and other. A total of 466 documents were recorded in the Clerk's office. Seven new business registrations were issued in July. There is a total of 230 businesses currently registered in Luna County. In July, a total of 12 marriage licenses were issued, and 16 probates were opened and 1 was closed. The Lodger's tax collected for the month of June was \$131.75 with a year- to-date total of \$1,706.00. They attended and processed minutes for three commission meetings (one regular meeting, one special meeting, and one work session). Through ERIC notification, approximately 1000 notices were sent out. Of those notices 535 were cross state matches and 448 were in-state updates. As a result of the notices, a total of 89 cancelation notices were returned and processed. August 24th is candidate filing day for the upcoming Local Election to be held on November 2nd 2021. Commissioner Sweetser asked what cross-state matches were. Ms. McWright stated that they are notices we receive from ERIC if the person has moved out of state. We receive notice and are able to contact them to cancel registration here.

Treasurer Kristie Hobbs reported that this month is one of their slower months and they use it to play catch-up on filing and letters. For the month of July, they took 1,285 tax payments, 24 tax releases, 273 credit card payments. To date, they have collected \$14,251,223 for 2020 taxes.

Sheriff Kelly Gannaway reported on the criminal side for the month of July. No homicides, no rapes, 10 assaults, 4 burglaries, 7 larcenies, and 4 vehicle thefts. The overall criminal totals are up a little bit. The non-criminal paper service is up, accidents are down and DWI's are down. The total for non-criminals is up but overall grand totals for the month are down. New vehicles are still in

production. Deputy Paredes and Deputy Soledad are attending the law enforcement academy. One is in Dona Ana. And one is in Santa Fe Academy. Deputy Lopez resigned after being in the academy for two weeks. Sargent Ramirez resigned. HIDA Task Force Agent Delagarza retired after 22 years of law enforcement. They have two deputy positions, one sergeant position and one task force position to fill. Sherriff Gannaway stated the National Night Out on August 3rd was a great success and they had a big turnout. A total of 800 hamburgers and hotdogs were served. He thanked Senator Crystal Diamond for securing funds for the purchase of body armor for Sheriff's office, detention center for our county and some others as well.

Commissioner Smrkovsky reported that our capital outlay and the message coming from the state at this time is that shovel ready bigger projects are the ones they are looking at funding at this time. She virtually attended the NM Counties board meeting on August 5th and 6th over zoom. They reviewed lots of things including the upcoming annual conference which is in Lea County September 21st -23rd. Ms. Smrkovsky encouraged Luna County employees to attend if they are able. Ms. Smrkovsky reported that the Economic Development Infrastructure Policy Committee met on August 11th and Do it for Broadband gave a presentation. She stated there is lots of federal funding available to get broadband in the county.

COUNTY MANAGER'S REPORT: County Manager Chris Brice reported:

- National Night Out was a huge success. They served 800 hamburgers and 800 hotdogs. He thanked Main Street and everyone else who participated.
- They are working on several grants. TPF grant for the drainage in the Columbus Industrial Park is vital, and it is shovel ready. They are working with the village of Columbus on a water tower.
- Mr. Brice, Christy Anne Harvey, and Sarah Estrada went to the Santa Teresa Port of Entry and met with Jerry Pacheco and Tony Hall to talk about what has been done at the port in Santa Teresa and what could be done at the port here to try and build it up.
- The electronic time clock system should be finished by October.
- The new Detention Maintenance Building has already been funded and should be built soon. Someone will be coming in to remove the old units. Hopefully this will be a no cost job with the possibility of taking the materials they remove with them as pay.
- They continue to work on Dispatch and the EOC
- Starmax is up and running. They are working on air conditioning issues in the movie theaters that must be completed before they can open.
- Sarah Estrada has been brought on as the Grants Manager/Grant Writer.
- A Green Stream event will be held on August 12th at 1:00. The Secretary for Economic Development will be present to help kick off the event.
- Western has started a Vocational School in Welding and they have quite a few people interested in it. Next they are working on getting a CDL program up and running.

- Premel Patel has worked on tracking down the owner of the abandoned house up near Rockhound State Park. The owners were willing to hand it over to the county. It will be the home of the new trash collection area.
- A meeting was held with the State-wide CID to discuss hiring a building official to serve both the County and the City (possibly on a 2-3 day a week basis).
- We have had a few vehicle break-in's in the parking lot recently. Looking at using the Fina Station to help secure some of the vehicles a little better.
- The Columbus Learning Center is not getting a whole lot of use in its current capacity. It is being looked at as the location for the New Port of Entry Economic Development Building.
- Mr. Brice will be attending the Legislative Finance Committee meeting in Taos in the next few weeks. Let him know of any concerns that need to be taken to them.
- The Legislative Committee for Indian Affairs meets every month rotating between the different tribes in the state. It will be held in Luna County in September hosted by the Fort Hill Apaches. It will be held at the learning center.
- NM Counties Annual Conference is coming up in September. Some Employees will be attending virtually and some will be attending in person.
- County Manager and Pablo Montoya will be attending the Fire Chiefs Conference in Ruidoso in September.
- Lee Cook, formerly of the Deming Police Department has been hired as the Detention Center Director.

INDIGENT CLAIMS REPORT: Upon a motion by Commissioner Sweetser and a second by Commissioner Smrkovsky, the meeting of the Board of County Commissioners was unanimously recessed and the meeting of the Indigent Hospital Claims Board convened.

Budget & Procurement Director Joanne Hethcox reported claims for the month of July of \$2,562.06. In July they collected \$54,564.42 in GRT. The balance for the Indigent Claims Fund total is \$1,789,578.92 as of July 31st. All of last year's PO's were closed out July 31st so there are no encumbrances. As of the first week of August there are almost a million dollars of encumbrances. Chair Reedy asked for a motion to consider the claims dated August 12th. Commissioner Smkrovsky made a motion to consider the claims as presented by Joanne Hethcox for August. The motion was seconded by Commissioner Sweetser and approved unanimously.

Commissioner Smrkovsky motioned to recess as a Claims Board and reconvene as a County Commission. Commissioner Sweetser seconded the motion which carried unanimously.

PUBLIC COMMENT:

- Jack Harmon voiced concerns with the Algae Plant. He stated that the facility is unsecure and full of hazardous waste and is very dangerous. Christy Ann Harvey responded. She stated that Green Stream was purchased by another company. She stated that the State has done due diligence in looking at the company. Some work has already been done to improve it. It is a private company and it is not considered a toxic dump or hazard.
- Linda Harmon asked what Sapphire Energy was and what they produce. Christy Ann Harvey responded. She explained that Sapphire Energy was a bio-diesel producer from algae. Ms.

Harmon responded that this company used hazardous materials in the process. Commissioner Sweetser responded and stated that it was an experimental project and that the fuel made was for jet fuel. Linda Harmon discussed dollar amounts reportedly used for this project. Christy Ann Harvey explained that grants are used by these companies to clean up and restart. It helps get public money to private organizations to help them grow.

- Scott Chandler expressed concerns over the amount of water used at the algae plant. He stated that he was told the algae plant would have unlimited water rights. Mr. Brice stated that he would reach out to the State Engineer's office for clarification.
- Susan Schiffner expressed concerns over the current condition of the algae plant. She wanted to know what the restrictions are on the current owners as far as clean up. Mr. Brice explained that they are working on a county ordinance to address these issues.
- Russ Howell expressed appreciation for the clean-up that will happen on the corner at Rock Hound. She also expressed concern with the sound system in the commission chambers. She also expressed concern with the timeliness of the meeting minutes for previous County Commissioner meetings. County Manager explained that sound panels have been put up to help with the sound issue and they are working with a contractor to address the sound system issues.
- Susan Schiffner expressed concerns with the dumping of onions near her home. She stated that flies are a real concern. She also stated that crates and bags are being dumped along with the onions.
- Carmen McDonald expressed concerns over the algae plant, she is concerned that it is being "sold" as green energy. She shared her experience in California and also read comments from people in England who were concerned about windmills that were brought in to the country.
- Andrew Bell expressed concern over the wind solar and algae plants. He would like to see
 the county set up funds and policies to ensure clean up after they are no longer operational.
 Mr. Brice explained that the county is setting up guidelines for the companies coming in to
 the county to follow.
- Linda Harmon asked for explanation of what the ordinances are. Mr. Patel explained to her that the ordinances set the guidelines for companies coming into the county.
- Chelsea Evans, Interim director for Main Street, reported on the success of the National Night
 out, she also gave an update on upcoming community events. She also discussed upcoming
 projects.
- Alberta Morgan asked people making public comment to speak into the microphone to be heard. She also gave her opinion on the solar wind plant.
- Andrew Bell asked that we focus on existing resources like petroleum, natural gas, and coal.

Break-11:30 am -11:40 am

PUBLIC HEARING:

a. Ordinance 106: An Ordinance Approving a local Economic Development Project for Green Stream Algae LLC d/b/a Green Stream Farms: PUBLIC HEARING: Christy Ann Harvey, Community Director for Economic Development, introduced the ordinance. She stated that the ordinance is for the approval of a LEDA project that involves Green Stream Algae Farms in Columbus NM. It is a \$250,000 grant coming from the State of New Mexico. The County will act as fiscal agent for the grant. She explained that the ordinance must be passed in order for the County to proceed with the project. Commissioner Sweetser asked

for verification of what the Algae Green Stream produced was for and what the economic cost was.

Public Hearing Comments on Ordinance 106:

- Linda Harmon expressed concern over the type of chemicals used and the methods of clean up that was used by the previous company that was in the location of Green Stream. She stated that it was previously used to make bio-chemical jet fuel and will now be used to make a consumable product and expressed great concern over the safety of it and would like to see the paperwork on the clean-up. Mr. Brice responded by stating that Green Stream is under FDA regulations who presumably will regulate the safety of the transition from jet fuel to the algae farm.
- Susan Schiffner expressed concern over the changes already happening to expand and start up the Algae farm. Mr. Brice stated that Green Stream is a private company and the County does not regulate what a private company does. They are allowed to start working on expansions and startups. He reminded her that the ordinance being discussed is just in regards to the \$250,000 grant being awarded by the state.
- Linda Harmon stated that Green Stream is a multi-million-dollar company and she expressed concern over them being awarded \$250,000 by the state. Mr. Brice stated that the company will be creating many new jobs which in turn gives the money back to the state.
- Susan Schiffner asked how many jobs would be coming in to the community through Green Stream. Ms. Harvey stated that the county is in competition with many other states/counties to attract businesses to the area. The grant is one of many ways that our county is attempting to attract businesses to set up here.
- Paul Hoylen asked who owns the land where the Algae Farm is located. Ms. Harvey stated that Green Stream Farms and its parent company own the land. Mr. Hoylen also asked who they bought it from and expressed concern over possible conflict of interest in previous and current owners of the property. Ms. Harvey stated that a company from California owned it before Green Stream.
- Linda Harman asked who took the land over when Sapphire went out of business. She wanted to know if the County took it over. Mr. Brice stated that the County did not take it over, but he is unsure of who did.
- Collette Chandler wanted to clarify that the only thing being considered right now under this ordinance is that Luna County will be the fiscal manager for the LEDA funds.

Commissioner Smrkovsky stated that the project is funded through the state, not the county and that the county would simply be the fiscal manager. She asked for clarification on the wording of the last paragraph of the ordinance. County Attorney Charles Kretek clarified and they agreed that it would be amended. Chair Reedy read the conditions (1-9) of the ordinance out loud. Commissioner Smrkovsky motioned to approve Ordinance 106: An Ordinance Approving a local Economic Development Project for Green Stream Algae LLC d/b/a Green Stream Farms as amended. Commissioner Sweetser seconded the motion which carried unanimously following a roll call vote.

b. Ordinance 107: An Ordinance Addressing Energy Production Facilities: PUBLIC HEARING: Planning Director, Premal Patel stated that the ordinance is being established to have regulation standards incorporated within the ordinance to hold land holders accountable to some degree on what they do with the land. The ordinance will also outline the standards on the decommissioning and reclamation of properties. He mentioned that

anyone who wants a copy of the draft can give their email address to Yossi to get the information sent to them. County Commissioner Linda Smrkovsky asked for clarification on a few points in the ordinance. Mr. Kretek gave explanation for points she questioned.

Public Hearing Comments on Ordinance 107:

- Susan Schiffner asked how close we are to actually having windmills put in the County. Mr. Patel stated that solar panels are being put in at this time, but not windmills.
- Linda Harmon asked if anyone has researched how much fossil fuel it takes to make one windmill. She also asked if anyone has researched how the blades on a windmill are not recyclable after their life cycle is over. She also stated that solar panels are not recyclable and they are full of toxic chemicals. She wanted to know if the County would be responsible for the deflation of property values caused by these things. Mr. Brice responded that this is a nationwide debate and it is a completely separate topic than what is being discussed for this ordinance. Ms. Harmon stated that "we the people" will have to go get a lawsuit in place to stop Windmills and Solar from being put in place.
- Scott Chandler stated that he believes the county manager and the commissioners do
 have the power to keep windmills and solar plants out of Luna County. He stated that
 they could put a moratorium on them. He expressed concern that property values are
 being lowered because of green energy.
- Susan Schiffner stated that land owners are being given incentives to put up windmills and solar panels and that it affects everybody.
- Carmen McDonald read an email that she received from Crystal Gewide, a resident of Roosevelt County regarding her account of the windmills constructed in that area.
- Linda Harmon stated that Luna County has a slogan to "Keep NM Beautiful," she also stated that wind and solar farms are not beautiful and she does not want to look at them. She also brought up a lawsuit in California where a certain species of birds are bursting into flames when they fly over the solar panels.

Break-12:44 pm -3:00 pm

Meeting reconvened from break at 3:00 pm and public hearing of Ordinance 107 continued: Mr. Patel restated that the ordinance is being established to have regulation standards for landowners put in to place.

Continued Public Hearing Comments on Ordinance 107:

- Susan Schiffner stated that she would like to see the ordinance be put on hold and stated that she, Linda Harmon, and Jack Harmon would like to be included in the committee to provide input on the policy being created. Mr. Patel asked for their email addresses to contact them.
- Chair Reedy read a portion of the ordinance to the Public.
- Jack Harmon expressed concern over the Sandhill Cranes (who are an endangered species) that stop in Luna County during their migration.
- Collette Chandler stated that she is all for the ordinance being considered. She proposed that the ordinance include something that implies that public input will be considered when decisions are being made. She also mentioned a few other counties in the state who allow the public to put moratoriums in place when issues are being discussed. She asked if the County Attorney could clarify the parameters of the

ordinance. Mr. Kretek clarified the parameters of the ordinance in response to Ms Chandler's questions.

Commissioner Sweetser motioned to approve Ordinance 107: An Ordinance Addressing Energy Production Facilities. Commissioner Smrkovsky seconded the motion which carried unanimously following a roll call vote.

Luna County Non-CDL employees Drug and Alcohol Policy

SECTION 1.0 PURPOSE AND APPLICABILITY

- 1.1 The County believes that it has an obligation and right to have alert, drug/alcohol free employees on the job, and must provide a safe work environment. This means that during working hours, all employees are expected to be free from any substance, whether legal or illegal, that can negatively affect job performance or risk the health and safety of employees or the public.
- 1.2 The purpose of this testing policy is to establish Luna County's program and the procedures for implementing a pre-employment/ reasonable suspicion/ random drug testing/return to work drug and alcohol testing policy. This policy is also to protect the physical and psychological well-being of all the employees at the County's facilities and job sites and protect the safety of the public. Use of intoxicants and drugs that alter the ability to function on the job in an effective and safe manner will not be tolerated. The use of or condition of being under the influence of drugs/alcohol while at work can affect the morale of other employees as well as increase accidents, theft, and absenteeism.
- 1.3 This testing policy is a critical step in establishing and maintaining an efficient and safe work force and will be applied in conjunction with all established County policies, procedures and programs.
- 1.4 The County will vigorously pursue the enforcement of this policy, and will make efforts to protect the privacy of its employees. It is the intent of this policy to encourage and support employee recovery from substance abuse through the County Employee Assistance Program, (EAP), unless the EAP proves ineffective for that employee.
- 1.5 The Luna County Human Resources Director is the Designated Employer Representative (DER). For questions about drug testing, contact the Human Resources Department.
- 1.6 This policy applies to all non-CDL Luna County employees.

SECTION 2.0 DEFENITIONS

- 2.1 Accident For purposes of Post-Accident drug and alcohol testing, an accident is defined as an incident resulting in property damage or injury requiring medical attention AND where a reasonable basis exists to believe that drugs or alcohol may have caused or contributed to the incident AND there is an individualized reasonable suspicion to believe the employee involved may have been under the influence of drugs or alcohol.
- 2.2 Alcohol The intoxicating agent in beverage alcohol, ethyl alcohol, or other low molecular weight alcohols including methyl and isopropyl alcohol.

- 2.3 Alcohol Concentration The alcohol in a volume of breath expressed in terms of grams of alcohol per 210 liters of breath as indicated by an evidential breath test.
- 2.4 Confirmation drug test A second analytical procedure to identify the presence of a specific drug or metabolite which is independent of the initial test and which uses a different technique and chemical principle from that of the initial test in order to ensure reliability and accuracy. (Gas chromatography/ mass spectrometry (GC/MS) is the only authorized confirmation method for cocaine, marijuana, opiates, amphetamines, and phencyclidine).
- 2.5 Controlled substance Controlled substance means the category of drugs as listed: Cocaine; Opiates; Semi-synthetic Opiates; Oxycodone Opiates; 6-acetylmorphine (6-AM); Phencyclidine (PCP); Amphetamines or Methamphetamines.
- 2.6 Covered employee All employees are subject to reasonable suspicion alcohol and drug testing, post-accident alcohol and drug testing and return to work alcohol and drug testing. Safety-sensitive employees are also subject to random drug testing. Law enforcement employees are also subject to steroid testing.
- 2.7 Covered position (Safety-Sensitive) Safety-sensitive positions for purposes of random drug testing include all law enforcement personnel, all detention center employees and emergency dispatch employees.
- 2.8 Designated Employer Representative (DER) The person(s) designated by Luna County to receive confidential test results.
- 2.9 Dilute Specimen A urine sample with a low Specific Gravity and a low Creatinine level.
- 2.10 Invalid Test A urine sample with which the laboratory has been unable to obtain a valid test result.
- 2.11 Medical Review Officer (MRO) A licensed physician (Medical Doctor or Doctor of Osteopathy) responsible for receiving laboratory results generated by an Employer's drug testing program who has knowledge of substance abuse disorders, possesses a certificate of completion or certification from an approved MRO program and has appropriate medical training to interpret and evaluate an individual's confirmed positive test result together with his or her medical history and any other relevant biomedical information.
- 2.12 Positive Drug Test A drug test that is confirmed by gas chromatography separation and mass spectrometric identification technology at or above the cut-off levels established by the Department of Health and Human Services (DHHS). These cut-off levels may change from time to time depending upon DHHS rules. The County will always test at the currently-required DHHS levels. The County will attempt to notify covered employees if these levels change. Currently, the cut-off levels are (expressed in nanograms per milliliters (ng/mL):

- 2.13 Refusal to Test- Refusal to provide an acceptable alcohol or controlled substance test)
 - 2.13.1 Failing to provide adequate breath for alcohol testing without a valid medical explanation after he or she has received notice of the requirements for breath testing in accordance with the requirements of this policy.
 - 2.13.2 Failing to provide adequate urine for controlled substance testing without a valid medical explanation after he or she has received notice of the requirement for urine testing in accordance with the requirements of this policy.
 - 2.13.3 Failure to cooperate with the process in a manner that obstructs the collection of the specimen.

SECTION 3.0 REQUIRED TESTS

3.1 Pre-employment Drug Test

- 3.1.1 All applicants for employment will be informed that their employment is contingent upon passing a drug test. Successfully passing the test requires a negative result for controlled substances as verified by a Certified Drug Technician.
- 3.1.2 Refusal to test by any finalist for employment will result in the individual not being hired into that position. Luna County will pay the costs associated with pre-employment testing.
- 3.1.3 Luna County will not pay the candidate's time for a pre-employment test.
- 3.1.4 Pre-employment job applicants who test positive for controlled substance will not be hired and may request in writing, within 10 calendar days from the date of testing, a retest of the same specimen at the applicant's expense.
- 3.1.5 In extraordinary circumstances, the County Manager may waive or postpone a preemployment drug test.

3.2 Post-accident Drug and Alcohol Test

- 3.2.1 All Luna County employees involved in an Accident while in the course and scope of performing their job duties are subject to post-accident drug and alcohol testing immediately after grounds to test have been found. Grounds to require a post-accident test will be found in any Accident in which an employee was operating a motorized vehicle and is deemed responsible for causing the Accident. This determination of responsibility must occur within two hours of the accident. Refusal by an employee to test constitutes a positive test result and may result in disciplinary action up to and including termination of employment.
- 3.2.2 It is the responsibility of any covered employee who is subject to post-accident testing to remain readily available for such testing. If the employee is not readily available, he/she may be deemed by Luna County to have refused to submit to testing. This provision shall not be construed to require the delay of necessary medical attention for injured people, to prohibit the employee from leaving the scene of an accident to obtain assistance in responding to the accident, or to obtain necessary emergency medical care.
- 3.2.3 Under no circumstance will the employee be allowed to drive himself or herself to the testing facility. The supervisor shall drive the employee to the testing facility.

3.3 Random Drug Test

- 3.3.1 Luna County conducts random drug testing on employees in Covered Positions.
- 3.3.2 The selection of employees from Covered Positions for random drug testing shall be made by a scientifically valid method, such as a random table or a computer-based random number generator that is matched with employees' identification numbers. The random selection and testing dates shall be unannounced and spread reasonably throughout the year with each employee having an equal chance of being tested each time the random selections are made. Each covered employee randomly selected for testing shall, upon notification, immediately report to the testing sight. Employees who are engaged in travel, working offsite within Luna County or cannot, for safety reasons immediately report for testing, must report as soon as practical thereafter but not later than two (2) hours after receiving notification. Employees not on shift at the time of random selection must report upon their return to work.
- 3.3.3 The number of employees selected will be in excess of the actual number required to enable the testing pool to reach the appropriate annualized rate despite absence due to sick-leave, vacations or other valid absences.
- 3.3.4 The random selection process will be conducted in strict confidence to ensure no employee is forewarned and that testing is unannounced. A limited number of individuals will have knowledge of the random selection to ensure confidentiality and the integrity of the testing process.

3.4 Reasonable Suspicion Drug and Alcohol Test

- 3.4.1 A Covered Employee must submit to reasonable suspicion testing for drug and alcohol if his or her supervisor and a Human Resources designated representative meeting the training requirements have reasonable suspicion to believe that the employee is under the influence of drugs or alcohol. The determination that reasonable suspicion exists to require the employee to undergo an alcohol and/or controlled substance test must be based on specific, contemporaneous, articulable observation concerning the appearance, behavior, speech or body odors of the covered employee.
- 3.4.2 When a reasonable suspicion test is required, it must be conducted immediately. Any delay in testing must be for good cause and the supervisor shall prepare a report indicating the good cause for the delay no later than the completion of the next work day.
- 3.4.3 The referring supervisor and Human Resources designated representative shall complete and sign the Reasonable Suspicion Form, attached hereto as Exhibit A, prior to administering the test.
- 3.4.4 Under no circumstance will the employee be allowed to drive himself or herself to the testing facility. The supervisor shall drive the employee to the testing facility.
- 3.4.5 Refusal by any employee will be treated as a positive drug test and may result in immediate termination of employment.

3.5 Return-to-duty

Before an employee returns to work after engaging in conduct prohibited by this policy, the employee shall undergo a return to duty drug and/or alcohol test, as determined by the prohibited conduct. The return-to-duty test must indicate a verified negative result for drugs according the standards in Section 2.12. The return-to-duty test result for alcohol must indicate an alcohol concentration of less than 0.04 B.A.C.

4.0 Confidentiality

Information and records relating to test results, drug and alcohol dependencies, and legitimate medical explanations provided to the MRO will be kept confidential to the extent required by law and maintained in secure files separate from personnel files.

5.0 Employee Assistance Program

- 5.1 Luna County takes its commitment to provide safe conditions to the public and its employees seriously. Recognizing this commitment, the County maintains an Employee Assistance Program (EAP) that can provide access to professional services in an effort to aid any employee who has an alcohol or chemical dependency problem. Participation in this program is voluntary and all records regarding self-referral or acknowledgement will be kept confidential to the extent required by law.
- 5.2 All employees who suspect they may have alcohol or substance abuse problems are strongly encouraged to utilize employee assistance program resources before the problem affects their employment status. There will be no disciplinary action involved for voluntary self-referral to the EAP. Voluntary self-referral, however, shall not relieve the employee from responsibility for adequate job performance. Self-referral after notification of a required drug or alcohol test will not eliminate the requirement to take such a test and will not preclude the taking of a disciplinary action against an individual who fails a required drug or alcohol test.
- 5.3 Any costs for counseling or rehabilitation above and beyond Luna County's EAP allocation shall be the responsibility of the employee.

6.0 Consequences of Violating this Policy

- 6.1 Applicants who refuse to cooperate in a drug test or who test positive will not be hired and will be ineligible for rehire pursuant to the Luna County Personnel Ordinance No. 23.
- 6.2 Employees who refuse to cooperate in or submit to mandated testing, who test positive for a controlled substance or who use, possess, buy, sell, manufacture or dispense a controlled substance while on duty or who otherwise violate this policy will be subject to disciplinary action up to and including termination.
- 6.3 The County Manager, in his/her sole discretion, may offer any employee subject to discipline under this policy the opportunity to return to work on a last-chance basis pursuant to terms and conditions dictated by the County Manager, which shall include return to duty testing at times and frequencies determined by the County Manager for a minimum period of one year but not more than two years as well as a waiver of the right to contest any termination resulting from a subsequent positive test. If the employee either does not complete the rehabilitation program or tests positive after completing the rehabilitation program, the employee will be immediately discharged from employment.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners directs the Luna County Manager, or his designees, and grants the authority necessary to effectuate the transfer of the Deming Readiness Center, including but not limited to signing of deed and documents and cooperating with the process of obtaining the necessary regulatory approval.

BE IT FURTHER RESOLVED that, as conditions of acquisition, Luna County will assume responsibility for and see to its completion the application for the registry of the adobe wall and outbuilding on the State/National Registry of Historic Places and will honor any outstanding leases or facility use commitments.

BE IT FURTHER RESOLVED that the citizens of Luna County are deeply appreciative of the New Mexico Army National Guard's willingness to allow Luna County to acquire the Deming Readiness Center and of the efforts of State Senator Crystal Diamond to facilitate the County's acquisition.

The financial assistance requested is in the amount of \$2,500,000.00. Luna County hereby pledges the required 10% local match in the amount of \$250,000.00 in support of the application, for which funds are currently available in the General Fund.

- That all action (not consistent with the provision hereof) heretofore taken by the Governing body and the officers and employees thereof directed toward the Application and the Project, and the same is hereby ratified, approved and confirmed.
- 2. That the Application authorized by the Governing Body, be and the same is hereby approved and confirmed.
- 3. That the officers and employees of the governing Body are hereby directed and requested to submit the completed Application to the Board for its review, and are further authorized to take such other action as may be requested by the Board in its consideration and review of the Application and to further proceed with arrangements for financing the Project.
- 4. All acts and resolutions in conflict with this resolution are hereby rescinded, annulled, and repealed.

Be it remembered that at the Regular Meeting of the Luna County Board of County Commissioners in Deming New Mexico, on the 9th day of September, 2021, the following proceedings were had and entered of record.

PROCLAMATION 21-08

IN SUPPORT OF NEW MEXICO'S OIL AND GAS INDUSTRY

- **WHEREAS**, New Mexico is a major producer of oil and natural gas since hydrocarbons were first discovered in the early 1920s;
- WHEREAS, data from the State's Oil Conservation Division reported that New Mexico produced about 367.8 million barrels of oil and 1.9 trillion cubic feet of natural gas in 2020;
- WHEREAS, New Mexico's oil and natural gas industry provides a significant contribution of direct economic activity through purchases, employment and payments to state and local governments;
- WHEREAS, activities related to the oil and natural gas industry, including payments to other industries, households and state and local governments supported more than 125,000 jobs statewide, which represents from that 10% of total employment within New Mexico;
- **WHEREAS,** the New Mexico oil and natural gas industry resulted in almost \$15,000,000,000 in total economic output, with more than \$7,000,000,000 in labor income and nearly \$3,000,000,000 in state and local tax payments or 25% of statewide tax revenues;
- WHEREAS, the largest single category of New Mexico's General Fund recurring expenses is for public education;
- **WHEREAS,** the total General Fund spending reached \$7,660,000,000 in FY20, of which 33.5% or \$2,570,000,000 was funded by New Mexico's oil and natural gas industry;
- **WHEREAS,** New Mexico's FY20 Operating Budget provided \$3,170,000,000 to school districts and charter schools, with 33.5% or \$1,060,000,000 being attributable to the oil and natural gas industry;
- **WHEREAS,** New Mexico's oil and natural gas industry also provided \$290,000,000 or 33.5% of the \$867,000,000 in General Fund expenditures on higher education;
- **WHEREAS,** in total, New Mexico's oil and natural gas industry provided \$1,370,000,000 for New Mexico schools and public education in FY20;

WHEREAS, State and Federal legislation, Non-Governmental Organization activists and other entities continue to deride, impede and inhibit oil and natural gas development within the State of New Mexico, particularly in southeastern New Mexico;

WHEREAS, President Biden's Executive Order of Tackling the Climate Crisis at Home and Abroad indefinitely suspended the federal oil and natural gas leasing program on federal lands; and

WHEREAS, no other state stands to be more adversely impacted by President Biden's moratorium on the federal oil and natural gas leasing program than New Mexico.

NOW, THEREFORE, BE IT PROCLAIMED, that the Board of County Commissioners of Luna County, recognizes that New Mexico's oil and natural gas industry provides over one-third of the revenue for the State of New Mexico and expresses its enduring support for the New Mexico oil and natural gas industry and calls upon Governor Lujan Grisham and our federal legislative delegation to urge the end of the moratorium on the federal oil and natural gas leasing program.
