DISCUSSION ITEM: American Rescue Plan Act Funding: (*Note: Items were presented for discussion only and no actions were taken.) County Manager Chris Brice explained that the County received a total of about \$4.6 million for the American Rescue Plan. The first part came July 2021 in the amount of \$2.3 million. The county will receive another \$2.3 million no sooner than June 30, 2022. After receiving this money, initially there was a very broad range of things this money could be spent on with very few rules. As time went on there have been more rules applied on how this money can be spent, and the rules are constantly changing. This meeting was to discuss and get some ideas of how this money should be spent.

MINUTES REGULAR MEETING LUNA COUNTY BOARD OF COUNTY COMMISSIONERS Thursday, January 13, 2022

BE IT REMEMBERED that the Luna County Board of County Commissioners met in regular session at 10:00 a.m. on Thursday, January 13, 2022 in the Chambers of the Luna County Courthouse, Deming, New Mexico, for the purpose of conducting any and all business to come properly before the Board. Due to the Covid-19 Pandemic and the Governor's Orders regarding social distancing, the commission meeting was also conducted via teleconference and webcasting.

The following staff and elected officials were present: County Manager Chris Brice, Assistant to the County Manager Yossie Nieblas, Administrative Assistant Lupita Hernandez, IT Technician Nathan Ortberg, Clerk Berenda McWright, Chief Deputy Clerk Leslie Nabours, Deputy Clerk Pilar Salcido, Assessor Michelle Holguin, Treasurer Kristie Hobbs, Sherriff Kelley Gannaway, Captain Michael Brown, Detention Deputy Director Pablo Montoya, Road Department Director David Bailey, Economic Development & Community Director Christie Ann Harvey, Community Development Liaison Mary Mackey, County Attorney Charles Kretec, LCDC Director Lee Cook, Community Development Director Premal Patel, and Budget & Procurement Director Joanne Hethcox. Other directors and elected officials were present virtually.

CALL TO ORDER: Chair Reedy called the meeting to order at 10:00 a.m., and led the Pledge of Allegiance and the salute to the flag of New Mexico.

ROLL CALL: Deputy Clerk Pilar Salcido called roll. The following members of the Board constituting a quorum were present:

Barbara L. Reedy, District 1 Linda M. Smrkovsky, District 2 John S. Sweetser, Chair District 3

ELECT 2022 CHAIRPERSON: Commissioner Sweetser moved to nominate Commissioner Smrkovsky as the 2022 Chairperson. Chair Reedy seconded the motion which was unanimously approved.

APPROVAL OF AGENDA: Chair Smrkovsky entertained a motion to approve the agenda. Commissioner Sweetser moved to approve the agenda as submitted. Commissioner Reedy seconded the motion which carried unanimously following a roll call vote.

MINUTES: Upon a motion made by Commissioner Reedy and a second by Commissioner Sweetser the Minutes for the Regular Meeting of December 9, 2021, were unanimously approved.

SERVICE AWARDS: Janet Pacheco was not present to receive her five years of service award. James McBurney was not present to receive his five years of service award. LCDC Director Lee Cook presented Dolores Gonzales with her five years of service award. LCDC Director presented to Mary Helen Allison a plaque in recognition of her retirement.

SPECIAL RECOGNITION AWARD: Betty Quiroz-LCDC Director Lee Cook recognized Ms. Quiroz for her constant commitment to LCDC.

PRESENTATION:

- Quarterly Restrictive Housing Unit Report: Mr. Cook reported the Quarterly Restrictive Housing Unit Report by following HB 364. From October 1, 2021, thru December 31, 2021, the Luna County Detention Center had twelve detainees who met the reporting requirements. Detainees had access to showers, television, medical attention, mental health attention and were seen by detention staff hourly.
- 9/11 Flag of Honor Presentation: Teresa Aguilera stated the Teen Court Program is presenting the 9/11 Flag of Honor to the County. The frame was designed, built, and assembled by Carlos Apodaca's Woodshop class at Deming High School. The 9/11 Flag of Honor will be placed on the wall by the DWI office.
- Market Volatility (Bond Refinancing): Mark Valenzuela presented possible options for refinancing bonds. With the interest rate market now there might be an opportunity to refinance the bonds and potentially save the county some money.

ELECTED OFFICIALS REPORTS: Assessor Michelle reported the office has mailed out their first mailing of the year all livestock and personal property have been sent out on December 31st. They are busy starting their rendering period for this year which includes manufactured homes and exemptions (family exemptions, veteran's exemptions, limitation freezes, other exemptions, and disabled veterans). Any personal property, livestock, and manufactured homes that are not rendered by the end of February will incur a 5% penalty. The exemptions and limitations can be rendered by the end of April. The Assessor's office has processed 3,459 documents for 2021. The appraisal staff is busy calculating for the end of the year and conducting last-minute reviews before they send out the Notice of Values at the end of March. Renee Rivera has just transferred from County Service Specialist to an Appraisal Associate. Ms. Rivera has passed her first IAAO course towards her goal of attaining her IAAO certification. Mary Perez has passed her third IAAO course, she only needs one more class to get her certification. The County Service Specialists are processing livestock and personal property statements received. They are also processing exemptions, limitations, manufactured home stickers, all the online forms and inquiries. They are also processing the last of the deeds for the year, change of addresses, affidavits, tax levies, and helping customers in the office and online. The GIS/Floodplain/911 Rural Addressing department is continually updating the maps, processing UPC's, processing year-end deeds, reviewing and signing off on flood plain inquiries for the County and the City. They continue to also process data inquiries, issuing of new addresses for the County, process address designation letters, continue to work on city limits subdivisions on the GIS map, scan subdivision plats in the system, and check surveys and descriptions for Claim of Exemptions. Ms. Holguin stated that online services continue to be temporarily down which has increased phone inquiries, and the public coming into the office. She asked that the public please be patient while this gets fixed.

County Clerk Berenda McWright reported they processed 35 in person voter registrations, 14 through the mail, and 223 online and removed 14. There is a total of 12,663 active voters, 5,202 are

Democrats, 4,230 are Republicans, 109 are Libertarians, and 3,122 declines to state. They have recorded 490 documents and have 3 new businesses registered and have a total of 235 registered businesses in Luna County. There were ten marriage licenses issued and eight filed. There were 11 probates opened, eight closed and eight updated. The Lodgers Tax collected was \$377.29 and the year to date total is \$3,270.34. There was one commission meeting recorded and minutes prepared. A total of 25 records requests were processed via e-mail. Many calls were received due to the records not being available online. They are ready to go to the Legislative Conference and take some classes.

Treasurer Kristie Hobbs reported her office is done with tax season. Itwas a very eventful tax season they usually gets two part-time employees to help but unfortunately one had a death in the family so they just had one part-time employee. They had an intern to help with the processing of the mail. This tax season they collected a total of 19,123 in-person payments. They did 4,954 credit card payments and they processed 13,869 scanner mail payments. They collected a total of \$9,467,314 for this tax season. Ms. Hobbs stated they now have a drop box located outside by the picnic table. Anyone who would like to drop off their taxes instead of mailing can use the box which is checked daily. If this drop box does well they may put another one somewhere around town, possibly at Peppers or at the Senior Citizens Center to make it convenient.

Sheriff Kelly Gannaway gave the monthly activity reports. Assaults, larcenies, vehicle theft, and robberies are up. Overall criminal yearly totals are up. Yearly total for non-criminal are down accidents are up, DWI is down. Overall totals for non-criminals are down. The yearly grand total for criminal and non-criminals are down. Deputy Moreno and Deputy Nunez are headed to the academy on the 24th of January. They will be there for 16 weeks. One Deputy is on medical leave and another one is going on medical leave soon. Attentively there is another Deputy who is possibly retiring on February 1st. Interviews are scheduled for tomorrow for the School Resource Officer position. He has three opened Deputy positions background checks are currently being done for those positions. The Security Resource Officer is responsible for patrolling three schools.

Commissioner Reedy thanked everyone for helping her in the last year as Chairperson. She believes many good decisions were made and she stated there is some personal pleasure in being a board member. She has enjoyed every minute of it. Commissioner Smrkovsky thanked Commissioner Reedy. Commissioner Reedy also stated she had a wonderful time at the detention center.

Chair Smrkovsky looks forward to being the Chair as this is her last year.

COUNTY MANAGER'S REPORT: County Manager Chris Brice reported:

- Dispatch: Dispatch had a total of 6,742/911 calls and 228 warrants issued. The last working session allowed some of the money from the Rescue Act to go ahead and get the new CAD system and new radio system on track. Looking forward to getting quotes and going out to get the dispatchers a new CAD system.
- LCDC: There was a total of 367 people booked and 182 released. The average daily
 population was 379 with 243 Marshalls. They are well on track to exceed the annual
 expenses. Many counties in the State spend up to 20-40% of their general fund just to support

- a detention center. The fact that they exceed and make money is a blessing that Luna County can be thankful for. The new maintenance building framing is up.
- Road Department: A total of 2,612 tires were received and 95.70 total miles bladed. Capital Outlay Agreement received \$500,000 for heavy equipment purchases. Colonias extension request approved ongoing work with Wilson on the addition of Scotch Pine Rd. They were able to get a lot more done than they anticipated. They finished installing four-way stop signs at Dona Ana & Hermanas Grade intersection. They have completed LGRF construction on Hermanas, Solana/8th, La Bajada, and NM DHS, that is the road that goes out to the dump west of town. They are working on other projects with BLM, NMDOT, and NM DHS.
- Budget and Procurement: GRT continues to be a bit higher than expected and they continue to work on the budget. Hopefully, Open Gov will be available soon.
- Human Resources: The department has on-boarded two LCDC officers and one dispatcher, off-boarded twelve individuals. The currently available positions are DO, Starmax cooks part time, healing House advocate part-time, domestic violence offender treatment & intervention facilitator part-time, and Health Equity Program Manager. Interviews have been scheduled for CASA Program Manager, Procurement Specialist, Adult Drug Court Monitor, Sherriff's Deputy, and County Services Specialist for the Assessors. The minimum wage is now \$11.50 an hour. The HR office has moved across from the Treasurer's office.
- Starmax: Sales for the month of December are \$14,623.25. Continue to do work on various issues including the fire suppression system. They are waiting on a cost estimate from the suppression system company. They are looking for bids for the refurbishment of the carpet and drapes in the theatres. The WNMU fiber optic system has been completed.
- Emergency Management: Emergency Manager Phillip Rodriguez continues to monitor the spread of Covid-19. The spread is at 10.95% which is down from 14.4%. They assisted the Department of Health and the New Mexico National Guard. A mass notification system for Luna County should be up and running by the end of January or the middle of February. Anyone who registers on their phones will be able to receive all emergency broadcasts and any updates. The County has administered 317 doses of the Pfizer vaccine. We are also working on the hazard mitigation plan. We currently have two bids we have out to request for proposal (RFP).
- Luna County Fire: They responded to thirteen fires. Two bush trucks were received from Pete's Equipment.
- Community Health and Well Being: There was four DWI arrest and they are tracking 84 misdemeanor DWI offenders. The Healing House currently has 23 clients sheltered, 23 BIP participants, and eight orders of protection. The Health Council has received certification to provide the community NARCAN training. There have been 45 at-home Covid test kits distributed. Casa is serving 38 kids in Luna, Hidalgo, and Grant Counties. PAT is serving 151 clients in Luna and Hidalgo Counties. They have donated and distributed eight car seats and have performed 302 home visits. JJIC has six families enrolled in Strengthening Families, Girls Circle had 26 participants, Boys council had 24 participants, and adult drug court had 15 participants.

- IT had a total of 888 work orders completed. There have been 1,673 plus attacks on our networks. They continue to work on multiple projects.
- Economic Development: Currently waiting on citizen input for land use ordinances. In the process of finalizing Schroeder's contract, pending license approval for Sunnyside Farms. Franzoy's issue appears to have been mitigated.
- Maintenance/Projects: Remodeling is being done in Park Plaza and multiple Courthouse offices. The Fire alarm system will need to be changed per the fire marshal at MVSEC. The fire block was installed in the fire suppression and partition fence constructed at Starmax.

INDIGENT CLAIMS REPORT: Upon a motion by Commissioner Reedy and a second by Commissioner Smrkovsky, the meeting of the Board of County Commissioners was unanimously recessed and the meeting of the Indigent Hospital Claims Board convened.

Budget and Procurement Director Joanne Hethcox reported no claims for the month of December. The money received for the month of December was \$88,491.15 and the balance for the Indigent Claims Fund totaled \$1,817,921.43, of that \$604,213.26 is encumbered. Commissioner Sweetser motioned to approve the Indigent Claims Report as presented. Commissioner Reedy seconded the motion which carried unanimously.

Commissioner Reedy motioned to recess as a Claims Board and reconvene as a County Commission. Commissioner Sweetser seconded the motion which carried unanimously.

COMMUNITY SUPPORT REPORT: Deming Luna County Mainstreet Executive Director Chelsea Evans and Deming-Luna County Chamber of Commerce Executive Director Debbie Troyer reported on upcoming events.

PUBLIC COMMENT: Chair Smrkovsky opened the floor to public comment. Several members of the public went before the board.

NEW BUSINESS: CBDG Health Complex Bid Award: FY110-01- County Manager Chris Brice explained they have been working on this for about a year. This project is for a new Department of Health office renovation located on Slate Street. This building is owned by Luna County which was previously leased out and used as a physical therapy facility. Their current building is falling apart. The County has received Capital Outlay, CBDG, money left over from another project from a previous Capital Outlay project. All that money together did not come up to anywhere near the amount needed to refurbish this building. The CBDG Board in recognizing the fact that all costs have gone up asked all of the applicants for this project how much would be needed to get this project done. Mr. Brice stated they then requested another \$750,000. They did award the extra \$750,000 but when they received the award letter, it was only in the amount of \$500,000. Mr. Brice has sent a letter asking for the additional \$250,000. Even with that extra \$750,000 they still fall short of the bid amount. The bid came in, in the amount of \$2,367,500. They will need to request through the Rescue Act the amount of \$400,000, and then an additional \$250,000 as a 10% buffer just in case there are cost overruns on this project. Commissioner Smrkovsky motioned to award the CDBG Health Complex Bid to WestCon Commercial Industries. Commissioner Reedy seconded the motion which carried unanimously following a roll call vote.
