Section 4-18: Raising or Keeping Domesticated Female Chickens

- The keeping of domesticated female chickens shall be in compliance with the following, in addition to any zoning and/or building regulations that may be applicable to the construction of coops and:
 - o No more than six domesticated female chickens shall be kept or maintained on a single premises. It shall be unlawful to keep roosters or more than six domesticated female chickens. It shall be unlawful to keep or maintain domesticated female chickens at a duplex or apartment complex.
 - o Such domesticated female chickens must be confined in a coop which is fully enclosed with a solid floor and made of suitable, washable material. The coop shall be cleaned regularly with all droppings and excretions placed in a fly-proof container unless otherwise disposed of in accordance with any federal, state or local health regulations.
 - The chicken coop must be located at least 50 feet from the nearest residence other than that of the owner.
 - No coop shall be placed in a front or side yard.
 - Failure to confine the domesticated female chickens, maintain the coop or manage the droppings and excretions in compliance with this section shall be unlawful.
 - o It shall be unlawful to slaughter any domesticated female chickens on the premises
 - o It shall be unlawful to raise domesticated female chickens for commercial purposes within the corporate limits of the town.
 - o It shall be unlawful to keep domesticated female chickens on premises within the town without first obtaining an approval of the location of the chicken coop and issuance of an annual permit. Any annual permit would be subject to ordinance revisions adopted by the council. Should the council amend this section to prevent domesticated female chickens or any other new conditions, such amendment would apply to current permits within 30 days from the date of adoption of the council's revisions.

KEEPING CHICKENS NEIGHBOR CONSENT FORM

I certify that all the information on this application and any documentation attached are correct to the best of my knowledge.

A total of six (6) female chickens/hens is the maximum allowed. Chicken Coops are required to be at least 50 ft from the nearest residence other than that of the owner. No Chicken Coop shall be allowed in the front or side yard. All abutting property owners are required to give consent, before Chicken permits are allowed at the requested property. If issued, the Chicken Permit will be annually updated to ensure that all requirements are met. If you have any questions about the Chicken permit process then contact the Town of Lyman for more information.
