The Regular Meeting on June 22, 2023 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance. He

established that there was a quorum to proceed with the county's business as presented and noted that the meeting is recorded.

# A. Commissioners Comments:

Commissioner Duffy introduced James Chorney to speak on an update from North Central and introduce the newest staff member to their team. Jim Chorney introduced Connor Vecellio the new Transportation Planning Coordinator. He will be developing and implementing transportation plans and policies for the 6-county region.

Commissioner Kreiner stated that this morning we received notification that the Kinzua Skywalk is temporarily closed. DCNR had to decide for closer effective today to allow for a structural assessment to be done by a 3<sup>rd</sup> party.

Jim Chorney spoke on the community capacity program. We have been doing the program for about a year and a half now. It's a pilot program and we hope it continues to get funded moving forward. The intent of this program is for us to be able to provide technical assistance to a lot of our smaller municipalities and non-profit organizations that are looking to apply for grants or loans. An issue we are finding is a lot of them don't have the capacity to do it or have never done it in the past and choose to not do it. This program allows us to assist with these issues. Our website has a very simple 2-page application that can be filled out. We have a team that goes through the applications and assigns them to the appropriate person with the knowledge to help them apply. This opportunity allows us to apply to any funding source unlike in the past that was funding source specific. We have right now 111 project that have been submitted. 21 that have been submitted for application. 11 of them have been funded for about a total of 8.6 million dollars to the region. One main problem is that at least 61% of those are being held up due to a lack of match. It is an issue but we are working with funding sources to reduce matches or come up with something to help with the match.
