1, 2 and 3: Call to Order, Pledge of Allegiance & Roll Call

The Regular Meeting on January 28, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. He established that there was a quorum to proceed with the county's business as presented.

There were no changes or additions to the Agenda as presented.

4. Comments and Announcements

Commissioner Duffy reported on the status of Complete Count Committee for the 2020 Census. She indicated that they were still securing volunteers to help make sure that all citizens are counted. The next meeting is February 5 at 3:30 p.m. She will be there along with Heather Conrad, Outreach Specialist will be there to facilitate the meeting along with Jeremy Morey of Planning.

Commissioner Kreiner asked Lisa Pratt to provide an update regarding the election changes with the Act 77 Reform. She said it recently passed and noted that the state will take out a 90 million bond to reimburse counties up to 60% of the cost of new equipment from last year's purchase. There will be no straight party beginning in the November General election. Voter registration deadline is now 15 days prior to the election instead of 30. Canvassing of ballots will be centralized which they already did last time. There is a second type of mail in ballot for anyone who wants one. The deadline to receive those is up until 8:00 p.m. on election day and has to come to the Election's office. You can be now be on a permanent absentee list that is automatic and goes out in February of each year.

Commissioner Kreiner recognized the Maintenance Department for their efforts with the recent weather while staff was off and how quickly and effectively they cleared the snow and ice.

A. McKean County Comprehensive Plan – Jeremy Morey, Planning Director

Potter and Cameron have adopted their portion and McKean County held the 45 day open public comment period. They did receive a letter from Pat Cercone and Joseph Narin, addressing education and it's importance and the need to address it in the Comprehensive Plan. Those were passed on their consultant and subsequently added. Another letter form Linda Thompson about the varied housing stock where throughout the development young professionals indicated a 6-bedroom Victorian needing to be fixed up won't work for them. Diverse housing stock is needed including detached houses and multi-family dwellings. This was included as were subsidies. The last letter was a forest company employee regarding energy development in including protection of natural development, so we aren't clearing lands to put up wind farms or solar panels. The four comments have been addressed in the plan. They are now ready for a resolution to adopt. Commissioner Duffy asked if it would be on the county web page, Jeremy Morey indicated that it already was. She thanked him for his work on the plan and the many meetings.

B. McKean County Fiscal Policies – Lori Coffman, Finance Director

Lori Coffman indicated that there were three policies that needed to be adopted and in place for federal monies. The policies state that guidelines are followed, properly deposited and reconciled with the recipient so the monies are paid out to the recipient. This will update our policies to the Uniform Federal Guidelines.

C. McKean County GIS Agreements – Sean McLaughlin

Sean McLaughlin indicated that he drafted tow agreements to sell certain data sets that are not being sold by the Assessment office. The other is the state multiparty agreement where the state prefers all counties sign.
