B. Resolutions and Approvals of the Board

- Commissioner Lane moved to approve the Community Development Block Grant Citizenship Participation Plan. Commissioner Kreiner seconded and noted the two new parts, one was a new emergency declaration added, the second was a Cares Act. No further discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.
- 2) Commissioner Lane moved to approve a Resolution Authorizing the Proper Officers of McKean County to Authorize the filing of the Application and Business Plan for the Redevelopment assistance Capital Program (RACP) funds for the Wilds Sonshine Factory Project, with the project (ME-300-2206) in the amount of \$489,200.00 and further, in accordance with a prepared administrative agreement dated January 28, 2020, with no cost to McKean County. Commissioner Kreiner seconded. No discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.

C. Contracts/Leases/Purchase Agreements

- 1) Commissioner Lane moved to approve Architect Agreement with Crabtree, Rohrbaugh & Associates, Mechanicsburg, PA in the amount of \$97,540.00 for McKean County Courthouse Roof Replacement and Gutter Repair Project. Commissioner Kreiner seconded. Commissioner Lane noted that the county took out a bond last year for \$1,000,000 and a good portion of that money will be put toward this project so that the roof will last many years. No further discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.
- 2) Commissioner Lane moved to approve Agreement between McKean County and Erie County for Forensic Pathology from January 1, 2020 to December 31, 2020 with a \$5,000 retainer, autopsies to be billed at \$1,100 per report. Commissioner Kreiner seconded. Commissioner Lane noted that this is a contract that has existed for many years and it was the best alternative. Commissioner Kreiner said that the cost had gone up and the \$1,100 was a reduced rate. No additional discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.

- 3) Commissioner Lane moved to approve KOS Copier 8595I Agreement for copier for DHS for \$283.65 per month for 5 years for a total \$17,019 with a maintenance agreement option of \$.0048 per black and white copy. Commissioner Kreiner seconded. No discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.
- 4) Commissioner Lane moved to approve KOS Copier color C356if III copier Agreement for copier for DHS for \$61.38 per month for 5 years for a total \$3,709.80 with a maintenance agreement option of \$.07 per color copy and \$.008 for black and white copy. Commissioner Kreiner seconded. No discussion on the motion. Vote on the motion: Yes: Kreiner, Lane. Carried 2-0.
