The Regular Meeting on May 26, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. It was established that there was a quorum to proceed with the county's business, as presented, and noted that the meeting is recorded.

There were no changes or additions to the Agenda as presented.

4. Comments and Announcements

A. Commissioners' Comments

Commissioner Duffy welcomed Kimberly Briggs as the new director of the Office of Aging and commended Bill Orzechowski and thanked him for his willingness to work part time to see the transition through. Cliff Lane echoed Commissioner Duffy's sentiment.

Commissioner Kreiner recognized graduating seniors from high school, college, 6th grade and noted it is a difficult time to be graduating without any pomp and circumstances as is customary and wished them all the best.

He also noted that last week was EMS workers week. He had recognized nurses, hospitals and police and this wraps ups the recognition of all the front line workers during the COVID-19 crisis.

He also recognized the veterans who were honored yesterday for the sacrifices they made for our freedom.

Commissioner Duffy indicated that the Census was moving forward and there are banners in each municipality that are being updated with the numbers of the self-reporting as those increase. That is part of a county wide challenge.

Commissioner Lane noted that they did discuss that the amount was not budgeted for the three-year lease and not the one-year lease and Jean thought there could be changes that the one year lease would be more beneficial. - 3) Commissioner Duffy moved to accept a Purchase of Service Agreement from Steel Fusion Reference Laboratory Services for Processing, Monessen, PA, for the analysis for probation. Commissioner Lane seconded.

E. Proclamations and Recognitions

Commissioner Lane read the proclamation for Mental Health Awareness Month for May. Commissioner Duffy moved to accept the Proclamation. Vote on the motion: Yes: Kreiner, Duffy, Lane. Carried 3-0. Maggie Travis gave an overview of their interventions during the pandemic, she has been making phone calls and video

chats. They have been coordinating with service providers and case managers. She has developed a Facebook page to connect and post uplifting messages and the helpline, warmline and crisis number. She indicated that the tactics are working along with sending cards and masks that have been donated from her church. She has also been sending newsletter and Zoom meetings, Facebook live classes for wellness, music appreciation and connecting. She also read the Mental Health Bell Story.

9. Public Comment Period

Dan Wertz wanted to build off the proclamation and express his opinion that mental health and physical health and a solid education background are the three pillars required to form a strong foundation for individuals to reach their maximum potential in life. The pandemic reminds us that the balance can be upset this wellness balance, which can come from situations like a pandemic or physical abuse, mental abuse, domestic violence or military impact from service or unexpected loss of loved one, financial uncertainty, or bout of depression from the winter blues. At the end of it all, we all experience various stress in our lives that can upset that balance, there are resources and support. He thanked Maggie for highlighting what she does to support those needs. There are many resources available, he listed several of them that are online. The Governor also announce a "Reachout PA – your mental health matters" to provide feedback to his office. He emailed the details to Pam who will send it along to the media.

10. Adjournment

Commissioner Lane made a motion to adjourn the meeting, Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Kreiner, Duffy, Lane. Carried 3-0.

Commissioner Kreiner adjourned the meeting at 10:28 a.m.
