1, 2 and 3: Call to Order, Pledge of Allegiance & Roll Call

The Regular Meeting on June 9, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. He established that there was a quorum to proceed with the county's business as presented and noted that the meeting is recorded.

Commissioner Kreiner commended the Elections and Voter Registration Directors, Lisa Pratt and Linda Frey, and noted that it had been a long few weeks putting together the 2020 primary, particularly with all the changes with the write-in ballots and that they were finally breathing a sigh of relief.

Commissioner Kreiner noted the resignation of Amy Aguilar effective June 1, 2020.

5. Minutes

Commissioner Lane made a motion to accept the Minutes as presented from the May 26, 2020 meeting. Commissioner Duffy seconded and asked for a correction on the Summary of Motions Carried on the title of the Airport Authority Loan title. Motion was amended to accept the minutes with the noted change. Commissioner Duffy seconded the amended motion.

- B. Resolutions and Approvals of the Board
 - 1) Commissioner Duffy moved to approve a consent agenda item to appoint four members to the Planning Commission: Anthony Clarke, Butch Shaffer, Richard Kallenborn, Nancy Rathbun, effective January 1, 2020 until December 31, 2024. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
 - 2) Commissioner Lane moved to approve the Language Access Plan for the Emergency Solutions Grant. Commissioner Duffy seconded the motion. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

- 3) Commissioner Duffy moved to approve the Children's Advocacy Center Grant Agreement Extension, extending the time to September 1, 2020. Commissioner Lane seconded the motion. Commissioner Duffy noted that this was due needing additional time to spend the funds due to Covid-19 restrictions. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- 4) Commissioner Lane moved to approve the MATP Participation Grant Agreement and Assurance of Compliance. Commissioner Duffy seconded the motion. Commissioner Kreiner noted that he did speak to Dessa Chitester at ATA and they are just beginning working on the budget part of it, so that will be coming out. Commissioner Duffy asked if this was an electronic signature, it was determined it was typically paper. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- 5) Commissioner Lane moved to approve the 2020/2021 State Food Purchase Plan and The Emergency Food Assistance Program with the Pennsylvania Department of Agriculture for funding and resources from USDA. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- 6) Commissioner Duffy moved to authorize issuing a Memorandum of Understanding with six county food distributions locations to participate in the SFPP and TEFAP programs as indicated in item 8B5, above, with the following locations:

Commissioner Lane seconded the motion and noted that the Friendship Table was a new addition. Commissioner Duffy asked Chief Clerk Pam Burlingame to comment. She noted that this was another opportunity to utilize those funds and that the county allocation would remain the same and now be divided by six locations instead of five.
