The Regular Meeting on June 23, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. He established that there was a quorum to proceed with the county's business as presented and noted that the meeting is recorded.

#### 4. Comments and Announcements

#### A. Commissioners Comments

Commissioner Duffy spoke to Jeremey Morey who is doing a radio announcement with WESB. As of June 22, there have been people 27256 counted in McKean County. The 2010 population showed 43,450, so they are making progress. The municipalities with the highest responses as of June 22, were Bradford Township at 76% of what reported in 2010, Wetmore Township 73%, Foster Township 72%, Bradford City 57%. They are still going on with the challenge so banners have been placed in each municipality to show the residents the response rate. There are also yard signs to help remind people to self-respond. The challenge will be an award of a monetary prize to the top two municipalities. If anyone has not yet received an invitation to complete the census, then the census bureau does not recognize that anyone lives there and they can still complete the census online at 2020Census.gov or by phone at 844-330-2020 and the county would appreciate if people would do that.

  - 2) Commissioner Duffy moved to authorize an Application to the Pennsylvania Department of Community and Economic Development for the Covid-19 County Relief Block Grant Program for \$3,668,797.00 Commissioner Lane seconded the motion. Commissioner Duffy pointed out that one of the stipulations of that is that counties must have been and remain in compliance with all relevant laws, regulations and orders during the period of the Covid-19

Disaster Emergency under the Governor's Proclamation dated March 6, 2020. We have been pretty successful in McKean County with mitigation efforts, we have low cases, but we need to make sure that we are following those recommendations, not only for the health and safety of all of our residents but also so we can continue to receive this funding and allocate the funding as has been stipulated. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

- 3) Commissioner Lane moved to approve the First Restatement of Intergovernmental Cooperation Agreement Establishing the Northern Tier Regional 911 System Project Commissioner Duffy seconded. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0
- 4) Commissioner Duffy moved to approve the applications for County Aid from the Liquid Fuels Fund as follows:

Angie Tennies indicated that the property went to upset sale in 2018 and did not sell. Went to Judicial Sale in July 2019, it did not sell, went into the repository after that. This is the second bid before the board today. The board previously took action previously on a prior bidder who was awarded the property by the municipality and the school district, the county approved that bid, the buyer then backed out of the purchase. The existing bids were resubmitted to the school district and township and both have awarded to the Albneys. Commissioner Duffy seconded. No discussion on the motion. A RESOLUTION OF THE MCKEAN COUNTY COMMISSIONERS AUTHORIZING
APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC
DEVELOPMENT FOR THE
COVID-19 COUNTY RELIEF BLOCK GRANT PROGRAM.

WHEREAS, the Governor of Pennsylvania announced the disbursement of six-hundred and twenty-five million dollars to sixty counties within the Commonwealth of Pennsylvania, through Act 24 of 2020 and the Federal Cares Act; and,

WHEREAS, McKean County was given the opportunity to apply for Covid-19 County Relief Block Grant Program through the Pennsylvania Department of Community and Economic Development grant program for the Counties prorated portion, \$3,668,797.00, to support any or all Covid-19 related expenses within the following seven categories:

- 1. Offsetting the cost of direct county response, planning & outreach efforts related to Covid-19
- 2. Assist qualifying municipalities located within the county to offset response and planning efforts related to Covid-19
- 3. Small Business Grant Programs to support businesses with fewer than 100 employees & to support businesses and other entities that are primarily engaged in the tourism industry
- 4. Grant programs to support the following entities for costs related to assisting businesses during the Covid-19 Disaster Emergency: CEDOs, LDDs, IRCs, SBDCs, EDCs.
- 5. Behavioral Health & Substance use disorder treatment services
- 6. Broadband internet deployment with priority given to unserved or underserved areas
- 7. Qualifying non-profits

THEREFORE, BE IT RESOLVED that the McKean County Commissioners approve the application that was submitted to the Pennsylvania Department of Community and Economic Development for the Covid-19 County Relief Block Grant program funding in the amount of \$3,668,797.00.
