1, 2 and 3: Call to Order, Pledge of Allegiance & Roll Call

The Regular Meeting on August 11, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. Commissioner Kreiner asked those in attendance to keep their face masks on unless they were speaking. He established that there was a quorum to proceed with the county's business as presented and noted that the meeting is recorded.

There were no changes or additions to the Agenda as presented.

4. Comments and Announcements

A. Commissioners Comments

Commissioner Kreiner noted that the municipalities were doing a great job in response to the census. He said he hoped that there were enough self-responses to decrease the number of people who have to go door to door and thanked the committee for their efforts. Commissioner Kreiner welcomed Gabby Neubert to the meeting and noted that she would also be leaving as she had completed her internship through Workforce Solutions in the Planning Department with GIS. He also welcomed Bart Barton, Adjutant from the Smethport American Legion.

B. Human Resources Update

Commissioner Kreiner noted that there were two new employees - Daniel Golan, Courts – Law Clerk and Bob Veilleux, Economic Development Liaison and two Leave/Change of Service, one for the purposes of retirement: Kim Woods, First Deputy, Prothonotary/Clerk of Courts with her last day being Friday after 20 years of service with the county and he thanked her for her service. They had also received a resignation: Beth Monti, Bradford Township Tax Collector, effective date will be 1-15-2021.

Commissioner Lane made a motion to accept the Minutes as presented from the July 28, 2020 meeting. Commissioner Duffy seconded. No discussion on the motion.

- B. Resolutions and Approvals of the Board
 - 1) Commissioner Lane moved to approve MS-339 application from Bradford Township for Liquid Fuel fund allocation of \$10,210.88 for 2020 Road Project to pave Erickson and Fuller Roads. Commissioner Duffy seconded the motion. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
 - 2) Commissioner Duffy moved to approve MS-339 application from Smethport Borough for Liquid Fuel fund allocation of \$3,478.23 to encumber for future paving projects. Commissioner Lane seconded the motion. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
 - 3) Commissioner Lane moved to authorize property tax refunds to Daniel J. Brinsky, Lewis Run, in the amounts of County: \$303.49, Township: \$87.63, School: \$655.37 for taxes paid on an assessment that was adjusted due to an error in the Assessment Book omitting a combination deed recorded on 3/17/2005 to combine parcels 25-020-112 and 25-020-125. Commissioner Duffy seconded. Chief Tax Assessor, Angelia Tennies noted that they were recently made aware of the combination deed that had been recorded and when the transfer occurred, the parcels were not. Under the refund rules in Purdon's and the tax assessment combination law, he is entitled to a six-year refund or as long as he has owned the property. They did the recalculations for him. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
 - 4) 4a. Commissioner Duffy moved to approve a repository sale for 7 Chestnut Street, Mt. Jewett Borough, reputed owner listed as US National Bank Associates to David L. Eastman and Jason J. Eastman, Kane PA for \$1,275.00. Commissioner Lane seconded the motion. Chief Tax Collector Angelia Tennies noted that they were the only ones who placed the bid and it was awarded by the municipality and the school district. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
 - 4b. Commissioner Lane moved to approve a repository sale for 35 Bon Air Road, Foster Township, reputed owner James and June Hand to Brian and Tawny Milne, Rixford for \$300.00. Commissioner Duffy seconded. Angie Tennies stated that there were other bids on this property, this is the second highest bid, the reason that this was approved was that it borders the Milne's property and the township and school district felt it was better to award this to a neighbor than to bring someone else in and they are going to go ahead and clean up the site. No further discussion on the motion.

 - 5) Commissioner Duffy moved to approve a Request for Exempt Status from the Borough of Kane for 519 Haines Street, Kane as Municipal Government exemption Commissioner Lane seconded. Angie Tennies noted that these properties were purchased from the

county repository and they are exempt from taxes, as municipal entities, and they are processing them. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

- 6) Commissioner Lane moved to approve a request for Exempt Status from the Borough of Kane for 432 Greeves Street, Kane as Municipal Government exemption. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0
- 7) Commissioner Duffy moved to Request for Exempt Status from the Borough of Kane for 430 Greeves Street, Kane as Municipal Government exemption. Commissioner Lane seconded. No discussion on the motion.

 Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- 8) Commissioner Lane moved to accept Medical Assistance Transportation Program (MATP) allocation for Fiscal Year 2020-2021 for \$645,913.00, as allocated through notification from the PA Department of Human Services. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0
- 9) Commissioner Duffy moved to approve the Children's Advocacy Center Pennsylvania Commission on Crime and Delinquency (PCCD) grant application for \$47,000. Commissioner Lane seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0-
- 10) Commissioner Kreiner stated there were no bids for light fixtures, so #10 was not addressed.

- 1) Commissioner Lane moved to approve an agreement ESI Employee Assistance Group for Employee Benefit Services for Public Safety for \$2,084.37 and TotalCare for \$8,406.36 from 9/1/2020 to 8/31/2021 for a total Invoice Cost of \$10,490.73 Commissioner Duffy seconded. Commissioner Kreiner noted that he felt this was a great program and he was familiar with it from other places he had worked and it provides employees with options when they don't have anything else to fall back on. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- 2) Commissioner Lane moved to approve a North Central PREP work plan to include confirmation of training and utilization of the required client activity and impact reporting into the Pulse System. Commissioner Duffy seconded. Commissioner Duffy noted that this is the Partnership for Regional Economic Performance and this is something that they do with North Central which coordinates economic development efforts, so this is to help coordinate customer service. Jeremy has been working with North Central to get a new contract in place. She thanked Jeremy Morey for his efforts and stated that it is important to work regionally since many counties in the area face the same challenges. They are trying to improve their relationship with them and make businesses more aware of what North Central does for the county and for the region. They are located in Ridgway and as soon as Covid ends the staff will be attending more

meeting and they will have more of a presence in the county. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
