1, 2 and 3: Call to Order, Pledge of Allegiance & Roll Call

The Regular Meeting on December 8, 2020 of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence. He established that there was a quorum to proceed with the county's business as presented and noted that the meeting is recorded.

There were no changes or additions to the Agenda as presented.

4. Comments and Announcements

A. Commissioners Comments: Commissioner Duffy reviewed the Broadband project that is underway. She said that there is information on the county website. She also expressed concern that the Covid number countywide were going in the wrong direction so she would like everyone to consider what they could do to help stop the spread and she encouraged everyone to listen to what the medical experts are telling us. This is not a political issue and everyone needs to do what they can do to help slow the climbing numbers. She said it was important to remind everyone. Commissioner Lane echoed her statements and wanted to encourage people to be mindful during the upcoming holiday and as people are thinking that they need to see someone, please consider that Covid might be spread by you or by them and how important it really is to see them again next year when it is safer. Commissioner Kreiner agreed and said that we all have a responsibility to slow, if not eradicate the pandemic and hopefully sooner rather than later. He said it was imperative that we protect each other and that there are basic ways we can do that. One is wearing a mask and wearing it in the right properly fitted position in a way that covers both the nose and the mouth, practicing good hygiene, if you can – wash with soap and water for 20 seconds, if that isn't available then using hand sanitizer and making it a priority to keep our work areas sanitized. And most important is social distancing. If we can follow these simple steps, we can keep our economy open, keep our schools open. It is imperative that we all take an active stance. Lori Coffman mentioned that the budget is available for public view. There is a copy in the commissioner's wing in the courthouse and it is online. She said there was no tax increase for 2021. The General Fund Budget is 18, 095,800 and the All Funds Budget is 42,581.
