Commissioner Lane made a motion to amend the Draft Agenda as presented to remove Item 8B3 regarding the PILOT program for Brookline Court and South Center Street in Bradford.

Commissioner Duffy seconded the nomination. No further discussion. Vote on the motion: Yes: Kreiner, Duffy, Lane. Carried 3-0. The Agenda was amended to reflect this change and accepted as amended to proceed with the business of the county.

Commissioner Lane made a motion to accept the Minutes as presented from the January 12, 2021 Meeting. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

#### B. Resolutions and Approvals of the Board

- 1) Commissioner Lane moved to approve the Act 13 Greenways Fund allocations for \$34,606, as recommended by the McKean County Planning Commission:
  - a. \$2,582 Hamlin Township Baseball Field Drainage Project

b. \$6,024 – Tuna Valley Trail Association Marilla Landing Trailhead Construction Commissioner Duffy seconded. Jeremy Morey said these were the only 3 that qualified for the Greenways and they were scored and recommended to the commissioners for approval. No further discussion on the motion. Commissioner Duffy expressed her thanks to the commission for their efforts. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

- 2) Commissioner Duffy moved to approve the At-Risk Bridge Fund allocations for \$57,259, as recommended by the McKean County Planning Commission:
  - a. \$10,470 Hamlin Township for Dewey Avenue Bridge Rehabilitation Project
  - b. \$19,616 Liberty Township for Sherwood Hollow culvert replacement
  - c. \$27,173 City of Bradford for Elm Street Bridge Construction Project \$26,000.

Commissioner Lane seconded the motion. Jeremy Morey stated these were the three highest scoring applications out of 7, there was \$390,185 requested overall, they could not fund all of those, so they are recommending the three highest scoring. No further discussion on the motion. Vote on the resolution: Yes: Duffy, Kreiner, Lane. Passed 3-0.

- C. Contracts/Leases/Purchase Agreements:
  - Commissioner Lane moved to approve a Lease agreement with Costa's Supermarket, Inc. for office space as occupied by Magisterial District Judge 48-3-02 (MDJ Todd) at 625 E Water Street Smethport for a 6-year lease, first 3 years @ \$1,700/ mo; next 3 years @ \$1,750, to include the utility of borough water only. Commissioner Duffy seconded. No discussion on the motion. Vote on the resolution: Yes: Duffy, Kreiner, Lane. Passed 3-0.
