 - 4) Commissioner Lane moved to approve the Commonwealth of Pennsylvania Redevelopment Assistance Capital Project (RACP) Use of Funds, RDA-300 for PA Wilds Sonshine Factory Project with Funding Sources for Matching Funds as \$155,549 from Wilds Sonshine Northwest Saving Bank Loan (\$250,000) total and \$525,000 appraised land value of site

location, owned by Wilds Sonshine Factory. Commissioner Duffy seconded. No further discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

- 5) Commissioner Duffy moved to Approval to Commonwealth of Pennsylvania Redevelopment Assistance Capital Project (RACP) Use of Funds, RDA-301, for Wilds Sonshine Factory for \$1,169,749 total project cost showing \$489,200 RACP Reimbursement and \$680,549 Match Only from Wilds Sonshine Factory contributions.
