1, 2 and 3: Call to Order, Pledge of Allegiance & Roll Call

The Regular Meeting on August 10, 2021, of the McKean County Board of Commissioners was called to order by Commissioner Kreiner at 10:00 AM, followed by the Pledge of Allegiance and a moment of silence.

He established that there was a quorum to proceed with the county's business and noted that the meeting is recorded.

There were no changes or additions to the Agenda, as presented. Commissioner Duffy moved to approve the Agenda. Commissioner Lane seconded, all in favor. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

4. Comments and Announcements

A. Commissioners Comments: Commissioner Duffy spoke about the PA Career Link Day slated for August 12 at the Bradford location, 40 Davis Street. They are welcoming everyone to come in and learn and explore to see what your PA Career Link Office can do for you. She said they assist individuals with career and training services, assist employers looking for resources for their organizations and they assist with finding training options from available providers for people who want to get back into the workforce. She also said that the North Central CES committee, Comprehensive Economic Development Strategy, now has a survey available online at

<u>https://www.surveymonkey.com/r/KZV3JFX</u>. It is 45 questions. It is a chance for individuals to share their personal perspectives about the current conditions affecting life in the region. The survey is an opportunity for residents of McKean County to have input into our economic development strategy. She encouraged input.

Commissioner Lane shared that last week, the three commissioners attended the annual summer convention of CCAP, the County Commissioners Association of Pennsylvania. It was the first time they had all been able to get together in a year and a half. They had several breakout sessions that were very helpful, about the ARP money, broadband and reducing prison populations, as well as other matters.

Commissioner Kreiner reminded everyone that COVID is still circulating and that the papers have provided information that the Delta variant is prominent in all areas around us. McKean County is still in the moderate stage and there are regions nearby that are in the high stage. Everyone needs to monitor the numbers and make changes as needed.

- Commissioner Duffy moved to approve Family Center Grant Extension due to DHS approval to implement an Agreement Amendment of current grant agreements through June 30, 2022. Commissioner Lane seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.
- Commissioner Lane moved to approve an Application for County Aid from Port Allegany Borough to encumber funds for a future project in the amount allocated, \$4,196.00.

- 8) Commissioner Lane moved to accept a Letter of Commitment for National Telecommunication and Information Administration (NTIA) grant application, to be submitted in collaboration with PA DCED, including a commitment of county resources for administration, fiscal and project management for Broadband project. Commissioner Duffy seconded. No discussion on the motion. Vote on the motion: Yes: Duffy, Kreiner, Lane. Carried 3-0.

9) Commissioner Duffy moved to approve the Act 152 project funding to award \$44,550 to Applicants, as recommended by the McKean County Act 152 Review, as shown below. Commissioner Lane seconded the motion. Commissioner Duffy clarified that it was being awarded and there is still additional documentation and that it is a reimbursement of the expenses. Bob Veilleux confirmed that there is a contract that will need to be entered into and that each will have to submit documentation for the expenses, including the actual tipping fees at the landfills, so the grant amounts may vary, if the fees are less than projected. 9. Public Comment Period

Harriett Nevill asked where she could view the commitment for the grant application. She wanted to know what is the Broadband project. She wanted to know what the plan is. Bob Veilleux said he would need to verify if he could send it. He said it was for Wetmore, Seaward Avenue and Bolivar Drive areas. They discussed the funding and the access that those areas have now. Bob outlined how they qualified for the funding. She asked if this was additional money. She also expressed her concerns about the Infrastructure bill and how the commissioners will be using that funding. Commissioner Lane indicated that other counties were working on plans that the funds have not yet been passed. Harriet stated that's the point she was wanting to make and wanted to know what the commissioners were planning to do with the money. Commissioner Kreiner said the infrastructure just had the interim final rule where they took comments on it and they will be releasing their final rule in September and October and they are reviewing their thoughts to be determined from the guidelines. Patrick Barrett asked the Commissioners to consider utilizing the money to establish a passenger rail. Harriett Nevill indicated there are track in Annin Township and outlined transportation challenges for local residents.
