Below are descriptions of the events that occurred at each meeting

1. 2019 HMPU kick off meeting held on April 25th, 2019

At this meeting, Bruce Manning, Tracy Carl, & Gerard Rettger had a brief presentation explaining the process and timeline of events that lead to the update of the HMP. Small group discussion occurred between the presenters and the attendees. At this point, the municipal representatives had the opportunity to ask questions in regards to the timeline and process of the update of the plan to better understand obligations and expectations of both county and municipal offices.

2. 2019 HMPU risk assessment public meeting held on August 29th, 2019

At this meeting, Bruce Manning, former director of McKean County DES and the current McKean County Hazmat officer gave a presentation on the risks and hazards that were incorporated into the 2019 HMPU, a description of each risk, the associated impacts of said risks, and the preventative measures that can be taken to mitigate against those risks. At the conclusion of the presentation, the floor was opened up to questions, comments, and concerns. About a half hour of discussion proceeded. At the end of this discussion period, the meeting was adjourned.

3. 2019 HMPU mitigation action review public meeting held on October 29th, 2019.

At this meeting, Bruce Manning, Gerard Rettger, Tracy Carl, and Sean McLaughlin had intended on presenting the 2019 HMPU mitigation actions, goals and strategies for public input, but to our dismay, no member of the public was in attendance. As a result, Gerard Rettger & Sean McLaughlin organized meetings with all 22 municipalities for the second time, to present the mitigation actions, goals, and strategies to the municipal officials to garner input and support.
