ORDINANCE NO. 2013-3

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF MONROE TOWNSHIP, REPEALING ORDINANCE NO. 3-1970 IN IT'S ENTIRETY, PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF A PER CAPITA TAX

WHEREAS, the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, enacted an ordinance on December 30, 1970, being Ordinance Number 3-1970 which authorized the collection of per capita tax; and

WHEREAS, the County of Cumberland has eliminated the collection of per capita tax; and

WHEREAS, the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, has determined that the collection of the per capita tax as set forth in the above-referenced ordinance is no longer in the best interest of the citizens of Monroe Township; and

WHEREAS, the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, has decided to repeal the above-referenced tax ordinance and to abolish said taxes at this time.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED and it is hereby adopted the Board of Supervisors of Monroe Township that:

SECTION 1: SHORT TITLE

This Ordinance shall be known and may be cited as the "Monroe Township Per Capita Tax Repeal Ordinance."

SECTION 2: PURPOSE

The purpose of this Ordinance is to repeal the Monroe Township Per Capita Tax Ordinance and to abolish said tax.

SECTION 3: PREAMBLE

The preamble recited above is hereby incorporated by reference herein.

SECTION 4: REPEAL OF PER CAPITA TAX ORDINANCE

Ordinance Number 3-1970 which enacted the collection of a per capita tax in Monroe Township is hereby REPEALED.

SECTION 5: ADMINISTRATIVE PROVISIONS

The Board of Supervisors of Monroe Township may, by resolution, enact provisions necessary for administration of this Ordinance.

SECTION 6: SEVERABILITY

If any section, subsection, clause or phrase of this Ordinance is held unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

SECTION 7: EFFECTIVE DATE

This Ordinance shall become effective five days after enactment.


