A RESOLUTION OF THE BOARD OF SUPERVISORS OF
MONROE TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA,
ESTABLISHING A FEE SCHEDULE FOR ON-LOT
SEWAGE TESTS AND PERMITS.

WHEREAS, the Board of Supervisors of Monroe Township is authorized by The Second Class Township Code, Act of November 9, 1995, P.L. 350, Act No. 60-1995, as amended (53 P.S. Section 65101, et. seq.); the Clean Stream Law (35 P.S. Section 691.1, et. seq. as amended); the Pennsylvania Sewage Facilities Act (Act of January 24, 1966, P.L. 1535 as amended, 35 P.S. Section 750.1 et. seq.); and by Monroe Township Ordinance No. 99-3; and

WHEREAS, the Board of Supervisors of Monroe Township desires to establish a Fee Schedule for on-lot sewage tests, permits and related matters; and

WHEREAS, the fee schedule will be effective as of January 3, 2012; and

WHEREAS, all sewage fees are to be collected by the Monroe Township Sewage Enforcement Officer and remitted to the Township on a regular basis; and

WHEREAS, all other Resolutions or parts of Resolutions inconsistent herewith shall be and the same expressly are repealed.

NOW, THEREFORE, be it resolved by the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, that the following be established as the Fee Schedule for On-Lot Sewage Tests and Permits:

<u>Perc Test:</u> using six perc test holes and completion

<u>System Design Evaluation:</u> advising applicant regarding available system options and confirming application is complete and that the:	
A. In-ground seepage bed system	\$ 60.00
B. Pressure-dosed system	\$ 150.00
C. Spray Irrigation or Drip system	\$ 175.00
<u>Final processing of application,</u>	\$ 30.00
<u>Perform final inspection of system</u>	\$ 75.00
<u>System repair:</u>
