### **CALL TO ORDER**

A. Whitmore, chair called the meeting of Montgomery County Alcohol Drug Addiction and Mental Health Services to order at 5:30 PM in the offices of the Montgomery County Alcohol Drug Addiction and Mental Health Services with a quorum present.

### **RECOGNITION OF GUESTS**

### **BOARD SPOTLIGHT**

Outpatient Restoration to Competency (ORTC) Program - Jennifer Hochdoerfer,  
Program Coordinator/Forensic Monitor

Due to a raising increase in the use of forensic beds at Summit Behavioral Health, Ohio Mental Health and Addiction Services asked larger counties to create a program to decrease the wait list for state hospital beds, promote cost effective models of restoration and address long-standing issues of balancing needs of the defendant with those of the court.

The program is a partnership with OhioMHAS, Summit Behavioral Healthcare, Montgomery County Municipal Courts, Wright State University, South Community and Ohio AMS.

To be eligible for persons the defendant must be:

- \* 18 and older
- \* Montgomery County resident
- \* Misdemeanor charge
- \* No recent history of multiple or serious violent offenses
- \* Mental Health diagnosis
- \* Competency Finding: IST-R
- \* Least restrictive environment recommendation of Outpatient

#### Services Provided

Restoration Education: Provided at a frequency of 1-4 times per week for a duration of 15-60 minutes per session based upon the individual's ability to attend sessions and sustain attention.

Clinical Services: Provider agency will offer services based upon the individual's diagnosis, to include individual/group therapy, psychiatric services, case management. Provider agency will have contact with the individual 3-5 times per week.

Ohio Alcohol Monitoring System (AMS): SCRAM-GPS Monitoring: Individual will be placed on SCRAM-GPS Monitoring for the duration of restoration Ohio AMS will monitor inclusionary zones (treatment/restoration appointments).

#### Law Enforcement Trainings & Partnerships - Jennifer Cox, Director Training

Dayton Police Department was the lead agency and from 2003 to 2015, 7% full time officers had attended from 7 of the 30 departments. Criminal Justice Coordinating Center of Excellence was receiving requests from various departments about the need for additional CIT Academies. In January 2016, Montgomery County Sheriff's Office approached Montgomery County ADAMHS regarding a CIT Academy partnership.

The Montgomery County CIT Advisory Committee was established and by December 2016:

- 4 CIT Academies hosted (3 with MCSO; 1 with Dayton PD)
- 96 additional officers trained (now 17% of full time officers)
- 7 additional departments participating (now at 14 of 30)

Commitment between MCSO/ADAMHS to offer quarterly CIT Academies until all of the Montgomery County Law Enforcement agencies are at 25% of their sworn officers.

Newest Partnership and curriculum is with the Ohio Peace Officer Training Academy. ADAMHS was a part of the curriculum development and Training the Trainers process. Trauma-Informed Policing (TIP) was launched January 2017. Mandatory curriculum for all 34,000 sworn officers in Ohio. There are 22 TIP instructors in the State; in our region – 2 certified instructors at ADAMHS, 2 at Montgomery County Sheriff Office, 1 Hamilton County and 1 Sydney Police Department. Received an invitation to present TIP at OPOTA in London Ohio for the Ohio Sheriffs Association Annual In-service, Ohio Tactical Officers Association Annual Conference.

Plans for 2017 include:

- MCSO & ADAMHS will host 4 CIT Academies
- One-Day CIT Companion Course for Dispatchers will be added in the Spring
- CIT Companion Course for BH professionals will be added (Fall)
- Continue outreach to the 16 departments who are not currently participating
- Continue to market Mental Health First Aid – Public Safety as basic LE course and CIT Academy as Advanced course
- Incorporate OPOTA Trauma-Informed Policing into ADAMHS Training offerings

## **EXECUTIVE DIRECTOR'S REPORT**

Workforce Development - Drug Free work force grant through the State. Montgomery County Alcohol Drug Addiction and Mental Health Services Prevention and Early Intervention Division will work with Job & Family Services/Economic Development, Chamber of Commerce and Dayton Business Journal to develop policies and practices, which will be available to the public.

SSI Ohio Project Specialist - Coalition on Homelessness no Housing in Ohio (COHHIO) to house a SSI Ohio Project Specialist. This will be a contract position and will provide services to Montgomery, Preble and Madison-Clark-Greene counties. The position will assist clients with the SSI/SSDI application process and will expedite the disability determination process for disabled individuals that are homeless, at risk of homelessness and/or preparing to exit institutions. The Governor's Interagency Council on Homelessness and Affordable Housing developed implementation of this initiative.

Increasing Board Visibility - Think Again Campaign - the public awareness campaign highlighting the misconceptions behind the heroin epidemic and encouraging the public to rethink their perceptions regarding substance use addiction was launched in mid-October and will conclude early February. During the campaign, Montgomery County ADAMHS's message and name was distributed across multiple media outlets. A wide range of materials and multiple mediums were used and included:

- Campaign landing page
- Transit ads for RTA (Bus Side Panels, Audio Messaging, Standing Sign at bus hub)
- Heroin Reference Guide
- Public Relations Component
- Radio Advertising
- Direct mail postcards targeted to East Dayton

Ad agency submitted the Think Again Campaign for a HER-MEES Award in two categories

Deterra (register mark) Drug Deactivation System charcoal disposal bags have been distribution to two pharmacies (Ziks on E. Third and First Street Pharmacy). Dayton Daily News will feature an article.

Participated in a conference call with Director Plouck at Ohio Mental Health Addiction Services regarding the CARA Funding. Montgomery County ADAMHS is in the first priority rung to receive a portion of the \$26M available. Recommendations which

support the COAT (Community Overdose Action Team) are due Friday. The State must submit its funding application to SAMHSA by February 15th.
