#### 1. CALL TO ORDER

J. Jackson, Chair called the meeting of the Alcohol Drug Addiction and Mental Health Services Board Montgomery County (ADAMHS) to order at 5:30 PM via ZOOM call. #### 2. RECOGNITION OF GUESTS

Director Jones-Kelley acknowledged and welcomed tonight guests via ZOOM.

#### 3. **BOARD/PROVIDER SPOTLIGHT**

A lot has happened over the last several months in our community and while devastating it has been enlightening. One of the major needs is how we manage crisis in our community, provide more services and a stronger continuum of services. This evening we wanted to share with you the Fusion Center we have

been talking with you about. Jamie Sellars from RI International provided an overview of what that will look like and how to bring forward in our community.

#### Crisis Now: Transforming Services is within our reach.

Crisis Now Model – now is the time for crisis services to expand because of a confluence of factors and forces, including:

- Crisis care often being the preferred and most efficient care for people in crisis
- The absence of core elements of successful crisis care in many communities
- Mental health reform proposals that are on the table but fail to seize the opportunity to improve crisis care
- Mental health parity legislation and coverage expansion.

While some communities are crisis ready, there are very few communities where all key elements of crisis care are in place and many where even the "parts" of crisis care that exist are inadequate.

#### The State of Crisis in the US

- Over 47,000 Americans will die from suicide this year; alone and in despair
- Today, thousands of Americans will ask for help to resolve their crisis and receive that help initially someone who carries a gun
- The largest provider of mental health care in a 24/7 setting in many US states is their Department of Corrections
- Emergency Departments in most communities are overwhelmed and underresourced to handle mental health issues – Psychiatric Boarding has been the topic of lawsuits in multiple states.

#### Four Core Elements for Transforming Crisis Services

- 1. Regional or statewide crisis call centers coordinating in real time
- 2. Centrally deployed, 24/7 mobile crisis
- 3. Short-term, "sub-acute" residential crisis stabilization programs
- 4. Essential crisis care principles and practices

A true mental health emergency response system function as an integral part of a regional crisis system serving the whole population rather than an offering of a single provider, utilizes peers as integral staff members, has 35/7 access to psychiatrists and strong coordination across all levels of care.

Legal Counsel advised to rescind that resolution and separate into two recommendations and approve remaining funding balances in the contract of Life Essential being move to Catholic Social Services of the Miami Valley and Catholic Social Services of the Miami Valley contract increased by that amount.

C. Williams moved and D. Foley seconded Montgomery County Alcohol Drug Addiction and Mental Health Services approve the following recommendation(s):

#19-111 - rescind the resolution #19-111 dated April 22, 2020 to change the name from Life Essentials to Catholic Social Services of the Miami Valley. Further the Executive Director or board designee is authorized to sign any documents necessary to execute this process.

- Training Division continues to offer training on-line. Please join us on-line.
- Overdose deaths have increased the last four months. As of May 20<sup>th</sup> we are at 119 which is an increase from last year. COAT has reactivated strategies that were in place the last couple of years and creating additional services to meet individuals where they are currently.
- COVID-19 Update S. Elder and A. Stevens have been getting information into the community.
- Graph with open positions in the community and breakdown of where the positions are.
- Staff will be returning to the office officially on June 8<sup>th</sup>. Office hours will temporarily change to 8:30 AM 4:30 PM. Staff have remained safe, healthy and are anxious to return to the office.
