In addition to running the risk of a sewer backup into your home, flushing wipes can negatively impact sewage flows for an entire neighborhood. Recent estimates indicate the lift station repairs and a replacement grinder will exceed \$25,000, a completely avoidable expense.


Mounds View continues to work with developers on projects in the City. Feel free to stop at City Hall or **visit the City's website to see the latest information.**

2018 Elections

Three at-large seats, two for Council and one for Mayor, are open for the November 6, 2018, General Election. **Filing for office is the process by which a candidate's name gets placed on the ballot.** All City office candidates must:

- be an eligible voter of the City of Mounds View
- not have filed for another office at the upcoming Primary or General election
- be 21 years of age or more upon assuming office
- have maintained residence in the City for at least 30 days before the General Election

A filing fee of \$20 or petition in place of the filing fee is required. Filing begins July 31st and ends at 5:00 p.m. on August 14th in person either at Mounds View City Hall or Ramsey County Elections. Absentee Voting in Person

Eligible voters may cast an absentee ballot in person 46 days prior to each election at either the Ramsey County Public Works Building, 1425 Paul Kirkwold Drive, Arden Hills, or the Ramsey County Elections Office, 90 Plato Boulevard West, St. Paul, during regular business hours; from 10:00 a.m.-3:00 p.m. on the Saturday before Election Day; or until 5:00 p.m. on the Monday before Election Day.

Absentee voting for the August 14th Primary Election will begin on June 29th and Absentee voting for the November 6th General Election will begin on September 21st.

Absentee Voting by Mail

Absentee voters must first complete an absentee ballot application by visiting www.rcelections.org and clicking on Elections and Voter Registration or by calling the Ramsey County Elections office at 651-266-2171 to have an application sent to you by mail.

Peddlers and Solicitors

Throughout the year door-to-door peddling, soliciting, and canvassing raises questions from Mounds View residents. While most of these activities are regulated by the City, they cannot be prohibited entirely. A canvasser, for example, may go door-to-door without a permit from the City. A canvasser may be a person asking for signatures on a petition or requesting support for a political candidate. Booster clubs, Scouts, etc., are required to register with the City. Contact barb.benesch@moundsviewmn.org with questions.

All peddlers and solicitors are:

- Required to obtain a permit from the City
- Required to carry their City-issued photo ID card with them and present it upon request
- Restricted to soliciting between the hours of 9:00 a.m. and 8:00 p.m.

Please join us in making our neighborhoods safer by promptly reporting unlicensed solicitors or any other suspicious activity. For your safety, residents should:

- Not let a peddler, solicitor, or canvasser into your home, even if they have a permit

National Pollinator Week

National Pollinator Week is a time to celebrate pollinators and spread the word about what you can do to protect them. **Eleven years ago the U.S. Senate's unanimous approval and designation of a week in June as "National Pollinator Week" marked a necessary step** toward addressing the urgent issue of declining pollinator populations. Pollinator Week has now grown into an international celebration of the valuable ecosystem services provided by bees, birds, butterflies, bats, and beetles.

The Pollinator Partnership is proud to announce that June 18-24, 2018, has been designated National Pollinator Week. Information on Pollinator Week is available at pollinator.org/assets/generalFiles/Pollination-Fast-Facts-General-2018.pdf.

Did you know that the City of Mounds View is a **"Pollinator Friendly" City? Last year Public Works Director Don Peterson requested Council adopt a Resolution endorsing "Pollinator Friendly" policies and procedures.** He noted the Parks, Recreation and Forestry Commission also endorsed this Resolution. On July 24, 2017, the City Council adopted Resolution 8797, **Endorsing "Pollinator Friendly" Policies and Procedures.** City Ordinance 908 allows residents to keep bee hives in their backyard.

Annual Honeybee Keeping License Application

Requirements relating to the keeping of honeybees are located in Mounds View City Code Chapter 701.06. All permit holders are required to be familiar with the provisions of this chapter. In submitting a license application, the applicant declares that they meet the requirements for issue of said permit, and that such location will be operated in compliance with the adopted regulations and ordinances. Council to Update & Codify City Code

The Council will be spending time at future meetings and workshops conducting a systematic review and update of all 14 Chapters (Titles) of the Mounds View City Code which provide regulation and direction on everything from business licensing to zoning to Boards and Commissions.

All changes, even the smallest technical amendments, must be adopted via the ordinance process which requires a first reading at council and then a minimum of two weeks followed by a second reading at a City Council meeting. Finally, a summary of the ordinance must be published in the official city newspaper and does not become effective until 30 days after that publication is out. This provides residents and business owners a minimum of two more council meetings after approval along with the two meetings during the approval process to provide input and feedback.

All proposed changes will be available on the City's website in the council packet agenda items which are posted on the web page, typically the Friday before the council meetings.

Upon completion of the update, the City will then codify or insert the amendments/changes into the code and republish the amended code. During this process, we ask residents and business owners to engage in the process by checking the website/Council agendas; attend meetings and provide feedback if so inclined; email nyle.zikmund@moundsviewmn.org; or write any concerns you may have—all of which will be shared with the City Council.

No Parking on Your Lawn

All vehicles must be parked on a driveway or parking pad. Driveways and parking pads must be hard surfaced (concrete, asphalt, or brick). Gravel may be used up to 300 square feet or the wheelbase of your recreation vehicle (whichever is larger).

A Zoning Permit is required to build or enlarge a driveway or parking pad.

Driveways and parking pads must be at least five feet from side and rear property lines.

Proactive Code Enforcement in Mounds View

A top priority for the City of Mounds View Community Development Department is to ensure the quality of life for our residents. Some people may believe Code Enforcement is a nuisance and feel targeted when an inspector knocks on their door or issues a letter regarding code violations. Please know code violations are administered and handled uniformly throughout the City. The Mounds View Code Enforcement staff proactively looks for code violations in order to maintain a clean and safe community. When an inspector sees a violation, they will immediately attempt to talk with the homeowner. However, often times the inspector is unable to speak directly with a homeowner, in which case the resident will receive what is called a Notice of Violation and looks like this:

If you fail to correct the violations within the time specified above you will be subject to further legal action. Additionally, the City Council may, after notice to the owner and occupant or other responsible party and an opportunity to be heard, provide for abating (correcting) the violation by the City at your expense. If the cost, or any portion of it, has not been paid within thirty (30) days after the date of the bill, the unpaid cost will be certified to the County Auditor for collection along with current taxes in the following year.

This form is NOT a “citation.” It is used as a way to inform residents that City Staff observed a property violation and what corrective actions are needed to bring the property into compliance. The name and contact information of the inspector issuing the notification is at the bottom of the letter. Please contact the inspector if you receive a notice to discuss any concerns. The inspectors are willing to work with property owners to keep our City clean and remain a great place to live.

City Staff proactively looks for grass and weeds over eight (8) inches, deteriorated structures, junk vehicles (including unlicensed or expired tabs), garbage and trash accumulation, and parking on the lawn. Even in the winter, vehicles must be parked on an improved parking surface.

Rental properties must comply with the same property standards as single family residents. Please contact the City if you have concerns about any rental property in Mounds View. Home Improvement Financing Made Easy

The City of Mounds View has home improvement financing available. Whether **you’re thinking of** updating a bathroom or you need to add insulation to your **home, it’s never been easier to complete your projects.**

The Center for Energy and Environment’s (CEE) Lending Center provides low-interest financing to homeowners. Through this partnership, residents have access to loans with flexible terms and monthly payments that will be affordable. Programs are also available for mobile home owners. In addition, Ramsey County is offering an Energy Conservation Deferred Loan for homeowners who meet income guidelines. The loan is 0% interest, has no monthly payments, and is forgiven if the homeowner stays in their home for 10 years.

Mounds View Residents Save Big with Home Energy Squad

Discounted Home Energy Squad (HES) visits are available to Mounds View residents. The City is buying down the cost of energy audits to help residents save energy and money in their homes. HES visits typically cost \$100, but Mounds View residents only pay \$50.

A HES visit includes a team of energy consultants who come to your home, evaluate your energy savings opportunities, and:



- Install free materials such as LED bulbs, programmable thermostat, door and attic hatch weather stripping, high-efficiency showerhead and faucet aerators
- Inspect your attic and wall insulation
- Perform a blower door and thermal image testing
- Complete a combustion safety test and carbon monoxide check
- Provide you with a customized report with additional recommendations

If your home needs insulation or air sealing, HES will provide a quote for the recommended work and connect residents to qualified contractors that will honor the quote.

New Building Official's Mission: Community Safety and Well-Being

Everyone relies on the safety of structures surrounding us in our everyday lives; our homes, schools, offices, stores, restaurants, recreational facilities, etc. Building and Zoning codes enable the Building Official to enforce important safeguards and standards for protection from fire, structural failure, deterioration, weather, and natural disasters. The permit application, plan review process, and required inspections help to ensure all construction complies with the *minimum requirements* of Minnesota State Building Codes and City zoning ordinances. Although no code can eliminate all risk entirely, codes help to significantly reduce risks unknowingly faced every day.

The safety and protection of Mounds View citizens and our visitors is an important factor for the Building Code Official. The goal is to ensure a safe, healthy, and long-lasting community for today and many years to come. Benefits of State building codes and City zoning codes:

- to protect the health and safety of you, your family, and the public
- to protect future owners who deserve reasonable assurance that the home or structure they occupy is safe
- **to ensure the community's welfare and economic wellbeing** by reducing the potential spread of fire, disease, and structural failures or premature degradation
- to ensure any contractors operating within the City are properly licensed and bonded
- to maintain uniform building practices and help keep building costs down
- to assure safety, quality of life, and enhancement of the community as a whole
- to regulate energy conservation requirements

Boulevard

Boulevard is a proposed three-story, 60-unit apartment building to be located at the northwest corner of Mounds View Boulevard and Groveland Road. The property is currently occupied by one house and three vacant lots. The project is in the process of obtaining Final Plat approval. If approved, construction is planned to begin in the fall and will take about one year to complete. The project will include workforce housing, in which residents will be limited to incomes within 60% of the Area Median Income level (varies dependent upon household size). The project received financial assistance from the Minnesota Housing Finance Agency, Metropolitan Council, and Ramsey County.

Comprehensive Plan

The Comprehensive Plan is a community-wide plan of how land will be used and developed between the years 2020 to 2040. The plan is updated every ten years. The City Council appointed a resident Taskforce to guide the process. The Taskforce has been meeting twice per month since January 2018. Because of time constraints of staff, the City has requested and received a one-year extension from the Metropolitan Council to complete the Comprehensive Plan.

In the meantime, the City is requesting the residents provide feedback through a Community Survey. The Community Survey has been inserted in this edition of the *Mounds View Matters*, mailed to residents in their April utility billing statements, and is available online at www.moundsviewmn.org.



Triton

Triton is a proposed four-story, 61-unit apartment building to be located near the intersection of Old Highway 8 and Mustang Drive on a site currently occupied by the Skyline Motel. The project is planned to include workforce housing, in which residents will be limited to incomes within 50% of the Area Median Income level (varies dependent upon household size). A number of units will be marketed to veterans with incomes within 30% of the Area Median Income.

The project will also include office space for area non-profits and social services. The developer, Newport Midwest, is applying for assistance from the Minnesota Housing Finance Agency. If funded, it is expected that the developer will apply for planning approvals in late 2018 or early 2019.

Crossroad Pointe

Crossroad Pointe is located at the corner of Mounds View Boulevard and County Road H2. The new development will replace a former gas station and **Roberts' restaurant and bar**. In February Council amended an ordinance and will no longer allow discharging of weapons within indoor facilities (the discharge of weapons is prohibited within City limits). INH had proposed a facility which included a shooting range, however has since provided the City with three options for consideration: (1) all apartments; (2) apartments and a daycare; or (3) apartments and a convenience store. Whichever option the City Council and INH select, a number of Public Hearings will be required for project approvals. Please visit the City website for project updates.

May honors Motorcycle Safety Month, National Bike Month, Older Americans Month, Mental Health Month, and Global Youth Traffic Safety Month.

As far as public safety, remember motorcycles are back on the roads. All drivers should be looking for them before a change of course or pulling out into a roadway.

The police department is often involved with at risk individuals due to a mental health condition or independent living. Please call 9-1-1 in response to these situations. The police department has emergency resources for people in need of immediate attention. Ramsey County Adult Crisis and Senior Linkage Line are available for non-emergency issues or questions regarding what **can be done to help. If you're not sure if a situation is an emergency or not please call 9-1-1.**

Annually the City holds a public meeting sponsored by the Safe Adult Validation and Education program on a topic related to senior safety. This summer the focus is on how to downsize and declutter. Stay tuned to our webpage for the date and details.





Emerald Ash Borer



Emerald Ash Borer (EAB) has been identified and confirmed in the City of Mounds View by the Minnesota Department of Agriculture (MDA).

There are several things residents should look for when checking for EAB. Woodpecker holes and outer bark removal are the most common visual symptoms to detect EAB, both of which are evident on the infested ash tree found in Mounds View. When the bark was pulled back, the S-shaped galleries and larvae were found in the tree, confirming the presence of the insect.

1. **Be sure you've identified an ash tree.** This is an important first step since EAB only feeds on ash trees. Ash have opposite branching—meaning branches come off the trunk directly across from each other. On older trees, the bark is in a tight, diamond-shaped pattern. Younger trees have a relatively smooth bark.
2. Look for woodpecker damage. Woodpeckers like EAB larvae. Woodpecker activity will start in the upper portion of the tree.
3. Check for bark cracks. EAB larvae tunneling under the bark can cause the bark to split open, revealing the larval (S-shaped) tunnels underneath.
4. Contact a professional. If you feel your ash tree may be infested with EAB, contact a licensed tree care professional; the City Forestry voicemail hotline, 763-717-4065, or email publicworks@moundsviewmn.org; or the MDA at arrest.the.pest@state.mn.us or 888-545-6684 (voicemail).

The City of Mounds View is requiring the following regarding EAB discovery:


1. Notify the Public Works Department—Forestry Hotline, 763-717-4065, of an infected Ash Tree with EAB.
2. Notify the Public Works Department—Forestry Hotline, 763-717-4065, if the Ash Tree will be treated (i.e. injection).
3. No removal of infected Ash Trees will occur between May 1 and October 31, or until the first hard frost occurs.

Flushable Wipes...Really Aren't



Flushable wipes have cost the City in excess of \$25,000. On March 19th the Groveland Lift Station became clogged with flushable wipes, causing a costly repair due to the damaged grinder and motor.

Wipes, no matter what brand or type are used, do not break down once flushed into the sewer system. Flushed wipes can snag on roots or pipe deformations. Eventually wipes can clog the sewer, create backups further down the line, and be an expensive repair for the City.

Please only flush toilet paper.

Keep the Toilet Bowl Lid Down!

Summer is the season for sewer cleaning. The sanitary sewer lines are cleaned using high pressure sewer cleaning equipment. During cleaning of sanitary sewer lines, air occasionally vents back into a home through the sanitary sewer service line; when this happens, water in the toilet bowl can bubble, surge or, in rare cases, splash out of the bowl. To minimize water splashing out of your toilet bowl, make it a habit to **"keep the lid down."**



Yard Waste Collection Sites

Ramsey County operates seven yard waste collection sites. All sites are free and open to Ramsey County residents with a photo ID. The nearest collection site is located in Ardan Park at 8307 Long Lake Road, Mounds View. This site accepts leaves, grass, garden waste, and organics for recycling.

Sewer Backups

If you have a sewer backup you should contact Public Works, 763-717-4050, before contacting a drain cleaning company. You may be able to avoid an unnecessary charge if the problem is in the City's sewer line rather than in your property's service line. A Public Works employee will show up to determine if the problem is in the City's line or in your property's service line.
