⇒ Running Club

Department next year to make it one of our own programs. Kim stated they are doing a program like this at Sawmill for \$150.00.

⇒ Pools

Lifeguard shortage-we only have 13 guards. We are short 9-12 guards. Commission suggested contacting the Saw Mill Club and the Girls and Boys Club to ask for any guards. Linda mentioned that we are offering a Lifeguard Training Course to help get us some lifeguards.

⇒ Capture Point Software

Peter reported that he is waiting to see what the fees are for use of Credit Cards/ Chase Bank. Eileen suggested that Peter work into the program cost the fee for using the Credit Card.
