The seven day average COVID positivity rate in Westchester is 2.8%. there are 2,398 active cases in the county. 26 in Mount Kisco. 78.9% of those in the 10549 zip code have at least one dose of COVID vaccine. A reminder to all who have not yet been vaccinated, there is vaccine availability locally through Open Door Family Medical Center, CareMount Medical Group and Northern Westchester Hospital. Those who are not vaccinated are in the greatest risk to contract the virus and experience severe illness and hospitalization.

The Food and Drug Administration has approved an additional booster vaccination dose only for those who are severely immunocompromised. This is very specific population who should contact their healthcare providers. Boosters are not yet recommended or available for the general population.

Increasing cases results in increased chance for the virus to spread and for stronger variants to develop. We encourage all to please do all you can to avoid contracting and the virus. It is time for everyone to go back to basics. Remember to maintain good hand hygiene, it is prudent to mask when in indoor locations and maintain distance from others. If you are experiencing symptoms, please isolate immediately and contact your health care provider to be tested.

Though we have reduced the frequency of these update calls we continue to track data and guidance related to COVID. We will intermittently send a call to keep the community up to date related to the virus and public health.

The seven day average COVID positivity rate in Westchester is 1.9%. On July 16 it was 1%. There are currently 1,127 active COVID cases in the County. That is more than double the 420 active cases on July 16. Though there are just 4 active COVID cases in Mount Kisco, surrounding communities have cases increasing at a higher rate.

Variants of the virus are more contagious and are spreading largely among those who have not been vaccinated. There is some data showing a small number of cases among those who have been vaccinated. As a result, we must all continue to be aware and exercise caution to avoid contracting and spreading the virus. The CDC has revised guidance recommending that masks be worn in doors by all, including those who are vaccinated, in areas with substantial or high transmission rates. As of Thursday, Westchester is on the list of NYS counties that have a substantial COVID transmission rate.

Because we do not know the vaccination status of those who enter Village facilities, beginning Monday we are requiring face coverings for the public who enter any Village building or indoor facility. We continue our policy that all Village employees must demonstrate proof of vaccination or wear a mask.

Though there is not currently a state or county mandate, we ask everyone to use their good judgement and consider wearing a mask when in public indoor settings. Be mindful that almost 25% of local residents have not been vaccinated and can more easily contract and spread the virus. We ask those community member to please consider being vaccinated as doses are readily available locally at Open Door Family Medical Center, CareMount Medical Group and through Northern Westchester Hospital.

The strength and endurance of this community has been extraordinary. Keep up the great work Mount Kisco. Please remember to be responsible for your actions.

Though there are currently no active COVID cases reported in Mount Kisco, there has been an uptick in cases across the county and the state. The seven day average COVID positivity rate in Westchester is 1%. On June 25th it was .3%. There are currently 420 active COVID cases in the county. On June 25th there were 222.

Variants of the virus are spreading primarily among those who have not been vaccinated. I am pleased to share that more than 75% of those eligible in the 10549 zip code have received at least one dose of vaccine. This means approximately 25% of those eligible in our community have not yet been vaccinated. Vaccines are plentiful and available locally at Open Door Family Medical Center, CareMount Medical Group and through Northern Westchester Hospital.

Mount Kisco you should be so proud of the tremendous progress we have made in beating back this virus. We all need to continue to be diligent and aware. Exercise good hand washing hygiene, if you are experiencing COVID symptoms, please isolate immediately and get tested. If you have not yet done so, please consider getting vaccinated.

The strength and health of our community is dependent upon all of us being responsible for our actions.

The seven day average COVID positivity rate in Westchester is .3%. There are 222 active COVID cases in the county. None in Mount Kisco. 63.9% of all Westchester residents and 76.2% of eligible Westchester residents have received at least one dose of COVID vaccine. Vaccines continue to be available locally at Open Door Family Medical Center, CareMount Medical Group and Northern Westchester Hospital

This week, NYS lifted the State of Emergency. This indicates we have emerged from the urgent health crisis. Additionally the majority of COVID safety precautions have been rescinded. However, those who are not vaccinated need to continue to wear a face covering in accordance with CDC guidance.

As we successfully emerge from a global pandemic (well done Mount Kisco!!) we will be reducing the frequency of these messages. The seven day average COVID positivity rate in Westchester is .7%. There are 778 active COVID cases in Westchester. 8 in Mount Kisco. 2 COVID patients are admitted to NWH from communities across Westchester. 1 is in ICU. 58% of all Westchester residents have received at least one dose of COVID vaccine. 70.8% of Westchester residents 18 or older have been vaccinated.

NYS adopted revised CDC guidance regarding face coverings. Individuals who are fully vaccinated are not required to wear face coverings outdoors or indoors except on public transportation, in nursing homes, homeless shelters, correctional facilities, healthcare facilities and in K-12 schools.

Individuals who are not fully vaccinated are required to wear masks and socially distance indoors in public spaces.

The Department of Health strongly recommends masks in indoor settings where vaccination status of individuals is unknown. As a result, individual businesses or other locations open to the general public may require masks be worn on their property.

The Village Board Trustees is having two important conversations; one is about regulating the use of gas powered leaf blowers, the other about whether to permit the retail sales of marijuana in the Village. We strongly encourage all community members to share their views. Currently in NYS, those who are fully vaccinated, are not required to wear a mask outdoors when interacting with others who are fully vaccinated. Masks continue to be required indoors in public spaces, since there is restricted air circulation and many are still not yet vaccinated. We will share when NYS guidance is updated.

The seven day average COVID positivity rate in Westchester is 3%. There are 4,264 active cases in the county. 41 in Mount Kisco. 16 COVID patients are admitted to NWH from communities across the county. 4 are in ICU. 45.2% of Westchester residents have received at least one dose of COVID vaccine.

NYS has temporarily halted distribution of the Johnson & Johnson COVID vaccine pending further safety information from the FDA and CDC. Any existing vaccine appointments at county or state facilities will be honored and either a substitute vaccine will be given.

Vaccine appointments are available using the am I eligible app at [ny.gov](https://ny.gov), through Westchester county department of health, [cvs.com](https://cvs.com), [walgreens.com](https://walgreens.com) and locally through Northern Westchester Hospital, Open Door Family Medical Center and CareMount Medical Group. We encourage all adults 18 and older to schedule appointments as soon as possible.

NYS expanded the existing curfew so that bars and restaurants can stay open until midnight beginning on Monday 4/19.

The Water Department will begin its annual hydrant flushing program on Monday, April 26th and continue through Friday, May 21st. Flushing will be performed Monday through Friday between the hours of 11pm and 7am. This might result in a slight discoloration of your water. This is temporary and poses no health risk. Simply run your water for a short period of time until it clears up. Do not do any laundry until you are sure your water is clear. If the discoloration persists, contact the Mount Kisco DPW at (914) 666-8193.

35.4% of Westchester residents have received at least one dose of the COVID vaccine. On April 6 all NYers 16 years and older will be eligible to receive the vaccine.

We are seeing across the county, and here in the Village an increase in the number of those who test positive for COVID-19. Over the past few weeks, we maintained a low number of cases in the Village. This past week the number of those who test positive has doubled. We are seeing an increase in active cases in areas across the Village, in single family and multi-family dwellings.

The spread of the virus is moving at a rate faster than vaccinations. Until a broader segment of the population is vaccinated, it is essential that everyone continue to follow strict COVID safety precautions. This is not time to relax. We must all be careful and diligent or we are going to see high infection rates that could lead to shutdowns.

Frequently washing one's hands and wearing a face covering are two essential safety precautions. Masks must be worn when folks are unable to maintain at least 6 feet distance from others. This is particularly important when interacting with those outside of those in your household. It is wonderful to see folks enjoying beautiful weather walking in town and in the park, eating at restaurants and celebrating together. When doing so, it is essential everyone protect themselves and others. Wearing a mask is necessary when playing sports in which players come into contact with others. This includes basketball, football, soccer, hockey, lacrosse, and volleyball.

As soon as an individual has symptoms, it is essential they self-isolate and get tested. If you have traveled before interacting with others, please get tested to ensure you have not contracted the virus. This is particularly important before sending children back to school. Testing is available at Open Door Family Medical Center, Caremount Medical Group, and NWH Center for Healthy Living.

Please be advised that 2021 County taxes should be paid by April 30th to avoid penalty. Mailed payments must be postmarked no later than April 30. Online payments can be made until 11:59 pm on April 30. To pay online go to <https://pay.xpress-pay.com/org/2DE6E55DF72F4B8> select 2021 County taxes. Please remind your children if they are in public, in the park, walking through your neighborhood or downtown, face coverings are required if they cannot maintain distance from others. Beginning April 1 New Yorkers will not be required to quarantine following domestic travel.

Mandatory quarantine remains in effect for international travelers.

Beginning April 2 Event, Arts and Entertainment venues can reopen at 33% of capacity or up to 100 people indoors and 200 people outdoors.

We have received many phone calls at Village Hall regarding the inability to make a vaccine appointment. Please know we share your frustration. All decisions with reference to vaccine availability rests with the federal and state government.

Today Johnson & Johnson applied to the FDA for emergency authorization for their COVID19 vaccine. Clinical trials indicate this single shot vaccine is 72% effective in the US at preventing moderate to severe COVID19. The pharmaceutical company indicated they can supply 100m doses to the US in the first half of this year.

NYS and Westchester County have authorized a return to play for sports classified as high risk. These include basketball, wrestling, football, cheer and many others. Following strict guidance many of the FLHS teams began practices this week.

We are expecting more snow on Sunday. Fortunately the forecast calls for just a few inches. As you are out and about in the community this weekend and through next week please remember to follow COVID safety precautions and to be responsible for your actions.

The 7 day average COVID positivity rate in Westchester is 6.6%. There are currently 11,396 active COVID cases in the County. 125 attributed to Mount Kisco. There are 35 COVID patients at NWH from communities across Westchester. 6 are in ICU.

Currently three COVID variants have been identified as being more contagious and spreading more easily and quickly than other strains. These variants have their origins in the UK, Brazil and South Africa. The UK variant has been identified in NY including in Westchester. This news should be motivation for all to increase their efforts in maintaining essential safety precautions to slow the spread of the virus. Initial research does indicate the current vaccines will be effective against these variants.

The vaccine supply chain begins with the Federal government and is dependent upon production by pharmaceutical companies. Currently just 250,000 doses are allocated to all of NYS weekly. NYS distribution can administer approximately 80,000 doses per day which would be more than 500,000 per week. Though the system for broad distribution is setup, the vaccine supply does not come close to meeting the demand. Currently there are no new appointments available. When appointments are available they can only be scheduled online at <https://am-i-eligible.covid19vaccine.health.ny.gov/> or by calling 1-833-NYS-4-VAX (1-833-697-4829) School taxes must be submitted or postmarked by February 1 to avoid late fees.

A deadline extension is available for Village taxes for those who certify financial hardship due to COVID. Forms and information are available at [mountkiscony.gov](http://mountkiscony.gov) or by calling Joanne Cerrentani at 864-0034.

Senior citizens who had property tax exemptions in the 2019/2020 fiscal year will automatically have that exemption applied to their property assessment in the 2020/2021 year. The Village Board authorized the roll over of these senior exemptions specifically for this year. Seniors who have not previously had an exemption and believe they may be eligible or those who have questions can contact Lynn Princisvalle at 864-0017

The seven day average COVID positivity rate in Westchester is 7% More than 1000 cases were reported in the county yesterday. Currently there are 115 active COVID cases in the Village. There are 39 COVID patients at Northern Westchester Hospital. 3 are in ICU.

New more contagious strains of the virus are present in NY and across the country. Sadly, it is not yet time for us to exhale. I cannot overstate the importance of continuing to limit social interactions, particularly as we are all spending more time indoors, to wear face coverings, maintain distance from others and ensure proper hand hygiene. These safety precautions are essential to limit the spread of the virus.

Vaccine demand is high and currently the supply is very limited. Ultimately there will be more availability, but today with more than 7 million New Yorkers eligible to receive a vaccine, just a fraction of the needed doses are allocated to NY. At the current time, there are no vaccine appointments available at the Westchester County Center. There may be appointments available in neighboring counties. Any appointments currently available are being scheduled at the end of April. The only recommendation we can make at this time is to continue to try to schedule at <https://am-i-eligible.covid19vaccine.health.ny.gov/> or call 1-833-NYS-4-VAX (1-833-697-4829) We know and understand that many are frustrated and want to receive a vaccine right away. We continue our conversations with the County and NWH. We know they will do all they can to broaden distribution when the vaccine supply has expanded. We will be sure to communicate that information as soon as it is available to us.

People have raised concerns about public safety in light of reported threats to government facilities. We are fortunate to have access to the extensive resources of the WCPD. Their Real Time Crime Unit monitors activity for potential threats across the County and specifically in our Village. There is no identified threat to our community. If there were the full resources of the county would spring into action to ensure our safety.

On Monday Village offices will be closed in observance of Martin Luther King Day. In the spirit of Dr. King, we will fill the lawn at Village Hall with paper bag luminaries as a symbol of hope and unity. We invite all to document their dream on a paper bag which will be used as a luminary. Bags are available through the weekend at the Library. All are welcome to watch a brief presentation which will be broadcast at 5 p on Altice channel 20, FIOS channel 40 and on Facebook Live or to drive-by to see the light illuminate the darkness.

A new strain of the virus has been identified in NYS and other areas of the country. This variant is 70% more contagious. This means that if you come into contact with someone who has this strain you will be more likely to contract the virus. It is urgent that we all limit social interactions, maintain distance from others and wear face coverings.

Many folks have questions about vaccines. The Village is communicating with the county and Northern Westchester Hospital regarding distribution. However we have no authority or ability to access or distribute vaccines. NYS is managing the distribution and is requiring a strict and specific protocols. Currently in NYS vaccines are available only for healthcare workers, residents and staff at long term care facilities, EMS workers and others who come into direct contact with COVID patients. The next phase of implementation will be open to all first responders, teachers and educators, public safety and transit workers and people 75 and older. Next week we are expecting to get details about an online reservation system for vaccines. Only those mentioned will be able to make a reservation. When information is available to the Village, we will communicate via News on our website, Facebook and will include in our next phone message. General information about vaccines in NYS roll out is posted at <https://covid19vaccine.health.ny.gov/>

The seven day average positively rate in Westchester is 6.1%. 109 active COVID cases are attributed to Mount Kisco. There are 31 COVID patients in NWH from municipalities across Westchester. 6 are in ICU. A total of 768 vaccines were administered at NWH.

This week NYS aligned with CDC quarantine guidelines, allowing those who have had contact with someone who has COVID to quarantine for just 10 days instead of 14 if they themselves have tested negative for the virus.

We ask that all remember that the virus is active and present in our community so please be cautious as you celebrate tonight and through the weekend. There is a higher risk of spreading and contracting the virus when groups gather, particularly in doors. If you are indoors, please ensure all are wearing face coverings, maintaining distance and there is proper ventilation with open windows. Remember you are safest when you are spending time just with those who live in your home.

Reminder that Friday trash collection is schedule for Monday

After being suspended for 10 months, paid parking enforcement in parking lots will begin Jan 4. This includes all municipal parking lots. Please note that the Village has changed our digital parking vendor to Passport Parking. This will enable all to use the Passport Parking application for spaces in parking lots AND at meters on the street. The Passport Parking app is available for download on the App Store.

Village taxes are due and must be postmarked by today 12/31 to avoid a late fee. Property owners who have experienced financial hardship specifically due to COVID may be eligible to extend the payment deadline without penalty. This is Mayor Gina Picinich sending this update today in lieu of our Friday message. The 7 day average positivity rate in Westchester is 5.9%. There are currently 151 active cases in the Village.

Today Westchester County released a COVID-19 Dashboard enabling all to access current information on total, active and new cases by municipality. The dashboard also shows number of tests and positivity rate for Westchester. The link to the dashboard is <https://arcg.is/10naWv0>

89,000 New Yorkers have received their first dose of the COVID-19 vaccine including frontline staff locally at Northern Westchester Hospital. As more vaccine doses are available, everyone who would like to take the vaccine will have access. Please note New Yorkers will not have to pay for the vaccine, you will not be asked to share your social security number or other confidential information. So do not fall prey to scams. The Village will share the distribution plan as soon as that information is available.

We anticipate that the Board of Trustees will approve an extension of the Village property tax deadline specifically for those who certify financial hardship due to the pandemic. A Public Hearing and Special Meeting are scheduled for Monday, 12/28. Details on how to certify hardship will be available on the Village Website in Quick Links and under Receiver of Taxes on Tuesday the 29th.

Thursday trash collection is on a standard schedule. Friday collection will be on Monday.

We have seen a substantial increase in COVID cases since October. The next 10 days in which many celebrate Christmas and New Years, will determine the further path of the virus. We ask that everyone please be smart and thoughtful particularly when spending time indoors. Wear face coverings. Be sure windows are open for proper ventilation. Avoid large groups. You will be safest if you only spend time with those who live in your home.

The spirit of this season is about hope, promise and generosity toward others. Please reflect this spirit by being responsible for your actions.

The COVID positivity rate in Westchester County is just over 6%. The hospitalization rate is .03% of the population of Westchester. We have not received local data in a few days, but we estimate there are approximately 180 active cases in the Village. There are 43 COVID patients at NWH from across Westchester. 6 patients are in ICU

Today the Governor outlined five phases for vaccine distribution:

- Phase One, which is currently in process, includes high-risk healthcare workers and long-term care staff and patients
- Phase Two includes first responders teachers and school staff, public health workers, essential front line workers who interact with the public and high risk individuals with comorbidities.
- Phase Three individuals over 65 years of age
- Phase Four all other essential workers
- Phase Five healthy adults and children

Timelines for distribution has not yet been shared.

Our DPW team has been working around the clock to made all roads, and Village sidewalks and crosswalks passable. They continue their work of snow removal in parking lots and to widen and salt walkways. Please remember it is the responsibility of individual business and residential property owners to clear their sidewalks.

We know the coronavirus is very active and present in our community. We know that it spreads quickly and extensively through contact with those who have the virus. More than 70% of the spread is happening in small indoor gatherings. Though New York has a lower infection rate than most other states, the rate at which cases are rising is alarming. The greatest concern is the number of rapidly increasing hospitalizations. NYS is focusing attention on strategies to ensure our hospitals are not overwhelmed. We are fortunate in Westchester, that even at the peak of active cases in the Spring, our hospitals did not reach capacity.

The seven day average positivity rate in Westchester is 6.3%. There are currently 152 active cases in the Village. We continue to see multiple cases in the same household particularly in smaller dwellings where it is difficult for people to distance. There are currently 37 COVID patients at NWH from municipalities across Northern Westchester. 5 patients are in ICU.

Today the Governor outlined updated criteria for Red, Orange and Yellow Zones that incorporates the 10 day positivity rate and hospital capacity. It is possible that Mount Kisco and other communities in Westchester will be identified as Yellow Zones.

The governor also shared that 73% of cases are the result of small indoor gatherings. Please do all that you can to limit indoor social interactions to those in your household.

It is expected that vaccines for approximately 500,000 individuals will be arriving New York before the end of December. Distribution will begin with healthcare workers and long-term care facilities. It is anticipated that broader distribution to the general public will begin in the early spring.

I heard that Santa will be making a socially distant appearance Saturday morning at 10 am in the parking lot at the American Legion. I also heard that Santa, Mrs Clause and Frosty will be shopping and strolling downtown from noon to 4. Saturday will be a great day to bring your family downtown to get lunch and purchase holiday gifts. Please remember to wear face coverings and keep a safe distance from others.

Happy Hanukkah to all on this second night. Hanukkah is a celebration of faith, hope and light. During these very challenging days please remember that your choices can help others and shine a light in the dark times. So please be responsible for your actions.

The number of COVID cases are rapidly rising across the nation, state, county and here in the Village. The seven day average positivity rate in Westchester is 5.2%. There are currently 6746 active cases in the County. 292 COVID patients hospitalized in Westchester. There are 138 active cases attributed to Mount Kisco. The majority of these cases are in smaller dwellings where people are not able to distance. This is causing multiple people in the same household to test positive. 25 COVID patients in Northern Westchester Hospital, are from municipalities across Westchester. 3 are in ICU. It is possible that the Village, and other communities in Westchester, could be identified as a Yellow Zone.

Key points for everyone to keep in mind:

- Contact tracing is showing that 65% of all cases are from small gatherings. That is indicator that we all must modify our behaviors and strictly limit social interactions outside of our household.
- Pick up the phone if you receive a call from NYS Contact Tracing, as you will need to know if you have had contact with someone who tested positive.
- If you have been in contact with someone who tested positive, self-quarantine and arrange for testing 5 days after contact.
- Immediately self-quarantine and contact healthcare provider if you have symptoms.
- If one person in the household has tested positive all members of the household must quarantine.

Tonight the annual Chamber of Commerce tree lighting will be a bit different. To ensure a safe environment, we invite families to watch this evening at 6 pm live on Altice channel 20 and FIOS channel 40 or on Facebook Live. Directly following, cars can line up in Shoppers Park to drive in front of Village Hall to see the tree and to wave to Santa and Mrs. Clause.

On Thursday, December 10, at 6:30 pm, the Mount Kisco Hebrew Congregation and Bet Torah will light the menorah for the first night of Chanukah. We invite all to watch as we broadcast live on Altice 20 and FIOS 40 and stream live on Facebook.

Restaurants across the Village are open for eat-in or take-out and retail stores are welcoming holiday shoppers all following COVID safety precautions. If you plan on purchasing gifts or if you deserve a night off from cooking please visit our local businesses.

A reminder that the second half of the Village taxes are due without penalty by December 31st. We strongly encourage folks to pay their taxes remotely. Payments can be mailed to the lockbox identified on the bill. Alternately the ability to pay taxes online will be available on December 10. There is bright news on the horizon. The first shipment of vaccines for healthcare workers are expected to arrive in NY before the end of December. Plans are being made for distribution to the broader population through the first and second quarter of 2021. The focus for all of us at this point is to follow safety precautions and protect each other as we all try to stay healthy. We ask that everyone please be responsible for your actions.

Across the nation and in NYS reports continue to indicate a rise in COVID cases. Active cases in Westchester exceed 5000. Hospitalizations are nearly 200. The seven day average positivity rate in Westchester is 4.1%. As of Wednesday, 80 active cases are attributed to Mount Kisco. There are 17 COVID patients from municipalities across Westchester in NWH with 1 in ICU.

As numbers are increasing, Mount Kisco, and other communities in Westchester, are getting closer to being designated a Yellow Zone. On Wednesday, the Governor shared that identified Yellow Zones in Westchester including parts of Yonkers, Ossining, New Rochelle, Tarrytown, Peekskill are on track to shift to Orange or Red Zones. This means further guidance will be implemented to reduce density in an effort to limit the spread of the virus. Increased social activity during holiday time raises the probability that the infection rate will continue to grow and many more people will contract the virus. It is important for everyone to please keep in mind the actions needed to limit the spread:

- Follow safety precautions including wearing face coverings when unable to distance and perpetually wash and sanitize your hands
- Limit social interactions outside of your immediate household
- Answer the phone if you receive a call from "NYS Contact Tracing", as you will need to know if you have had contact with someone who tested positive
- If you have been in contact with someone who tested positive, self-quarantine and arrange for testing 5 days after contact
- Immediately self-quarantine and contact healthcare provider if you have symptoms
- If one person in the household has tested positive all members of the household must quarantine

In the Village, testing is available at Open Door, CareMount and NWH Center for Healthy Living (with prescription.)

We are going to begin to see some activity at the field hospital in the parking lot at Northern Westchester Hospital. It is NOT because of a high COVID patient count, but because Northwell selected NWH as a location to deliver a COVID therapy. The field hospital will be used as an infusion center to administer a therapeutic antibody for a specific high risk patient group who are experiencing mild to moderate COVID symptoms. Access to this therapy is available through referral by a healthcare provider in corporation with NWH.

The choices we make and the actions we take directly impact the infection rate and if you, your family, colleagues and friends will contract the virus. I know the kindness, care and great regard we all have for each other in our beautiful Village. As we all move forward to battle the challenges before us, I implore everyone to please be responsible for your actions.

More than 1 million COVID cases were reported in the United States over the last 7 days. In Westchester the 7 day average positivity rate is 4.1%. NYS has identified specific locations in the county as cluster zones which means the positivity rate in these areas exceeds 4%. In addition to the Orange Zone in Portchester, portions of New Rochelle, Ossining, Tarrytown, Yonkers and Peekskill have been identified as Yellow Zones. To address the rapid spread in these communities, increased testing and restrictions on density have been implemented. Details on restrictions to reduce density in Red, Orange and Yellow Zones is available at <https://forward.ny.gov/cluster-action-initiative>

Our most recent report attributes 76 active cases to Mount Kisco. This increasing number indicates the virus is very active in our community. There are currently 14 COVID patients in NWH from municipalities across the region. None are in ICU. Please remember if you have been exposed to someone who has the virus or are experiencing symptom to quarantine immediately and contact your healthcare provider. COVID testing is available through Open Door Family Medical Center, CareMount Medical Group and NWH Center for Healthy Living at Chappaqua Crossing.

To reinforce the need to wear face coverings in public and to ensure all have masks available, the Village will distribute masks on Tuesday November 24 from 2-4:30 pm on the steps of Village Hall.

A small social gathering in your home to celebrate a birthday or to have dinner with a few friends may seem safe, but that is currently the primary source of spread; a person with COVID indoors with 10 others unmasked without proper ventilation will cause the majority of people in the room to contract the virus.

So as we head into Thanksgiving celebrations, it is essential that we all consider ways to limit social interactions. Also remember that travel increases the risk of spreading or contracting the virus. The CDC strongly encourages celebrating Thanksgiving only with those who reside in the same home. Village offices will be closed next week on Thursday and Friday. There is a change to garbage collection schedule. Cardboard and paper and Thursday's garbage will be collected on Wednesday. Friday garbage will be collected Monday, the 30th.

The balloon test for the proposed cell tower on Sarles Street has been rescheduled for tomorrow Saturday, the 21st from 8 am to noon.

For many of us the holidays will look different this year. But the sentiment remains the same. Even in the most challenging times there are blessings in our lives. Our families, whether near or far, our neighbors and a community that cares deeply for each other. Please do all you can to demonstrate your care and regard for others by being responsible for your actions.

Please permit this message to serve as an urgent plea for everyone to redouble their efforts in following Coronavirus safety precautions.

The number of positive cases has increased substantially through this week across the country, in Westchester and here in the Village. The positivity rate in Westchester yesterday was 4.3% with a 7 day average of 3.5%. The Yellow Zone in Portchester was upgraded to Orange, and stricter safety measures were implemented in that municipality. Currently 47 cases are attributed to the Village. We are seeing multiple people at the same address testing positive. This indicates spread is asymptomatic and it is challenging to quarantine in the same family dwelling. Northern Westchester Hospital currently has 7 COVID patients from across the Northern Westchester area. None are in ICU.

Effective tonight at 10 PM, NYS is implementing revised safety protocols they include:

- Bars & Restaurants and any establishments licensed by the State Liquor Authority, must close from 10:00 PM to 5:00 AM daily. Delivery and curbside pickup, is permissible after 10:00 PM.
- Gyms must close at 10:00 PM.
- Residential gatherings, both indoors and out, cannot exceed 10 people.

This is in addition to the need to wear a face covering indoors and outdoors when unable to distance from others.

Due to expected winds, the balloon test to provide visual reference for a proposed cell tower on a property on Sarles Street has been postponed to Sunday from 8 am to noon if weather permits. The entrance to the Shoppers Park lot by from the Blackeby lot by the Green Street Fire House will be closed next week due to construction. The Shoppers Park lot will be accessible from Main Street.

We will again be hosting open office hours on Wednesday November 18 from 3-5 pm. If weather permits we will be outside of Village Hall. Alternately we will be in the lobby. Stop by to ask a question or connect via zoom 841 3796 9708.

Mount Kisco, as the virus spread increases it is essential that we all rise up to the highest levels of our endurance and capability. Please limit your social interactions with those outside of your immediate family. When in public wear face coverings when you are not able to maintain a safe distance. If you have symptoms or a suspicion that you were exposed to the virus, please immediately quarantine and contact your healthcare provider to arrange for testing. We can stop this upward trend if we all are focused on being responsible for our actions.

Across the United States we are seeing record numbers of COVID cases. The 7 day average positivity rate in Westchester is 2.2% The increasing cases are coming closer to home. Today, Port Chester was identified as a “Yellow Zone” to reverse the trend of substantially increasing cases in the municipality. Restrictions on activity to limit the spread of the virus and increased testing are being implemented. (Cluster initiative guidance <https://forward.ny.gov/cluster-action-initiative> )

Our most recent report attributes 26 active cases to the Village. There are currently 6 COVID patients in Northern Westchester Hospital. 1 in ICU. Testing and quarantining is so important. As soon as there is the slightest suspicion that an individual is has symptoms or has been exposed to the virus, it is essential to contact your healthcare provider to be tested. We must all work together to stabilize and reverse this upward trend. Keep wearing face coverings. Keep your distance from others. Be sure to have hand sanitizer in your car, in your office and in your home. It is essential that we are all extra vigilant to avoid exposure to the virus.

Village offices will be closed on Wednesday in observance of Veterans day. This will result in a change to recycling collection. On Monday our DPW team will collect Bottles & Cans. On Tuesday, Paper & Cardboard. No collection Wednesday. Thursday and Friday will be regularly scheduled garbage pick up.

On Saturday we will be honoring three Mount Kisco residents who have made a substantial contributions to our Village by add their names to our wall of honor in Leonard Park. Across the country, the number of daily reported COVID cases continues to increase. More than 45 states and territories qualify to be on the NYS travel advisory list.

<https://coronavirus.health.ny.gov/covid-19-travel-advisory> Connecticut, New Jersey, and Pennsylvania all meet the criteria for the advisory, but it is not viable to enforce to a mandatory quarantine for travel from these neighboring states. NY highly discourages non-essential travel outside of the state.

In Westchester, the positivity rate is up to 1.7%. There are currently 19 active cases attributed to Mount Kisco. Though this is not cause for alarm, the increase is a concerning trend that we are watching closely. It is essential that we all maintain focus on following safety precautions. We do not want to risk going backward. If you are exhibiting any symptoms or believe you might have been exposed to the virus, please isolate immediately and contact your healthcare provider to arrange for testing.

If you plan on distributing candy tomorrow for Halloween, we encourage folks to create a contactless environment by placing treats in individual bags and setting them on a table at the end of a walkway, driveway or porch. Trick-or-treaters should be respectful by not ringing doorbells or knocking at homes who do not have treats available outside.

South Moger Avenue will be closed until approximately 3 pm tomorrow for pumpkin decorating. Drive-in movies will be in Leonard Park tomorrow night with the first screening at 7:30 pm. Registration is available for a few remaining spaces at <https://forms.gle/UhJQZchP3ZMksAd67>

The Board of Elections advised us of another change to an Election Day polling location. Election District 1, which usually votes at the Library, will be voting at Leonard Park with Election District 2. For Election Districts 3 and 7, the library remains your polling location. Election District 5 will be voting at Neighbors Link instead of the Ambulance Corps. All other Election Districts will be voting where they have in the past. If you are confused, you can verify your polling location at <https://voterlookup.elections.ny.gov/> Additionally, there is a printed list of streets and polling locations in the library and in the lobby of Village Hall. Early voting continues at the Memorial Pool Complex in Leonard Park on Saturday from 11 am - 4 pm and on Sunday noon to 6 pm. Voting is part of the foundation of our democracy. It is both a privilege and a responsibility. If you have not done so already, please make the time to vote.

In various states across the country COVID cases continue to rise. In NY, detailed virus tracking has identified neighborhood clusters which were declared red, orange or yellow zones. Since the implementation of strict safety restrictions in these zones, the number of cases have stabilized. In Westchester, the rolling seven day average positivity rate has been at approximately 1.4%. This average is higher than it had been through the summer and should be a reminder to all that the virus is still very active and present. There are currently 12 active cases attributed to the Village. These include students who are out of state and use their home address for testing.

As of Friday, if safety guidance is implemented, theaters in NY can open at 25% of capacity with a maximum of 50 people per screen.

In NY, early voting begins Saturday, October 24 and continues through Sunday, November 1. The early voting polling location in Mount Kisco is at the Memorial Pool Complex in Leonard Park. Westchester voters can cast ballots at any early voting location in the County. A full list of locations and times is available at <https://citizenparticipation.westchestergov.com/.../early...> and on Village of Mount Kisco Facebook page.

Absentee ballots can be dropped at early voting polling locations and at polling locations on Election Day.

A reminder that the CDC and Westchester County Department of Health have identified trick or treating, other multi contact activities and large gatherings particularly indoors as high risk for spreading the virus. Please consider alternate ways to celebrate Halloween. There is still time to register for a drive-in movie in Leonard on Halloween night. This week, the numbers of new positive and active COVID cases started slowly moving upward in Westchester. There have been as many as 100 new cases a day. The number of hospitalizations are also starting to increase. County Executive George Latimer indicated these increases are concerning. As of today we have 9 active cases in the Village. We do not want this slow increase to turn into a large cluster. It is important to remember that if you are not exposed will not contract the virus. Safety precautions are designed to limit exposure. So please continue to be diligent in working to keep yourselves, your families and your neighbors safe.

The CDC has classified traditional trick or treating a risk for spreading the virus. This is due to the multiple contacts and touch points associated with ringing doorbells, distributing treats and gathering. Our most recent report indicates we have 3 active COVID cases in the Village. In Westchester County the positivity rate today is 1.1% with a more than 7,000 people tested. In other areas of NY, new restrictions have been put in place to reduce the spread in COVID hot spots. Please review guidance at <https://forward.ny.gov/> before traveling to Brooklyn, Queens, Rockland, Orange and Broome Counties.

Friday is the last day to register to vote in NY. To register go to <https://voterreg.dmv.ny.gov/MotorVoter/>

If you have not already, please begin to think about when you plan on voting. Early voting is scheduled from October 24 to November 1 in the Memorial Pool Complex at Leonard Park. Voters will be able to drop off absentee ballot at the early voting location. Polling locations for Election Day have not yet been confirmed. We will share details and changes to Election Day polling locations as soon as that information is confirmed by the Board of Elections.

In some areas of NYS there have been increases in COVID cases. 20 zip codes have been identified as having a high positivity rate and are considered clusters. These 20 locations average a greater than 5% positivity rate of those tested. Some of these clusters are in neighboring Rockland and Orange Counties. NYS is working closely with county and local governments to reduce the spread of the virus in these areas.

Though the 7 day rolling average has fluctuated slightly in Westchester, the positivity rate of those tested continues to be approximately 1%. Hospitalizations in Westchester remain low and manageable. Our most recent report indicates that here in the Village, we have one active COVID case.

The deadline to complete the Census has been extended to October 31. There is still 29% of our residents who have not responded to the census survey. Opportunities for federal funding, sales tax, and grand dollars are all tied to population. A reduced count means reduced funding for the next ten years. So please if you have not yet responded, go to <https://my2020census.gov/>

Deadline to register to vote in the General Election is October 9. You can register online, in person or by mail. New Yorkers have the option to vote by mail using absentee ballots or in person during early voting or on Election Day. Early Voting, in person begins on October 24 at the Memorial Pool Complex in Leonard Park. For full details on registering and options to vote are available at <https://citizenparticipation.westchestergov.com>

We share everyone's concern about the need for the traffic light at Barker Street and North Bedford Road to be repaired. The Village has had many conversations with the NYS Department of Transportation. They have advised that the damage is so substantial it will take months to repair. We have elevated our concern to our NYS legislators who are trying to raise the priority to put this work at the top of DOT's list. Please continue to drive cautiously and treat the intersection as a 4 way stop.

There has been more activity downtown, children have returned to school on modified schedules, and some folks are returning to their offices. We are all aware that greater interaction increases the possibility of exposure to the coronavirus. Please continue to be cautious, wear face coverings when you are not able to distance from others, limit your social activity and remind your children, particularly teens, to do the same. And most of all please, be responsible for your actions.

**Text from Friday September 25, 2020:**

The virus continues to be active and present in our community. A positive case was reported at Fox Lane High School. The school district worked closely with the County Department of Health. There was limited risk due to reduced density in the building and safety precautions that are in place. Contact tracing was done to ensure all who might be exposed were directed to isolate and test.

Though the percentage of positive cases in neighboring counties has increased, the positivity rate of those tested remains at approximately 1% in Westchester. As of today we have 1 active case in the Village. **We can expect that** the number of active cases will continue to fluctuate. We continue to watch closely to identify trends or clusters and will act quickly to **address concerns and notify the community**. If we all continue to follow safety precautions of mask wearing, distancing and hand washing we can keep each other safe.

The NYS travel advisory list is updated weekly. This week Arizona, Minnesota, Nevada, Rhode Island and Wyoming were added due to high infection rates.

We have not yet received specific guidance for Halloween celebrations or trick-o-treating. We do ask that when planning everyone focuses on ways to reduce risk. For example outside is safer than inside. Smaller numbers of people is preferable. Reduce opportunities for multiple individuals to touch the same objects. Sanitizing and mask wearing if unable to distance be mandatory.

A reminder that school taxes must be postmarked or paid by September 30<sup>th</sup> to avoid penalty. Payment can be made by check or online. Questions should be directed to our receiver of taxes Joanne Cerrentani 864-0034.

This week we saw an uptick in positive COVID tests across Westchester. It is believed this increase is largely attributed to people returning from travel out of state. It is anticipated that more cases will be reported as schools open. The good news is hospitalizations remain low and there have not been any fatalities in Westchester in more than a week.

We have had extensive discussions with the County and specificity with Dr Amler, Commissioner of Public Health with reference to increase in cases in the Village. Currently there are 17 active cases attributed to MK. Contact tracing teams have been active and determined many of these cases are due to multiple people living in one residence. As an example, in a family of 4 all have tested positive. Additionally, college students who are out-of-state, but currently have their health insurance registered at their Mount Kisco address are also included in our report.

At this time Dr Amler is not concerned about the number of active cases in the village. The County is managing the contact tracing and keeping a close eye. She indicated that this increase is evidence the virus is still very present and active. She asked that I please remind everyone of the importance of taking every action possible to reduce the spread of the virus.

If you travel from a state on the Travel Advisory list (<https://coronavirus.health.ny.gov/covid-19-travel-advisory>) it is essential that you quarantine for 14 days until you are sure you have not contracted the virus. Please wear face coverings when you are indoors and when you are outdoors and unable to maintain distance from others. Limit your social interactions. And please perpetually wash your hands.

We are accepting registration for the Remote School Workspace for Mount Kisco students in grades 3-8. We provide a safe environment for students to participate in synchronous learning aligned with the Bedford Central School District schedule.
