- In comparing existing to proposed zoning: minimum lot size & max. height are the same, maximum building coverage is roughly the same, setbacks & minimum parking are significantly lower in the A District. MU-H allows a number of personal services that A does not; A allows a number of indoor & outdoor amusements that MU-H does not.
- The proposed ordinance states that no portion of the ride, at maximum extension, shall be closer than 220', measured horizontally, from any public library, school, or church.




