- f) Public requests, presentation of petitions, awards, memorials.
- g) Nonagenda items from the public (each speaker limited to three minutes).
- h) Workshop.
- i) Second reading and adoption of ordinances.
- j) First reading of ordinances.
- k) Resolutions.
- l) Motions.
- m) ~~Reserved Nonagenda items from the public (each speaker limited to three minutes).~~
- n) Communications from city council and city manager.
- o) Reports and information presentations from city staff.
- p) Executive session.
- q) Adjournment.
